Mr. BISHOP of Utah, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 5521) making appropriations for the Legislative Branch for the fiscal year ending September 30, 2007, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 2(b) of
3 rule XVIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 5521) making appropriations for
6 the Legislative Branch for the fiscal year ending Sep-

1 tember 30, 2007, and for other purposes. The first reading
2 of the bill shall be dispensed with. All points of order
3 against consideration of the bill are waived. General de-
4 bate shall be confined to the bill and shall not exceed one
5 hour equally divided and controlled by the chairman and
6 ranking minority member of the Committee on Appropria-
7 tions. After general debate the bill shall be considered for
8 amendment under the five-minute rule. The bill shall be
9 considered as read. All points of order against provisions
10 in the bill for failure to comply with clause 2 of rule XXI
11 are waived. Notwithstanding clause 11 of rule XVIII, no
12 amendment to the bill shall be in order except those print-
13 ed in the report of the Committee on Rules accompanying
14 this resolution. Each such amendment may be offered only
15 in the order printed in the report, may be offered only
16 by a Member designated in the report, shall be considered
17 as read, shall be debatable for the time specified in the
18 report equally divided and controlled by the proponent and
19 an opponent, shall not be subject to amendment, and shall
20 not be subject to a demand for division of the question
21 in the House or in the Committee of the Whole. All points
22 of order against such amendments are waived. At the con-
23 clusion of consideration of the bill for amendment the
24 Committee shall rise and report the bill to the House with
25 such amendments as may have been adopted. The previous

1 question shall be considered as ordered on the bill and
2 amendments thereto to final passage without intervening
3 motion except one motion to recommit with or without in-
4 structions.
