A BILL

To reauthorize the Great Ape Conservation Act of 2000.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. GREAT APE CONSERVATION ASSISTANCE.**

4 Section 4 of the Great Ape Conservation Act of 2000
5 (16 U.S.C. 6303) is amended—

6 (1) in subsection (d)—

1 (A) in paragraph (4)(C), by striking “or”
2 after the semicolon at the end;

3 (B) in paragraph (5), by striking the pe-
4 riod at the end and inserting “; or”; and

5 (C) by adding at the end the following:

6 “(6) address root causes of threats to great
7 apes in range states, including illegal bushmeat
8 trade, diseases, lack of regional or local capacity for
9 conservation, and habitat loss due to natural disas-
10 ters.”; and

11 (2) in subsection (i)—

12 (A) by striking “Every” and inserting the
13 following:

14 “(1) IN GENERAL.—Every”;

15 (B) in paragraph (1) (as designated by
16 subparagraph (A)), by striking “shall” and in-
17 serting “may”; and

18 (C) by adding at the end the following:

19 “(2) APPLICABILITY OF FACa.—The Federal
20 Advisory Committee Act (5 App. U.S.C.) shall not
21 apply to a panel convened under paragraph (1).”.

22 **SEC. 2. GREAT APE CONSERVATION FUND.**

23 Section 5(b)(2) of the Great Ape Conservation Act
24 of 2000 (16 U.S.C. 6304(b)(2)) is amended—

1 (1) by striking “expand” and inserting “ex-
2 pend”; and

3 (2) by striking “\$80,000” and inserting
4 “\$150,000”.

5 **SEC. 3. AUTHORIZATION OF APPROPRIATIONS.**

6 The Great Ape Conservation Act of 2000 is amended
7 by striking section 6 (16 U.S.C. 6305) and inserting the
8 following:

9 **“SEC. 6. AUTHORIZATION OF APPROPRIATIONS.**

10 “There are authorized to be appropriated to the
11 Fund—

12 “(1) \$5,000,000 for each of fiscal years 2006
13 and 2007; *and*

14 “(2) \$7,000,000 for ~~fiscal year 2008~~; *and each*
15 *of fiscal years 2008 through 2010.*”.

16 ~~“(3) \$10,000,000 for each of fiscal years 2009~~
17 ~~and 2010.”.~~
