To amend the Oil Pollution Act of 1990 to improve that Act, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. AUDITS AND REPORTS.**

2 (a) IN GENERAL.—Title I of the Oil Pollution Act
3 of 1990 (33 U.S.C. 2701 et seq.) is amended by adding
4 at the end the following:

5 **“SEC. 1021. AUDITS AND REPORTS.**

6 “(a) AUDITS.—Not later than April 30 of the fiscal
7 year in which this section is enacted, and every April 30
8 thereafter, the President shall provide to the Committees
9 on Commerce, Science, and Transportation and Environ-
10 ment and Public Works of the Senate and the Committee
11 on Transportation and Infrastructure of the House of
12 Representatives an audit conducted by an independent
13 third party that includes a detailed accounting of—

14 “(1) all funds from the Fund disbursed by the
15 National Pollution Funds Center; and

16 “(2) all funds from the Fund administered and
17 managed by the receiving agencies, including final
18 payments made through agencies, contractors, and
19 subcontractors.

20 “(b) REPORTS.—Not later than February 28 of the
21 fiscal year in which this section is enacted, and every Feb-
22 ruary 28 thereafter, the Secretary, the Secretary of the
23 Interior, the Secretary of Transportation, the Adminis-
24 trator of the Environmental Protection Agency, and the
25 heads of any other Federal agencies that, during the pre-
26 ceeding fiscal year, received funds from the Fund, shall—

1 “(1) provide to the President a report account-
 2 ing for the uses of the funds by the Federal agency,
 3 including a description of ways in which those uses
 4 relate to—

5 “(A) oil pollution liability, compensation,
 6 prevention, preparedness, and removal;

7 “(B) natural resource damage assessment
 8 and restoration;

9 “(C) oil pollution research and develop-
 10 ment; and

11 “(D) other oil pollution-related activities;
 12 and

13 “(2) make each report available to the public
 14 and other interested parties via the Internet website
 15 of the National Pollution Funds Center.

16 “(e) AUTHORIZATION OF APPROPRIATIONS.—There
 17 are authorized to be appropriated such sums as are nec-
 18 essary to carry out this section.”.

19 (b) CONFORMING AMENDMENT.—The table of sec-
 20 tions in section 2 of the Oil Pollution Act of 1990 (33
 21 U.S.C. prec. 1001) is amended by inserting after the item
 22 relating to section 1020 the following:

“Sec. 1021. Audits and reports.”.

1 **SECTION 1. AUDITS AND REPORTS.**

2 (a) *IN GENERAL.*—*Title I of the Oil Pollution Act of*
3 *1990 (33 U.S.C. 2701 et seq.) is amended by adding at the*

6 “(a) *AUDITS.*—*Not later than April 30 of the fiscal*
7 *year in which this section is enacted, and every 2 years*
8 *thereafter, the President shall provide to the Committees on*
9 *Commerce, Science, and Transportation and Environment*
10 *and Public Works of the Senate and the Committee on*
11 *Transportation and Infrastructure of the House of Rep-*
12 *resentatives an audit conducted by the Comptroller General*
13 *of the United States that includes a detailed accounting of*
14 *all funds from the Fund in excess of \$100,000 that are—*

15 “(1) *disbursed by the National Pollution Funds*
16 *Center; and*

17 “(2) *administered and managed by the receiving*
18 *agencies, including final payments made through*
19 *agencies, contractors, and subcontractors.*

20 “(b) *REPORTS.*—*Not later than February 28 of the fis-*
21 *cal year in which this section is enacted, and every Feb-*
22 *ruary 28 thereafter, the Secretary, the Secretary of the Inte-*
23 *rior, the Secretary of Transportation, the Administrator of*
24 *the Environmental Protection Agency, and the heads of any*
25 *other Federal agencies that, during the preceding fiscal*

1 *year, received funds from the Fund in excess of \$100,000,*
2 *shall—*

3 “(1) *provide to the President a report accounting*
4 *for the uses of the funds by the Federal agency, in-*
5 *cluding a description of ways in which those uses re-*
6 *late to—*

7 “(A) *oil pollution liability, compensation,*
8 *prevention, preparedness, and removal;*

9 “(B) *natural resource damage assessment*
10 *and restoration;*

11 “(C) *oil pollution research and development;*
12 *and*

13 “(D) *other oil pollution-related activities;*
14 *and*

15 “(2) *make each report available to the public*
16 *and other interested parties via the Internet website*
17 *of the National Pollution Funds Center.*

18 “(c) *AUTHORIZATION OF APPROPRIATIONS.—There are*
19 *authorized to be appropriated such sums as are necessary*
20 *to carry out this section.”.*

21 “(b) *CONFORMING AMENDMENT.—The table of sections*
22 *in section 2 of the Oil Pollution Act of 1990 (33 U.S.C.*
23 *prec. 1001) is amended by inserting after the item relating*
24 *to section 1020 the following:*

“*Sec. 1021. Audits and reports.*”.
