Mr. FEINGOLD introduced the following bill; which was read twice and referred to the Committee on Foreign Relations

A BILL

To provide for the redeployment of United States forces from Iraq by July 1, 2007.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. REDEPLOYMENT OF UNITED STATES FORCES**

4 **FROM IRAQ.**

5 (a) STATEMENT OF POLICY.—It is the policy of the
6 United States to redeploy United States forces from Iraq
7 by July 1, 2007, while maintaining thereafter in Iraq the
8 minimal level of United States forces sufficient to engage
9 directly in targeted counterterrorism activities, train Iraq

1 security forces, and protect United States infrastructure
2 and personnel in Iraq.

3 (b) REPORT.—

4 (1) REPORT ON STRATEGY FOR REDEPLOY-
5 MENT.—Not later than 60 days after the date of the
6 enactment of this Act, the Secretary of Defense and
7 the Secretary of State shall jointly submit to Con-
8 gress a report setting forth the strategy of the
9 United States for the redeployment of United States
10 forces from Iraq by July 1, 2007, in accordance with
11 the policy stated in subsection (a).

12 (2) ELEMENTS OF STRATEGY.—The strategy
13 set forth in the report under this subsection shall in-
14 clude the following:

15 (A) A flexible schedule for redeploying
16 United States forces from Iraq by July 1, 2007,
17 in accordance with the policy stated in sub-
18 section (a).

19 (B) An estimate of the number, size, and
20 character of United States military units need-
21 ed in Iraq after July 1, 2007, for purposes of
22 counterterrorism activities, training Iraq secu-
23 rity forces, or protecting United States infra-
24 structure and personnel in Iraq.

1 (C) A strategy for managing the regional
2 implications of the redeployment of United
3 States forces from Iraq in accordance with the
4 policy stated in subsection (a), including a de-
5 scription of proposed efforts to ensure a coordi-
6 nated diplomatic, political, and development
7 strategy to accompany such redeployment of
8 United States forces.

9 (D) A strategy for ensuring the safety and
10 security of United States forces in Iraq during
11 the redeployment under the policy stated in
12 subsection (a), and a contingency plan for ad-
13 dressing dramatic changes in security condi-
14 tions that may require a specified number of
15 additional United States forces to remain in
16 Iraq after July 1, 2007.

17 (E) A strategy for repairing and strength-
18 ening United States forces to effectively engage
19 and defeat global terrorist networks that threat-
20 en the United States.
