To amend the Public Health Service Act with respect to  
the National Foundation for the Centers for Disease  
Control and Prevention.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. NATIONAL FOUNDATION FOR THE CENTERS**  
 2 **FOR DISEASE CONTROL AND PREVENTION;**  
 3 **ACCEPTANCE OF VOLUNTARY SERVICES;**  
 4 **FEDERAL FUNDING.**

5 (a) **AUTHORITY FOR ACCEPTANCE OF VOLUNTARY**  
 6 **SERVICES; STRIKING TWO-YEAR LIMIT PER INDIVIDUAL.**—Section 399G(h)(2)(A) of the Public Health  
 7 Service Act (42 U.S.C. 280e–11(h)(2)(A)) is amended by  
 8 striking the second sentence and inserting the following:  
 9 “In the case of an individual, such Director may accept  
 10 the services provided under the preceding sentence by the  
 11 individual until such time as the private funding for such  
 12 individual ends.”.

14 (b) **FEDERAL FUNDING.**—Section 399G(i) of the  
 15 Public Health Service Act (42 U.S.C. 280e–11(i)) is  
 16 amended—

17 (1) in paragraph (2)—

18 (A) in subparagraph (A), by striking  
 19 “\$500,000”, and inserting “\$1,500,000”; and

20 (B) in subparagraph (B), by striking “not  
 21 more than \$500,000” and inserting “not less  
 22 than \$500,000, and not more than  
 23 \$1,500,000”; and

24 (2) by adding at the end the following:

25 “(4) **SUPPORT SERVICES.**—The Director of the  
 26 Centers for Disease Control and Prevention may

1 provide facilities, utilities, and support services to  
 2 the Foundation if it is determined by the Director  
 3 to be advantageous to the programs of such Cen-  
 4 ters.”.

5 **SECTION 1. NATIONAL FOUNDATION FOR THE CENTERS**  
 6 **FOR DISEASE CONTROL AND PREVENTION;**  
 7 **ACCEPTANCE OF VOLUNTARY SERVICES; FED-**  
 8 **ERAL FUNDING.**

9 (a) *AUTHORITY FOR ACCEPTANCE OF VOLUNTARY*  
 10 *SERVICES; STRIKING TWO-YEAR LIMIT PER INDIVIDUAL.—*  
 11 *Section 399G(h)(2)(A) of the Public Health Service Act (42*  
 12 *U.S.C. 280e–11(h)(2)(A)) is amended by striking the second*  
 13 *sentence and inserting the following: “In the case of an in-*  
 14 *dividual, such Director may accept the services provided*  
 15 *under the preceding sentence by the individual until such*  
 16 *time as the private funding for such individual ends.”.*

17 (b) *REPORTS.—Section 399G(h)(7) of the Public*  
 18 *Health Service Act (42 U.S.C. 280e–11(h)(7)) is amended—*

19 (1) *in subparagraph (A), by inserting “, includ-*  
 20 *ing an accounting of the use of amounts provided for*  
 21 *under subsection (i)” before the period; and*

22 (2) *by striking subparagraph (C) and inserting*  
 23 *the following:*

1           “(C) *The Foundation shall make copies of*  
2           *each report submitted under subparagraph (A)*  
3           *available—*

4                   “(i) *for public inspection, and shall*  
5                   *upon request provide a copy of the report to*  
6                   *any individual for a charge not to exceed*  
7                   *the cost of providing the copy; and*

8                           “(ii) *to the appropriate committees of*  
9                           *Congress.”.*

10           (c) *FEDERAL FUNDING.—Section 399G(i) of the Public*  
11           *Health Service Act (42 U.S.C. 280e–11(i)) is amended—*

12                   (1) *in paragraph (2)—*

13                           (A) *in subparagraph (A), by striking*  
14                           *“\$500,000”, and inserting “\$1,250,000”; and*

15                           (B) *in subparagraph (B), by striking “not*  
16                           *more than \$500,000” and inserting “not less*  
17                           *than \$500,000, and not more than \$1,250,000”;*  
18                           *and*

19                   (2) *by adding at the end the following:*

20                           “(4) *SUPPORT SERVICES.—The Director of the*  
21                           *Centers for Disease Control and Prevention may pro-*  
22                           *vide facilities, utilities, and support services to the*  
23                           *Foundation if it is determined by the Director to be*  
24                           *advantageous to the programs of such Centers.”.*
