A BILL

To amend the Internal Revenue Code of 1986 to provide for the modernization of the United States Tax Court, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE; ETC.**

4 (a) ~~SHORT TITLE.~~—This Act may be cited as the
5 “United States Tax Court Modernization Act”.

1 (b) ~~AMENDMENT OF 1986 CODE.—Except as other-~~
 2 ~~wise expressly provided, whenever in this Act an amend-~~
 3 ~~ment or repeal is expressed in terms of an amendment~~
 4 ~~to, or repeal of, a section or other provision, the reference~~
 5 ~~shall be considered to be made to a section or other provi-~~
 6 ~~sion of the Internal Revenue Code of 1986.~~

**TITLE I—TAX COURT
PROCEDURE**

**SEC. 101. JURISDICTION OF TAX COURT OVER COLLECTION
DUE PROCESS CASES.**

(a) **IN GENERAL.**—Paragraph (1) of section 6330(d) (relating to proceeding after hearing) is amended to read as follows:

~~“(1) JUDICIAL REVIEW OF DETERMINATION.—~~
The person may, within 30 days of a determination under this section, appeal such determination to the Tax Court (and the Tax Court shall have jurisdiction with respect to such matter).”.

(b) **EFFECTIVE DATE.**—The amendment made by this section shall apply to determinations made after the date which is 60 days after the date of the enactment of this Act.

**SEC. 102. AUTHORITY FOR SPECIAL TRIAL JUDGES TO
HEAR AND DECIDE CERTAIN EMPLOYMENT
STATUS CASES.**

(a) **IN GENERAL.**—Section 7443A(b) (relating to proceedings which may be assigned to special trial judges) is amended by striking “and” at the end of paragraph (4), by redesignating paragraph (5) as paragraph (6), and by inserting after paragraph (4) the following new paragraph:

1 “(5) any proceeding under section 7436(e),
2 and”.

3 (b) CONFORMING AMENDMENT.—Section 7443A(e)
4 is amended by striking “or (4)” and inserting “(4), or
5 (5)”.

6 (c) EFFECTIVE DATE.—The amendments made by
7 this section shall apply to any proceeding under section
8 7436(e) of the Internal Revenue Code of 1986 with re-
9 spect to which a decision has not become final (as deter-
10 mined under section 7481 of such Code) before the date
11 of the enactment of this Act.

12 **SEC. 103. CONFIRMATION OF AUTHORITY OF TAX COURT**
13 **TO APPLY DOCTRINE OF EQUITABLE**
14 **RECOUPMENT.**

15 (a) CONFIRMATION OF AUTHORITY OF TAX COURT
16 TO APPLY DOCTRINE OF EQUITABLE RECOUPMENT.—
17 Section 6214(b) (relating to jurisdiction over other years
18 and quarters) is amended by adding at the end the fol-
19 lowing new sentence: “Notwithstanding the preceding sen-
20 tence, the Tax Court may apply the doctrine of equitable
21 recoupment to the same extent that it is available in civil
22 tax cases before the district courts of the United States
23 and the United States Court of Federal Claims.”.

24 (b) EFFECTIVE DATE.—The amendment made by
25 this section shall apply to any action or proceeding in the

1 United States Tax Court with respect to which a decision
2 has not become final (as determined under section 7481
3 of the Internal Revenue Code of 1986) as of the date of
4 the enactment of this Act.

5 **SEC. 104. TAX COURT FILING FEE IN ALL CASES COM-**
6 **MENCED BY FILING PETITION.**

7 (a) **IN GENERAL.**—Section 7451 (relating to fee for
8 filing a Tax Court petition) is amended by striking all that
9 follows “petition” and inserting a period.

10 (b) **EFFECTIVE DATE.**—The amendment made by
11 this section shall take effect on the date of the enactment
12 of this Act.

13 **SEC. 105. AMENDMENTS TO APPOINT EMPLOYEES.**

14 (a) **IN GENERAL.**—Subsection (a) of section 7471
15 (relating to Tax Court employees) is amended to read as
16 follows:

17 “(a) **APPOINTMENT AND COMPENSATION.**—

18 “(1) **CLERK.**—The Tax Court may appoint a
19 clerk without regard to the provisions of title 5,
20 United States Code, governing appointments in the
21 competitive service. The clerk shall serve at the
22 pleasure of the Tax Court.

23 “(2) **LAW CLERKS AND SECRETARIES.**—

24 “(A) **IN GENERAL.**—The judges and spe-
25 cial trial judges of the Tax Court may appoint

1 law clerks and secretaries, in such numbers as
2 the Tax Court may approve, without regard to
3 the provisions of title 5, United States Code,
4 governing appointments in the competitive serv-
5 ice. Any such law clerk or secretary shall serve
6 at the pleasure of the appointing judge.

7 “(B) EXEMPTION FROM FEDERAL LEAVE
8 PROVISIONS.—A law clerk appointed under this
9 subsection shall be exempt from the provisions
10 of subchapter I of chapter 63 of title 5, United
11 States Code. Any unused sick leave or annual
12 leave standing to the employee’s credit as of the
13 effective date of this subsection shall remain
14 credited to the employee and shall be available
15 to the employee upon separation from the Fed-
16 eral Government.

17 “(3) OTHER EMPLOYEES.—The Tax Court may
18 appoint necessary employees without regard to the
19 provisions of title 5, United States Code, governing
20 appointments in the competitive service. Such em-
21 ployees shall be subject to removal by the Tax
22 Court.

23 “(4) PAY.—The Tax Court may fix and adjust
24 the compensation for the clerk and other employees
25 of the Tax Court without regard to the provisions of

1 chapter 51, subchapter III of chapter 53, or section
 2 5373 of title 5, United States Code. To the max-
 3 imum extent feasible, the Tax Court shall com-
 4 pensate employees at rates consistent with those for
 5 employees holding comparable positions in the judi-
 6 cial branch.

7 “(5) PROGRAMS.—The Tax Court may establish
 8 programs for employee evaluations, incentive awards,
 9 flexible work schedules, premium pay, and resolution
 10 of employee grievances.

11 “(6) DISCRIMINATION PROHIBITED.—The Tax
 12 Court shall—

13 “(A) prohibit discrimination on the basis
 14 of race, color, religion, age, sex, national origin,
 15 political affiliation, marital status, or handi-
 16 capping condition; and

17 “(B) promulgate procedures for resolving
 18 complaints of discrimination by employees and
 19 applicants for employment.

20 “(7) EXPERTS AND CONSULTANTS.—The Tax
 21 Court may procure the services of experts and con-
 22 sultants under section 3109 of title 5, United States
 23 Code.

24 “(8) RIGHTS TO CERTAIN APPEALS RE-
 25 SERVED.—Notwithstanding any other provision of

1 law, an individual who is an employee of the Tax
2 Court on the day before the effective date of this
3 subsection and who, as of that day, was entitled
4 to—

5 “(A) appeal a reduction in grade or re-
6 moval to the Merit Systems Protection Board
7 under chapter 43 of title 5, United States Code,

8 “(B) appeal an adverse action to the Merit
9 Systems Protection Board under chapter 75 of
10 title 5, United States Code,

11 “(C) appeal a prohibited personnel practice
12 described under section 2302(b) of title 5,
13 United States Code, to the Merit Systems Pro-
14 tection Board under chapter 77 of that title,

15 “(D) make an allegation of a prohibited
16 personnel practice described under section
17 2302(b) of title 5, United States Code, with the
18 Office of Special Counsel under chapter 12 of
19 that title for action in accordance with that
20 chapter, or

21 “(E) file an appeal with the Equal Em-
22 ployment Opportunity Commission under part
23 1614 of title 29 of the Code of Federal Regula-
24 tions,

1 shall be entitled to file such appeal or make such an
2 allegation so long as the individual remains an em-
3 ployee of the Tax Court.

4 “(9) COMPETITIVE STATUS.—Notwithstanding
5 any other provision of law, any employee of the Tax
6 Court who has completed at least 1 year of contin-
7 uous service under a non-temporary appointment
8 with the Tax Court acquires a competitive status for
9 appointment to any position in the competitive serv-
10 ice for which the employee possesses the required
11 qualifications.

12 “(10) MERIT SYSTEM PRINCIPLES; PROHIBITED
13 PERSONNEL PRACTICES; AND PREFERENCE ELIGI-
14 BLES.—Any personnel management system of the
15 Tax Court shall—

16 “(A) include the principles set forth in sec-
17 tion 2301(b) of title 5, United States Code;

18 “(B) prohibit personnel practices prohib-
19 ited under section 2302(b) of title 5, United
20 States Code; and

21 “(C) in the case of any individual who
22 would be a preference eligible in the executive
23 branch, the Tax Court will provide preference
24 for that individual in a manner and to an ex-

1 “(A) ANNUITY TO SURVIVING SPOUSE.—If
2 a judge described in paragraph (2) is survived
3 by a surviving spouse but not by a dependent
4 child, there shall be paid to such surviving
5 spouse an annuity beginning with the day of the
6 death of the judge or following the surviving
7 spouse’s attainment of the age of 50 years,
8 whichever is the later, in an amount computed
9 as provided in subsection (m).

10 “(B) ANNUITY TO CHILD.—If such a judge
11 is survived by a surviving spouse and a depend-
12 ent child or children, there shall be paid to such
13 surviving spouse an immediate annuity in an
14 amount computed as provided in subsection
15 (m), and there shall also be paid to or on behalf
16 of each such child an immediate annuity equal
17 to the lesser of—

18 “(i) 10 percent of the average annual
19 salary of such judge (determined in accord-
20 ance with subsection (m)); or

21 “(ii) 20 percent of such average an-
22 nual salary, divided by the number of such
23 children.

24 “(C) ANNUITY TO SURVIVING DEPENDENT
25 CHILDREN.—If such a judge leaves no surviving

1 spouse but leaves a surviving dependent child or
2 children, there shall be paid to or on behalf of
3 each such child an immediate annuity equal to
4 the lesser of—

5 “(i) 20 percent of the average annual
6 salary of such judge (determined in accord-
7 ance with subsection (m)); or

8 “(ii) 40 percent of such average an-
9 nual salary, divided by the number of such
10 children.

11 “(2) COVERED JUDGES.—Paragraph (1) applies
12 to any judge electing under subsection (b)—

13 “(A) who dies while a judge after having
14 rendered at least 5 years of civilian service com-
15 puted as prescribed in subsection (n); for the
16 last 5 years of which the salary deductions pro-
17 vided for by subsection (e)(1) or the deposits
18 required by subsection (d) have actually been
19 made or the salary deductions required by the
20 civil service retirement laws have actually been
21 made; or

22 “(B) who dies by assassination after hav-
23 ing rendered less than 5 years of civilian service
24 computed as prescribed in subsection (n) if, for
25 the period of such service, the salary deductions

1 provided for by subsection (c)(1) or the deposits
2 required by subsection (d) have actually been
3 made.

4 “(3) TERMINATION OF ANNUITY.—

5 “(A) IN THE CASE OF A SURVIVING
6 SPOUSE.—The annuity payable to a surviving
7 spouse under this subsection shall be terminable
8 upon such surviving spouse’s death or such sur-
9 viving spouse’s remarriage before attaining age
10 55.

11 “(B) IN THE CASE OF A CHILD.—The an-
12 nuity payable to a child under this subsection
13 shall be terminable upon (i) the child attaining
14 the age of 18 years, (ii) the child’s marriage, or
15 (iii) the child’s death, whichever first occurs, ex-
16 cept that if such child is incapable of self-sup-
17 port by reason of mental or physical disability
18 the child’s annuity shall be terminable only
19 upon death, marriage, or recovery from such
20 disability.

21 “(C) IN THE CASE OF A DEPENDENT
22 CHILD AFTER DEATH OF SURVIVING SPOUSE.—
23 In case of the death of a surviving spouse of a
24 judge leaving a dependent child or children of
25 the judge surviving such spouse, the annuity of

1 such child or children shall be recomputed and
2 paid as provided in paragraph (1)(C).

3 “(D) RECOMPUTATION.—In any case in
4 which the annuity of a dependent child is termi-
5 nated under this subsection, the annuities of
6 any remaining dependent child or children,
7 based upon the service of the same judge, shall
8 be recomputed and paid as though the child
9 whose annuity was so terminated had not sur-
10 vived such judge.

11 “(4) SPECIAL RULE FOR ASSASSINATED
12 JUDGES.—In the case of a survivor or survivors of
13 a judge described in paragraph (2)(B), there shall be
14 deducted from the annuities otherwise payable under
15 this section an amount equal to—

16 “(A) the amount of salary deductions pro-
17 vided for by subsection (e)(1) that would have
18 been made if such deductions had been made
19 for 5 years of civilian service computed as pre-
20 scribed in subsection (n) before the judge’s
21 death, reduced by

22 “(B) the amount of such salary deductions
23 that were actually made before the date of the
24 judge’s death.”

1 (b) DEFINITION OF ASSASSINATION.—Section
 2 7448(a) (relating to definitions) is amended by adding at
 3 the end the following new paragraph:

4 “(8) The terms ‘assassinated’ and ‘assassina-
 5 tion’ mean the killing of a judge that is motivated
 6 by the performance by that judge of his or her offi-
 7 cial duties.”.

8 (c) DETERMINATION OF ASSASSINATION.—Sub-
 9 section (i) of section 7448 is amended—

10 (1) by striking the subsection heading and in-
 11 serting the following:

12 “(i) DETERMINATIONS BY CHIEF JUDGE.—

13 “(1) DEPENDENCY AND DISABILITY.—”,

14 (2) by moving the text 2 ems to the right, and

15 (3) by adding at the end the following new
 16 paragraph:

17 “(2) ASSASSINATION.—The chief judge shall
 18 determine whether the killing of a judge was an as-
 19 sassination, subject to review only by the Tax Court.
 20 The head of any Federal agency that investigates
 21 the killing of a judge shall provide information to
 22 the chief judge that would assist the chief judge in
 23 making such a determination.”.

24 (d) COMPUTATION OF ANNUITIES.—Subsection (m)
 25 of section 7448 is amended—

1 (1) by striking the subsection heading and in-
2 serting the following:

3 “(m) COMPUTATION OF ANNUITIES.—

4 “(1) IN GENERAL.—”;

5 (2) by moving the text 2 ems to the right, and

6 (3) by adding at the end the following new
7 paragraph:

8 “(2) ASSASSINATED JUDGES.—In the case of a
9 judge who is assassinated and who has served less
10 than 3 years, the annuity of the surviving spouse of
11 such judge shall be based upon the average annual
12 salary received by such judge for judicial service.”.

13 (e) OTHER BENEFITS.—Section 7448 is amended by
14 adding at the end the following:

15 “(u) OTHER BENEFITS.—In the case of a judge who
16 is assassinated, an annuity shall be paid under this section
17 notwithstanding a survivor’s eligibility for or receipt of
18 benefits under chapter 81 of title 5, United States Code,
19 except that the annuity for which a surviving spouse is
20 eligible under this section shall be reduced to the extent
21 that the total benefits paid under this section and chapter
22 81 of that title for any year would exceed the current sal-
23 ary for that year of the office of the judge.”.

1 **SEC. 202. COST-OF-LIVING ADJUSTMENTS FOR TAX COURT**
 2 **JUDICIAL SURVIVOR ANNUITIES.**

3 (a) **IN GENERAL.**—Subsection (s) of section 7448
 4 (relating to annuities to surviving spouses and dependent
 5 children of judges) is amended to read as follows:

6 “(s) **INCREASES IN SURVIVOR ANNUITIES.**—Each
 7 time that an increase is made under section 8340(b) of
 8 title 5, United States Code, in annuities payable under
 9 subchapter III of chapter 83 of that title, each annuity
 10 payable from the survivors annuity fund under this section
 11 shall be increased at the same time by the same percent-
 12 age by which annuities are increased under such section
 13 8340(b).”.

14 (b) **EFFECTIVE DATE.**—The amendments made by
 15 this section shall apply with respect to increases made
 16 under section 8340(b) of title 5, United States Code, in
 17 annuities payable under subchapter III of chapter 83 of
 18 that title, taking effect after the date of the enactment
 19 of this Act.

20 **SEC. 203. LIFE INSURANCE COVERAGE FOR TAX COURT**
 21 **JUDGES.**

22 (a) **IN GENERAL.**—Section 7447 (relating to retire-
 23 ment of judges) is amended by adding at the end the fol-
 24 lowing new subsection:

25 “(j) **LIFE INSURANCE COVERAGE.**—For pur-
 26 poses of chapter 87 of title 5, United States Code

1 (relating to life insurance), any individual who is
2 serving as a judge of the Tax Court or who is retired
3 under this section is deemed to be an employee who
4 is continuing in active employment.”.

5 (b) EFFECTIVE DATE.—The amendment made by
6 this section shall apply to any individual serving as a judge
7 of the United States Tax Court or to any retired judge
8 of the United States Tax Court on the date of the enact-
9 ment of this Act.

10 **SEC. 204. COST OF LIFE INSURANCE COVERAGE FOR TAX**
11 **COURT JUDGES AGE 65 OR OVER.**

12 Section 7472 (relating to expenditures) is amended
13 by inserting after the first sentence the following new sen-
14 tence: “Notwithstanding any other provision of law, the
15 Tax Court is authorized to pay on behalf of its judges,
16 age 65 or over, any increase in the cost of Federal Em-
17 ployees’ Group Life Insurance imposed after April 24,
18 1999, including any expenses generated by such payments,
19 as authorized by the chief judge in a manner consistent
20 with such payments authorized by the Judicial Conference
21 of the United States pursuant to section 604(a)(5) of title
22 28, United States Code.”.

1 **SEC. 205. MODIFICATION OF TIMING OF LUMP-SUM PAY-**
2 **MENT OF JUDGES' ACCRUED ANNUAL LEAVE.**

3 (a) **IN GENERAL.**—Section 7443 (relating to mem-
4 bership of the Tax Court) is amended by adding at the
5 end the following new subsection:

6 “(h) **LUMP-SUM PAYMENT OF JUDGES' ACCRUED**
7 **ANNUAL LEAVE.**—Notwithstanding the provisions of sec-
8 tions 5551 and 6301 of title 5, United States Code, when
9 an individual subject to the leave system provided in chap-
10 ter 63 of that title is appointed by the President to be
11 a judge of the Tax Court, the individual shall be entitled
12 to receive, upon appointment to the Tax Court, a lump-
13 sum payment from the Tax Court of the accumulated and
14 accrued current annual leave standing to the individual's
15 credit as certified by the agency from which the individual
16 resigned.”.

17 (b) **EFFECTIVE DATE.**—The amendment made by
18 this section shall apply to any judge of the United States
19 Tax Court who has an outstanding leave balance on the
20 date of the enactment of this Act and to any individual
21 appointed by the President to serve as a judge of the
22 United States Tax Court after such date.

1 **SEC. 206. PARTICIPATION OF TAX COURT JUDGES IN THE**
 2 **THRIFT SAVINGS PLAN.**

3 (a) **IN GENERAL.**—Section 7447 (relating to retire-
 4 ment of judges), as amended by this Act, is amended by
 5 adding at the end the following new subsection:

6 “(k) **THRIFT SAVINGS PLAN.**—

7 “(1) **ELECTION TO CONTRIBUTE.**—

8 “(A) **IN GENERAL.**—A judge of the Tax
 9 Court may elect to contribute to the Thrift Sav-
 10 ings Fund established by section 8437 of title
 11 5, United States Code.

12 “(B) **PERIOD OF ELECTION.**—An election
 13 may be made under this paragraph only during
 14 a period provided under section 8432(b) of title
 15 5, United States Code, for individuals subject to
 16 chapter 84 of such title.

17 “(2) **APPLICABILITY OF TITLE 5 PROVISIONS.**—

18 Except as otherwise provided in this subsection, the
 19 provisions of subchapters III and VII of chapter 84
 20 of title 5, United States Code, shall apply with re-
 21 spect to a judge who makes an election under para-
 22 graph (1).

23 “(3) **SPECIAL RULES.**—

24 “(A) **AMOUNT CONTRIBUTED.**—The
 25 amount contributed by a judge to the Thrift
 26 Savings Fund in any pay period shall not ex-

1 ceed the maximum percentage of such judge's
 2 basic pay for such period as allowable under
 3 section 8440f of title 5, United States Code.
 4 Basic pay does not include any retired pay paid
 5 pursuant to this section.

6 “(B) CONTRIBUTIONS FOR BENEFIT OF
 7 JUDGE.—No contributions may be made for the
 8 benefit of a judge under section 8432(e) of title
 9 5, United States Code.

10 “(C) APPLICABILITY OF SECTION 8433(b)
 11 OF TITLE 5 WHETHER OR NOT JUDGE RE-
 12 TIRES.—Section 8433(b) of title 5, United
 13 States Code, applies with respect to a judge
 14 who makes an election under paragraph (1) and
 15 who either—

16 “(i) retires under subsection (b), or

17 “(ii) ceases to serve as a judge of the
 18 Tax Court but does not retire under sub-
 19 section (b).

20 Retirement under subsection (b) is a separation
 21 from service for purposes of subchapters III
 22 and VII of chapter 84 of that title.

23 “(D) APPLICABILITY OF SECTION
 24 8351(b)(5) OF TITLE 5.—The provisions of sec-
 25 tion 8351(b)(5) of title 5, United States Code,

1 shall apply with respect to a judge who makes
2 an election under paragraph (1).

3 “(E) EXCEPTION.—Notwithstanding sub-
4 paragraph (C), if any judge retires under this
5 section, or resigns without having met the age
6 and service requirements set forth under sub-
7 section (b)(2), and such judge’s nonforfeitable
8 account balance is less than an amount that the
9 Executive Director of the Office of Personnel
10 Management prescribes by regulation, the Exec-
11 utive Director shall pay the nonforfeitable ac-
12 count balance to the participant in a single pay-
13 ment.”.

14 (b) EFFECTIVE DATE.—The amendment made by
15 this section shall take effect on the date of the enactment
16 of this Act, except that United States Tax Court judges
17 may only begin to participate in the Thrift Savings Plan
18 at the next open season beginning after such date.

19 **SEC. 207. EXEMPTION OF TEACHING COMPENSATION OF**
20 **RETIRED JUDGES FROM LIMITATION ON**
21 **OUTSIDE EARNED INCOME.**

22 (a) IN GENERAL.—Section 7447 (relating to retire-
23 ment of judges), as amended by this Act, is amended by
24 adding at the end the following new subsection:

1 “(1) TEACHING COMPENSATION OF RETIRED

20 spouse if the magistrate judge establishes to the

1 “(o) TAX COURT JUDICIAL OFFICERS’ RETIREMENT
2 FUND.—

3 “(1) ESTABLISHMENT.—There is established in
4 the Treasury a fund which shall be known as the
5 ‘Tax Court Judicial Officers’ Retirement Fund’.
6 Amounts in the Fund are authorized to be appro-
7 priated for the payment of annuities, refunds, and
8 other payments under this section.

9 “(2) INVESTMENT OF FUND.—The Secretary
10 shall invest, in interest bearing securities of the
11 United States, such currently available portions of
12 the Tax Court Judicial Officers’ Retirement Fund as
13 are not immediately required for payments from the
14 Fund. The income derived from these investments
15 constitutes a part of the Fund.

16 “(3) UNFUNDED LIABILITY.—

17 “(A) IN GENERAL.—There are authorized

20 reduce to zero the unfunded liability of the

9 “(ii) the balance in the Fund as of the
 10 date the unfunded liability is determined.

11 “(p) PARTICIPATION IN THRIFT SAVINGS PLAN.—

12 “(1) ELECTION TO CONTRIBUTE.—

13 “(A) IN GENERAL.—A magistrate judge of
 14 the Tax Court who elects to receive an annuity
 15 under this section or under section 211 of the
 16 United States Tax Court Modernization Act
 17 may elect to contribute an amount of such indi-

 19 established by section 8437 of title 5, United

21 “(B) PERIOD OF ELECTION.—An election

13 able under section 8440f of title 5, United

15 “(B) CONTRIBUTIONS FOR BENEFIT OF
16 JUDGE.—No contributions may be made for the
17 benefit of a magistrate judge under section
18 8432(e) of title 5, United States Code.

19 “(C) APPLICABILITY OF SECTION 8433(b)
20 OF TITLE 5.—Section 8433(b) of title 5, United
21 States Code, applies with respect to a mag-
22 istrate judge who makes an election under para-
23 graph (1) and—

24 “(i) who retires entitled to an imme-
25 diate annuity under this section (including

1 a disability annuity under subsection (d) of
2 this section) or section 211 of the United
3 States Tax Court Modernization Act,

4 “(ii) who retires before attaining age
5 65 but is entitled, upon attaining age 65,
6 to an annuity under this section or section
7 211 of the United States Tax Court Mod-
8 ernization Act, or

9 “(iii) who retires before becoming en-
10 titled to an immediate annuity, or an an-
11 nuity upon attaining age 65, under this
12 section or section 211 of the United States
13 Tax Court Modernization Act.

14 “(D) SEPARATION FROM SERVICE.—With
15 respect to a magistrate judge to whom this sub-
16 section applies, retirement under this section or
17 section 211 of the United States Tax Court
18 Modernization Act is a separation from service
19 for purposes of subchapters III and VII of
20 chapter 84 of title 5, United States Code.

21 “(4) DEFINITIONS.—For purposes of this sub-
22 section, the terms ‘retirement’ and ‘retire’ include
23 removal from office under section 7443A(a)(2) on
24 the sole ground of mental or physical disability.

1 “(5) OFFSET.—In the case of a magistrate
2 judge who receives a distribution from the Thrift
3 Savings Fund and who later receives an annuity
4 under this section, that annuity shall be offset by an
5 amount equal to the amount which represents the
6 Government’s contribution to that person’s Thrift
7 Savings Account, without regard to earnings attrib-
8 utable to that amount. Where such an offset would
9 exceed 50 percent of the annuity to be received in
10 the first year, the offset may be divided equally over
11 the first 2 years in which that person receives the
12 annuity.

13 “(6) EXCEPTION.—Notwithstanding clauses (i)
14 and (ii) of paragraph (3)(C), if any magistrate judge
15 retires under circumstances making such magistrate
16 judge eligible to make an election under subsection
17 (b) of section 8433 of title 5, United States Code,
18 and such magistrate judge’s nonforfeitable account
19 balance is less than an amount that the Executive
20 Director of the Office of Personnel Management pre-
21 scribes by regulation, the Executive Director shall
22 pay the nonforfeitable account balance to the partici-
23 pant in a single payment.”.

15 “(b) COMPENSATION.—For the year in which a pe-
16 riod of recall occurs, the magistrate judge shall receive,
17 in addition to the annuity provided under the provisions
18 of section 7443B or under the applicable provisions of title
19 5, United States Code, an amount equal to the difference
20 between that annuity and the current salary of the office
21 to which the magistrate judge is recalled. The annuity of
22 the magistrate judge who completes that period of service,
23 who is not recalled in a subsequent year, and who retired
24 under section 7443B, shall be equal to the salary in effect

1 at the end of the year in which the period of recall oc-
 2 curred for the office from which such individual retired.

14 *extent feasible, the Tax Court shall compensate em-*
15 *ployees at rates consistent with those for employees*
16 *holding comparable positions in the judicial branch.*

18 *programs for employee evaluations, incentive awards,*
19 *flexible work schedules, premium pay, and resolution*
20 *of employee grievances.*

21 “(6) *DISCRIMINATION PROHIBITED.*—*The Tax*
22 *Court shall—*

23 “(A) *prohibit discrimination on the basis of*
24 *race, color, religion, age, sex, national origin, po-*

1 *litical affiliation, marital status, or handi-*
2 *capping condition; and*

3 “(B) *promulgate procedures for resolving*
4 *complaints of discrimination by employees and*
5 *applicants for employment.*

6 “(7) *EXPERTS AND CONSULTANTS.—The Tax*
7 *Court may procure the services of experts and consult-*
8 *ants under section 3109 of title 5, United States Code.*

9 “(8) *RIGHTS TO CERTAIN APPEALS RESERVED.—*
10 *Notwithstanding any other provision of law, an indi-*
11 *vidual who is an employee of the Tax Court on the*
12 *day before the effective date of this subsection and*
13 *who, as of that day, was entitled to—*

14 “(A) *appeal a reduction in grade or re-*
15 *moval to the Merit Systems Protection Board*
16 *under chapter 43 of title 5, United States Code,*

17 “(B) *appeal an adverse action to the Merit*
18 *Systems Protection Board under chapter 75 of*
19 *title 5, United States Code,*

20 “(C) *appeal a prohibited personnel practice*
21 *described under section 2302(b) of title 5, United*
22 *States Code, to the Merit Systems Protection*
23 *Board under chapter 77 of that title,*

24 “(D) *make an allegation of a prohibited*
25 *personnel practice described under section*

1 2302(b) of title 5, United States Code, with the
2 Office of Special Counsel under chapter 12 of
3 that title for action in accordance with that
4 chapter, or

5 “(E) file an appeal with the Equal Employ-
6 ment Opportunity Commission under part 1614
7 of title 29 of the Code of Federal Regulations,
8 shall be entitled to file such appeal or make such an
9 allegation so long as the individual remains an em-
10 ployee of the Tax Court.

11 “(9) *COMPETITIVE STATUS*.—Notwithstanding
12 any other provision of law, any employee of the Tax
13 Court who has completed at least 1 year of continuous
14 service under a non-temporary appointment with the
15 Tax Court acquires a competitive status for appoint-
16 ment to any position in the competitive service for
17 which the employee possesses the required qualifica-
18 tions.

19 “(10) *MERIT SYSTEM PRINCIPLES; PROHIBITED*
20 *PERSONNEL PRACTICES; AND PREFERENCE ELIGI-*
21 *BLES*.—Any personnel management system of the Tax
22 Court shall—

23 “(A) include the principles set forth in sec-
24 tion 2301(b) of title 5, United States Code;

1 **TITLE II—TAX COURT PENSION**
2 **AND COMPENSATION**

3 **SEC. 201. ANNUITIES FOR SURVIVORS OF TAX COURT**
4 **JUDGES WHO ARE ASSASSINATED.**

5 (a) *ELIGIBILITY IN CASE OF DEATH BY ASSASSINA-*
6 *TION.—Subsection (h) of section 7448 (relating to annuities*
7 *to surviving spouses and dependent children of judges) is*
8 *amended to read as follows:*

9 “(h) *ENTITLEMENT TO ANNUITY.—*

10 “(1) *IN GENERAL.—*

11 “(A) *ANNUITY TO SURVIVING SPOUSE.—If a*
12 *judge described in paragraph (2) is survived by*
13 *a surviving spouse but not by a dependent child,*
14 *there shall be paid to such surviving spouse an*
15 *annuity beginning with the day of the death of*
16 *the judge or following the surviving spouse’s at-*
17 *tainment of the age of 50 years, whichever is the*
18 *later, in an amount computed as provided in*
19 *subsection (m).*

20 “(B) *ANNUITY TO CHILD.—If such a judge*
21 *is survived by a surviving spouse and a depend-*
22 *ent child or children, there shall be paid to such*
23 *surviving spouse an immediate annuity in an*
24 *amount computed as provided in subsection (m),*
25 *and there shall also be paid to or on behalf of*

1 *each such child an immediate annuity equal to*
2 *the lesser of—*

3 “(i) 10 percent of the average annual
4 salary of such judge (determined in accord-
5 ance with subsection (m)), or

6 “(ii) 20 percent of such average annual
7 salary, divided by the number of such chil-
8 dren.

9 “(C) *ANNUITY TO SURVIVING DEPENDENT*
10 *CHILDREN.—If such a judge leaves no surviving*
11 *spouse but leaves a surviving dependent child or*
12 *children, there shall be paid to or on behalf of*
13 *each such child an immediate annuity equal to*
14 *the lesser of—*

15 “(i) 20 percent of the average annual
16 salary of such judge (determined in accord-
17 ance with subsection (m)), or

18 “(ii) 40 percent of such average annual
19 salary, divided by the number of such chil-
20 dren.

21 “(2) *COVERED JUDGES.—Paragraph (1) applies*
22 *to any judge electing under subsection (b)—*

23 “(A) *who dies while a judge after having*
24 *rendered at least 5 years of civilian service com-*
25 *puted as prescribed in subsection (n), for the last*

1 5 years of which the salary deductions provided
2 for by subsection (c)(1) or the deposits required
3 by subsection (d) have actually been made or the
4 salary deductions required by the civil service re-
5 irement laws have actually been made, or

6 “(B) who dies by assassination after having
7 rendered less than 5 years of civilian service
8 computed as prescribed in subsection (n) if, for
9 the period of such service, the salary deductions
10 provided for by subsection (c)(1) or the deposits
11 required by subsection (d) have actually been
12 made.

13 “(3) *TERMINATION OF ANNUITY.*—

14 “(A) *IN THE CASE OF A SURVIVING*
15 *SPOUSE.*—The annuity payable to a surviving
16 spouse under this subsection shall be terminable
17 upon such surviving spouse’s death or such sur-
18 viving spouse’s remarriage before attaining age
19 55.

20 “(B) *IN THE CASE OF A CHILD.*—The annu-
21 ity payable to a child under this subsection shall
22 be terminable upon (i) the child attaining the
23 age of 18 years, (ii) the child’s marriage, or (iii)
24 the child’s death, whichever first occurs, except
25 that if such child is incapable of self-support by

1 *reason of mental or physical disability the*
2 *child's annuity shall be terminable only upon*
3 *death, marriage, or recovery from such dis-*
4 *ability.*

5 “(C) *IN THE CASE OF A DEPENDENT CHILD*
6 *AFTER DEATH OF SURVIVING SPOUSE.—In case*
7 *of the death of a surviving spouse of a judge*
8 *leaving a dependent child or children of the*
9 *judge surviving such spouse, the annuity of such*
10 *child or children shall be recomputed and paid*
11 *as provided in paragraph (1)(C).*

12 “(D) *RECOMPUTATION.—In any case in*
13 *which the annuity of a dependent child is termi-*
14 *nated under this subsection, the annuities of any*
15 *remaining dependent child or children, based*
16 *upon the service of the same judge, shall be re-*
17 *computed and paid as though the child whose*
18 *annuity was so terminated had not survived*
19 *such judge.*

20 “(4) *SPECIAL RULE FOR ASSASSINATED*
21 *JUDGES.—In the case of a survivor or survivors of a*
22 *judge described in paragraph (2)(B), there shall be*
23 *deducted from the annuities otherwise payable under*
24 *this section an amount equal to—*

1 “(A) the amount of salary deductions pro-
 2 vided for by subsection (c)(1) that would have
 3 been made if such deductions had been made for
 4 5 years of civilian service computed as pre-
 5 scribed in subsection (n) before the judge’s death,
 6 reduced by

7 “(B) the amount of such salary deductions
 8 that were actually made before the date of the
 9 judge’s death.”.

10 (b) *DEFINITION OF ASSASSINATION.*—Section 7448(a)
 11 (relating to definitions) is amended by adding at the end
 12 the following new paragraph:

13 “(8) The terms ‘assassinated’ and ‘assassination’
 14 mean the killing of a judge that is motivated by the
 15 performance by that judge of his or her official du-
 16 ties.”.

17 (c) *DETERMINATION OF ASSASSINATION.*—Subsection
 18 (i) of section 7448 is amended—

19 (1) by striking the subsection heading and in-
 20 serting the following:

21 “(i) *DETERMINATIONS BY CHIEF JUDGE.*—

22 “(1) *DEPENDENCY AND DISABILITY.*—”,

23 (2) by moving the text 2 ems to the right, and

24 (3) by adding at the end the following new para-
 25 graph:

1 “(2) *ASSASSINATION.*—*The chief judge shall de-*
2 *termine whether the killing of a judge was an assas-*
3 *sination, subject to review only by the Tax Court. The*
4 *head of any Federal agency that investigates the kill-*
5 *ing of a judge shall provide information to the chief*
6 *judge that would assist the chief judge in making such*
7 *a determination.*”.

8 (d) *COMPUTATION OF ANNUITIES.*—*Subsection (m) of*
9 *section 7448 is amended—*

10 (1) *by striking the subsection heading and in-*
11 *serting the following:*

12 “(m) *COMPUTATION OF ANNUITIES.*—

17 “(2) *ASSASSINATED JUDGES.*—*In the case of a*

20 *such judge shall be based upon the average annual*
21 *salary received by such judge for judicial service.*”.

22 (e) *OTHER BENEFITS.*—*Section 7448 is amended by*
23 *adding at the end the following:*

24 “(u) *OTHER BENEFITS.*—*In the case of a judge who*
25 *is assassinated, an annuity shall be paid under this section*

1 *notwithstanding a survivor's eligibility for or receipt of*
 2 *benefits under chapter 81 of title 5, United States Code,*
 3 *except that the annuity for which a surviving spouse is eli-*
 4 *gible under this section shall be reduced to the extent that*
 5 *the total benefits paid under this section and chapter 81*
 6 *of that title for any year would exceed the current salary*
 7 *for that year of the office of the judge.”.*

8 **SEC. 202. COST-OF-LIVING ADJUSTMENTS FOR TAX COURT**
 9 **JUDICIAL SURVIVOR ANNUITIES.**

10 (a) *IN GENERAL.*—*Subsection (s) of section 7448 (re-*
 11 *lating to annuities to surviving spouses and dependent chil-*
 12 *dren of judges) is amended to read as follows:*

13 “(s) *INCREASES IN SURVIVOR ANNUITIES.*—*Each time*
 14 *that an increase is made under section 8340(b) of title 5,*

1 **SEC. 203. LIFE INSURANCE COVERAGE FOR TAX COURT**
2 **JUDGES.**

6 “(j) *LIFE INSURANCE COVERAGE.*—For purposes
7 of chapter 87 of title 5, United States Code (relating
8 to life insurance), any individual who is serving as
9 a judge of the Tax Court or who is retired under this
10 section is deemed to be an employee who is continuing
11 in active employment.”.

12 (b) *EFFECTIVE DATE.*—The amendment made by this
13 section shall apply to any individual serving as a judge
14 of the United States Tax Court and to any retired judge
15 of the United States Tax Court on or after the date of the
16 enactment of this Act.

17 **SEC. 204. COST OF LIFE INSURANCE COVERAGE FOR TAX**
18 **COURT JUDGES AGE 65 OR OVER.**

19 Section 7472 (relating to expenditures) is amended by
20 inserting after the first sentence the following new sentence:
21 “Notwithstanding any other provision of law, the Tax
22 Court is authorized to pay on behalf of its judges, age 65
23 or over, any increase in the cost of Federal Employees’
24 Group Life Insurance imposed after April 24, 1999, includ-

26 by the chief judge in a manner consistent with such pay-

1 *ments authorized by the Judicial Conference of the United*
2 *States pursuant to section 604(a)(5) of title 28, United*
3 *States Code.”.*

4 **SEC. 205. MODIFICATION OF TIMING OF LUMP-SUM PAY-**
5 **MENT OF JUDGES’ ACCRUED ANNUAL LEAVE.**

7 *ship of the Tax Court) is amended by adding at the end*

9 “(h) *LUMP-SUM PAYMENT OF JUDGES’ ACCRUED AN-*

12 *vidual subject to the leave system provided in chapter 63*

6 “(k) *THRIFT SAVINGS PLAN.*—

7 “(1) *ELECTION TO CONTRIBUTE.*—

8 “(A) *IN GENERAL.*—A judge of the Tax
9 Court may elect to contribute to the Thrift Sav-
10 ings Fund established by section 8437 of title 5,
11 United States Code.

12 “(B) *PERIOD OF ELECTION.*—An election
13 may be made under this paragraph as provided
14 under section 8432(b) of title 5, United States
15 Code, for individuals subject to chapter 84 of
16 such title.

17 “(2) *APPLICABILITY OF TITLE 5 PROVISIONS.*—
18 Except as otherwise provided in this subsection, the
19 provisions of subchapters III and VII of chapter 84
20 of title 5, United States Code, shall apply with re-
21 spect to a judge who makes an election under para-
22 graph (1).

23 “(3) *SPECIAL RULES.*—

24 “(A) *AMOUNT CONTRIBUTED.*—The amount
25 contributed by a judge to the Thrift Savings
26 Fund in any pay period shall not exceed the

1 *maximum percentage of such judge’s basic pay*
 2 *for such period as allowable under section 8440f*
 3 *of title 5, United States Code. Basic pay does not*
 4 *include any retired pay paid pursuant to this*
 5 *section.*

6 “(B) CONTRIBUTIONS FOR BENEFIT OF
 7 JUDGE.—*No contributions may be made for the*
 8 *benefit of a judge under section 8432(c) of title*
 9 *5, United States Code.*

10 “(C) APPLICABILITY OF SECTION 8433(b) OF
 11 TITLE 5 WHETHER OR NOT JUDGE RETIRES.—
 12 *Section 8433(b) of title 5, United States Code,*
 13 *applies with respect to a judge who makes an*
 14 *election under paragraph (1) and who either—*

15 “(i) *retires under subsection (b), or*
 16 “(ii) *ceases to serve as a judge of the*
 17 *Tax Court but does not retire under sub-*
 18 *section (b).*

19 *Retirement under subsection (b) is a separation*
 20 *from service for purposes of subchapters III and*
 21 *VII of chapter 84 of that title.*

22 “(D) APPLICABILITY OF SECTION 8351(b)(5)
 23 OF TITLE 5.—*The provisions of section*
 24 *8351(b)(5) of title 5, United States Code, shall*

1 *apply with respect to a judge who makes an elec-*
 2 *tion under paragraph (1).*

3 “(E) *EXCEPTION.*—*Notwithstanding sub-*
 4 *paragraph (C), if any judge retires under this*
 5 *section, or resigns without having met the age*
 6 *and service requirements set forth under sub-*
 7 *section (b)(2), and such judge’s nonforfeitable ac-*
 8 *count balance is less than an amount that the*
 9 *Executive Director of the Office of Personnel*
 10 *Management prescribes by regulation, the Execu-*
 11 *utive Director shall pay the nonforfeitable account*
 12 *balance to the participant in a single payment.”.*

13 (b) *EFFECTIVE DATE.*—*The amendment made by this*
 14 *section shall take effect on the date of the enactment of this*
 15 *Act.*

16 **SEC. 207. EXEMPTION OF TEACHING COMPENSATION OF RE-**

1 *tion 502(a)(5) of such Act shall not be treated as outside*
 2 *earned income when received by a judge of the Tax Court*
 3 *who has retired under subsection (b) for teaching performed*
 4 *during any calendar year for which such a judge has met*
 5 *the requirements of subsection (c), as certified by the chief*
 6 *judge of the Tax Court.”.*

7 **(b) EFFECTIVE DATE.**—*The amendment made by this*
 8 *section shall apply to any individual serving as a retired*
 9 *judge of the United States Tax Court on or after the date*
 10 *of the enactment of this Act.*

3 *“(2) TREATMENT OF UNUSED LEAVE.—*

4 *“(A) AFTER SERVICE AS MAGISTRATE*
5 *JUDGE.—If an individual who is exempted*
6 *under paragraph (1) from the subchapter re-*
7 *ferred to in such paragraph was previously sub-*
8 *ject to such subchapter and, without a break in*
9 *service, again becomes subject to such subchapter*
10 *on completion of the individual’s service as a*
11 *magistrate judge, the unused annual leave and*
12 *sick leave standing to the individual’s credit when*
13 *such individual was exempted from this sub-*

16 *“(B) COMPUTATION OF ANNUITY.—In com-*
17 *puting an annuity under section 8339 of title 5,*

21 *vivor or survivors entitled to an annuity in-*

24 *of unused sick leave standing to the individual’s*

5 “(C) *LUMP SUM PAYMENT.*—*Any accumu-*

9 *be paid in a lump sum at the time of separation*
10 *from service pursuant to the provisions and re-*

19 “(2) **MAGISTRATE JUDGES.**—*Any magistrate*
 20 *judge may by written election filed with the chief*
 21 *judge bring himself or herself within the purview of*

24 “(A) *6 months after the date of the enact-*
 25 *ment of this paragraph,*

1 “(B) the date the judge takes office, or

2 “(C) the date the judge marries.”.

11 (a) *RETIREMENT AND ANNUITY PROGRAM.—Part I of*
12 *subchapter C of chapter 76 is amended by inserting after*
13 *section 7443A the following new section:*

14 **“SEC. 7443B. RETIREMENT FOR MAGISTRATE JUDGES OF**
15 **THE TAX COURT.**

16 “(a) *RETIREMENT BASED ON YEARS OF SERVICE.—*
17 *A magistrate judge of the Tax Court to whom this section*
18 *applies and who retires from office after attaining the age*
19 *of 65 years and serving at least 14 years, whether continu-*
20 *ously or otherwise, as such magistrate judge shall, subject*
21 *to subsection (f), be entitled to receive, during the remainder*
22 *of the magistrate judge’s lifetime, an annuity equal to the*
23 *salary being received at the time the magistrate judge leaves*
24 *office.*”

1 “(b) *RETIREMENT UPON FAILURE OF REAPPOINT-*
2 *MENT.*—A magistrate judge of the Tax Court to whom this
3 section applies who is not reappointed following the expira-
4 tion of the term of office of such magistrate judge, and who
5 retires upon the completion of the term shall, subject to sub-
6 section (f), be entitled to receive, upon attaining the age
7 of 65 years and during the remainder of such magistrate
8 judge’s lifetime, an annuity equal to that portion of the sal-
9 ary being received at the time the magistrate judge leaves
10 office which the aggregate number of years of service, not
11 to exceed 14, bears to 14, if—

12 “(1) such magistrate judge has served at least 1
13 full term as a magistrate judge, and

14 “(2) not earlier than 9 months before the date on
15 which the term of office of such magistrate judge ex-
16 pires, and not later than 6 months before such date,
17 such magistrate judge notified the chief judge of the
18 Tax Court in writing that such magistrate judge was
19 willing to accept reappointment to the position in
20 which such magistrate judge was serving.

21 “(c) *SERVICE OF AT LEAST 8 YEARS.*—A magistrate
22 judge of the Tax Court to whom this section applies and
23 who retires after serving at least 8 years, whether continu-
24 ously or otherwise, as such a magistrate judge shall, subject
25 to subsection (f), be entitled to receive, upon attaining the

1 *age of 65 years and during the remainder of the magistrate*
2 *judge's lifetime, an annuity equal to that portion of the sal-*
3 *ary being received at the time the magistrate judge leaves*
4 *office which the aggregate number of years of service, not*
5 *to exceed 14, bears to 14. Such annuity shall be reduced*
6 *by $\frac{1}{6}$ of 1 percent for each full month such magistrate judge*
7 *was under the age of 65 at the time the magistrate judge*
8 *left office, except that such reduction shall not exceed 20*
9 *percent.*

10 “(d) *RETIREMENT FOR DISABILITY.*—A magistrate
11 *judge of the Tax Court to whom this section applies, who*
12 *has served at least 5 years, whether continuously or other-*
13 *wise, as such a magistrate judge, and who retires or is re-*
14 *moved from office upon the sole ground of mental or phys-*
15 *ical disability shall, subject to subsection (f), be entitled to*
16 *receive, during the remainder of the magistrate judge's life-*
17 *time, an annuity equal to 40 percent of the salary being*
18 *received at the time of retirement or removal or, in the case*
19 *of a magistrate judge who has served for at least 10 years,*
20 *an amount equal to that proportion of the salary being re-*
21 *ceived at the time of retirement or removal which the aggre-*
22 *gate number of years of service, not to exceed 14, bears to*
23 *14.*

24 “(e) *COST-OF-LIVING ADJUSTMENTS.*—A magistrate
25 *judge of the Tax Court who is entitled to an annuity under*

1 *this section is also entitled to a cost-of-living adjustment*
2 *in such annuity, calculated and payable in the same man-*
3 *ner as adjustments under section 8340(b) of title 5, United*
4 *States Code, except that any such annuity, as increased*
5 *under this subsection, may not exceed the salary then pay-*
6 *able for the position from which the magistrate judge retired*
7 *or was removed.*

8 “(f) *ELECTION; ANNUITY IN LIEU OF OTHER ANNU-*
9 *ITIES.—*

10 “(1) *IN GENERAL.—A magistrate judge of the*
11 *Tax Court shall be entitled to an annuity under this*
12 *section if the magistrate judge elects an annuity*
13 *under this section by notifying the chief judge of the*
14 *Tax Court not later than the later of—*

15 “(A) *5 years after the magistrate judge of*
16 *the Tax Court begins judicial service, or*

17 “(B) *5 years after the date of the enactment*
18 *of this subsection.*

19 *Such notice shall be given in accordance with proce-*
20 *dures prescribed by the Tax Court.*

21 “(2) *ANNUITY IN LIEU OF OTHER ANNUITY.—A*
22 *magistrate judge who elects to receive an annuity*
23 *under this section shall not be entitled to receive—*

24 “(A) *any annuity to which such magistrate*
25 *judge would otherwise have been entitled under*

1 *subchapter III of chapter 83, or under chapter*
 2 *84 (except for subchapters III and VII), of title*
 3 *5, United States Code, for service performed as*
 4 *a magistrate or otherwise,*

5 *“(B) an annuity or salary in senior status*
 6 *or retirement under section 371 or 372 of title*
 7 *28, United States Code,*

8 *“(C) retired pay under section 7447, or*

9 *“(D) retired pay under section 7296 of title*
 10 *38, United States Code.*

11 *“(3) COORDINATION WITH TITLE 5.—A mag-*
 12 *istrate judge of the Tax Court who elects to receive an*
 13 *annuity under this section—*

14 *“(A) shall not be subject to deductions and*
 15 *contributions otherwise required by section*
 16 *8334(a) of title 5, United States Code,*

17 *“(B) shall be excluded from the operation of*
 18 *chapter 84 (other than subchapters III and VII)*
 19 *of such title 5, and*

20 *“(C) is entitled to a lump-sum credit under*
 21 *section 8342(a) or 8424 of such title 5, as the*
 22 *case may be.*

23 *“(g) CALCULATION OF SERVICE.—For purposes of cal-*
 24 *culating an annuity under this section—*

1 “(1) service as a magistrate judge of the Tax
2 Court to whom this section applies may be credited,
3 and

4 “(2) each month of service shall be credited as
5 $\frac{1}{12}$ of a year, and the fractional part of any month
6 shall not be credited.

7 “(h) COVERED POSITIONS AND SERVICE.—This section
8 applies to any magistrate judge of the Tax Court or special
9 trial judge of the Tax Court appointed under this sub-
10 chapter, but only with respect to service as such a mag-
11 istrate judge or special trial judge after a date not earlier
12 than $9\frac{1}{2}$ years before the date of the enactment of this sub-
13 section.

14 “(i) PAYMENTS PURSUANT TO COURT ORDER.—

15 “(1) IN GENERAL.—Payments under this section
16 which would otherwise be made to a magistrate judge
17 of the Tax Court based upon his or her service shall
18 be paid (in whole or in part) by the chief judge of the
19 Tax Court to another person if and to the extent ex-
20 pressly provided for in the terms of any court decree
21 of divorce, annulment, or legal separation, or the
22 terms of any court order or court-approved property
23 settlement agreement incident to any court decree of
24 divorce, annulment, or legal separation. Any payment

1 *under this paragraph to a person bars recovery by*
2 *any other person.*

3 “(2) *REQUIREMENTS FOR PAYMENT.*—*Paragraph*
4 *(1) shall apply only to payments made by the chief*
5 *judge of the Tax Court after the date of receipt by the*
6 *chief judge of written notice of such decree, order, or*
7 *agreement, and such additional information as the*
8 *chief judge may prescribe.*

9 “(3) *COURT DEFINED.*—*For purposes of this sub-*
10 *section, the term ‘court’ means any court of any*
11 *State, the District of Columbia, the Commonwealth of*
12 *Puerto Rico, Guam, the Northern Mariana Islands, or*
13 *the Virgin Islands, and any Indian tribal court or*
14 *courts of Indian offense.*

15 “(j) *DEDUCTIONS, CONTRIBUTIONS, AND DEPOSITS.*—

16 “(1) *DEDUCTIONS.*—*Beginning with the next*
17 *pay period after the chief judge of the Tax Court re-*
18 *ceives a notice under subsection (f) that a magistrate*
19 *judge of the Tax Court has elected an annuity under*
20 *this section, the chief judge shall deduct and withhold*
21 *1 percent of the salary of such magistrate judge.*
22 *Amounts shall be so deducted and withheld in a man-*
23 *ner determined by the chief judge. Amounts deducted*
24 *and withheld under this subsection shall be deposited*
25 *in the Treasury of the United States to the credit of*

1 *the Tax Court Judicial Officers' Retirement Fund.*
2 *Deductions under this subsection from the salary of a*
3 *magistrate judge shall terminate upon the retirement*
4 *of the magistrate judge or upon completion of 14*
5 *years of service for which contributions under this*
6 *section have been made, whether continuously or oth-*
7 *erwise, as calculated under subsection (g), whichever*
8 *occurs first.*

9 “(2) *CONSENT TO DEDUCTIONS; DISCHARGE OF*
10 *CLAIMS.—Each magistrate judge of the Tax Court*
11 *who makes an election under subsection (f) shall be*
12 *deemed to consent and agree to the deductions from*
13 *salary which are made under paragraph (1). Pay-*
14 *ment of such salary less such deductions (and any de-*
15 *ductions made under section 7448) is a full and com-*
16 *plete discharge and acquittance of all claims and de-*
17 *mands for all services rendered by such magistrate*
18 *judge during the period covered by such payment, ex-*
19 *cept the right to those benefits to which the magistrate*
20 *judge is entitled under this section (and section 7448).*

21 “(k) *DEPOSITS FOR PRIOR SERVICE.—Each mag-*
22 *istrate judge of the Tax Court who makes an election under*
23 *subsection (f) may deposit, for service performed before such*
24 *election for which contributions may be made under this*
25 *section, an amount equal to 1 percent of the salary received*

1 *for that service. Credit for any period covered by that serv-*
 2 *ice may not be allowed for purposes of an annuity under*
 3 *this section until a deposit under this subsection has been*
 4 *made for that period.*

5 “(l) *INDIVIDUAL RETIREMENT RECORDS.—The*
 6 *amounts deducted and withheld under subsection (j), and*
 7 *the amounts deposited under subsection (k), shall be credited*
 8 *to individual accounts in the name of each magistrate judge*
 9 *of the Tax Court from whom such amounts are received,*
 10 *for credit to the Tax Court Judicial Officers’ Retirement*
 11 *Fund.*

12 “(m) *ANNUITIES AFFECTED IN CERTAIN CASES.—*

13 “(1) *1-YEAR FORFEITURE FOR FAILURE TO PER-*
 14 *FORM JUDICIAL DUTIES.—Subject to paragraph (3),*
 15 *any magistrate judge of the Tax Court who retires*
 16 *under this section and who fails to perform judicial*
 17 *duties required of such individual by section 7443C*
 18 *shall forfeit all rights to an annuity under this sec-*
 19 *tion for a 1-year period which begins on the 1st day*
 20 *on which such individual fails to perform such duties.*

21 “(2) *PERMANENT FORFEITURE OF RETIRED PAY*
 22 *WHERE CERTAIN NON-GOVERNMENT SERVICES PER-*
 23 *FORMED.—Subject to paragraph (3), any magistrate*
 24 *judge of the Tax Court who retires under this section*
 25 *and who thereafter performs (or supervises or directs*

1 *the performance of) legal or accounting services in the*
2 *field of Federal taxation for the individual's client,*
3 *the individual's employer, or any of such employer's*
4 *clients, shall forfeit all rights to an annuity under this*
5 *section for all periods beginning on or after the first*
6 *day on which the individual performs (or supervises*
7 *or directs the performance of) such services. The pre-*
8 *ceding sentence shall not apply to any civil office or*
9 *employment under the Government of the United*
10 *States.*

11 “(3) *FORFEITURES NOT TO APPLY WHERE INDI-*
12 *VIDUAL ELECTS TO FREEZE AMOUNT OF ANNUITY.—*

13 “(A) *IN GENERAL.—If a magistrate judge of*
14 *the Tax Court makes an election under this*
15 *paragraph—*

16 “(i) *paragraphs (1) and (2) (and sec-*
17 *tion 7443C) shall not apply to such mag-*
18 *istrate judge beginning on the date such*
19 *election takes effect, and*

20 “(ii) *the annuity payable under this*
21 *section to such magistrate judge, for periods*
22 *beginning on or after the date such election*
23 *takes effect, shall be equal to the annuity to*
24 *which such magistrate judge is entitled on*
25 *the day before such effective date.*

1 “(B) *ELECTION REQUIREMENTS.*—*An elec-*
2 *tion under subparagraph (A)—*

3 “(i) *may be made by a magistrate*
4 *judge of the Tax Court eligible for retire-*
5 *ment under this section, and*

6 “(ii) *shall be filed with the chief judge*
7 *of the Tax Court.*

8 *Such an election, once it takes effect, shall be ir-*
9 *revocable.*

10 “(C) *EFFECTIVE DATE OF ELECTION.*—*Any*
11 *election under subparagraph (A) shall take effect*
12 *on the first day of the first month following the*
13 *month in which the election is made.*

14 “(4) *ACCEPTING OTHER EMPLOYMENT.*—*Any*
15 *magistrate judge of the Tax Court who retires under*
16 *this section and thereafter accepts compensation for*
17 *civil office or employment under the United States*
18 *Government (other than for the performance of func-*
19 *tions as a magistrate judge of the Tax Court under*
20 *section 7443C) shall forfeit all rights to an annuity*
21 *under this section for the period for which such com-*
22 *penetration is received. For purposes of this paragraph,*
23 *the term ‘compensation’ includes retired pay or sal-*
24 *ary received in retired status.*

25 “(n) *LUMP-SUM PAYMENTS.*—

1 “(1) *ELIGIBILITY.*—

2 “(A) *IN GENERAL.*—*Subject to paragraph*
3 *(2), an individual who serves as a magistrate*
4 *judge of the Tax Court and—*

5 “(i) *who leaves office and is not re-*
6 *appointed as a magistrate judge of the Tax*
7 *Court for at least 31 consecutive days,*

8 “(ii) *who files an application with the*
9 *chief judge of the Tax Court for payment of*
10 *a lump-sum credit,*

11 “(iii) *is not serving as a magistrate*
12 *judge of the Tax Court at the time of filing*
13 *of the application, and*

14 “(iv) *will not become eligible to receive*
15 *an annuity under this section within 31*
16 *days after filing the application,*

17 *is entitled to be paid the lump-sum credit. Pay-*
18 *ment of the lump-sum credit voids all rights to*
19 *an annuity under this section based on the serv-*
20 *ice on which the lump-sum credit is based, until*
21 *that individual resumes office as a magistrate*
22 *judge of the Tax Court.*

23 “(B) *PAYMENT TO SURVIVORS.*—*Lump-sum*
24 *benefits authorized by subparagraphs (C), (D),*
25 *and (E) of this paragraph shall be paid to the*

1 *person or persons surviving the magistrate judge*
2 *of the Tax Court and alive on the date title to*
3 *the payment arises, in the order of precedence set*
4 *forth in subsection (o) of section 376 of title 28,*
5 *United States Code, and in accordance with the*
6 *last 2 sentences of paragraph (1) of that sub-*
7 *section. For purposes of the preceding sentence,*
8 *the term ‘judicial official’ as used in subsection*
9 *(o) of such section 376 shall be deemed to mean*
10 *‘magistrate judge of the Tax Court’ and the*
11 *terms ‘Administrative Office of the United States*
12 *Courts’ and ‘Director of the Administrative Of-*
13 *fice of the United States Courts’ shall be deemed*
14 *to mean ‘chief judge of the Tax Court’.*

15 *“(C) PAYMENT UPON DEATH OF JUDGE BE-*
16 *FORE RECEIPT OF ANNUITY.—If a magistrate*
17 *judge of the Tax Court dies before receiving an*
18 *annuity under this section, the lump-sum credit*
19 *shall be paid.*

20 *“(D) PAYMENT OF ANNUITY REMAINDER.—*
21 *If all annuity rights under this section based on*
22 *the service of a deceased magistrate judge of the*
23 *Tax Court terminate before the total annuity*
24 *paid equals the lump-sum credit, the difference*
25 *shall be paid.*

1 “(E) *PAYMENT UPON DEATH OF JUDGE*
2 *DURING RECEIPT OF ANNUITY.*—*If a magistrate*
3 *judge of the Tax Court who is receiving an an-*
4 *nuity under this section dies, any accrued annu-*
5 *ity benefits remaining unpaid shall be paid.*

6 “(F) *PAYMENT UPON TERMINATION.*—*Any*
7 *accrued annuity benefits remaining unpaid on*
8 *the termination, except by death, of the annuity*
9 *of a magistrate judge of the Tax Court shall be*
10 *paid to that individual.*

11 “(G) *PAYMENT UPON ACCEPTING OTHER*
12 *EMPLOYMENT.*—*Subject to paragraph (2), a*
13 *magistrate judge of the Tax Court who forfeits*
14 *rights to an annuity under subsection (m)(4) be-*
15 *fore the total annuity paid equals the lump-sum*
16 *credit shall be entitled to be paid the difference*
17 *if the magistrate judge of the Tax Court files an*
18 *application with the chief judge of the Tax Court*
19 *for payment of that difference. A payment under*
20 *this subparagraph voids all rights to an annuity*
21 *on which the payment is based.*

22 “(2) *SPOUSES AND FORMER SPOUSES.*—

23 “(A) *IN GENERAL.*—*Payment of the lump-*
24 *sum credit under paragraph (1)(A) or a pay-*
25 *ment under paragraph (1)(G)—*

1 “(i) may be made only if any current
2 spouse and any former spouse of the mag-
3 istrate judge of the Tax Court are notified
4 of the magistrate judge’s application, and

5 “(ii) shall be subject to the terms of a
6 court decree of divorce, annulment, or legal
7 separation, or any court or court approved
8 property settlement agreement incident to
9 such decree, if—

10 “(I) the decree, order, or agree-
11 ment expressly relates to any portion
12 of the lump-sum credit or other pay-
13 ment involved, and

14 “(II) payment of the lump-sum
15 credit or other payment would extin-
16 guish entitlement of the magistrate
17 judge’s spouse or former spouse to any
18 portion of an annuity under subsection
19 (i).

20 “(B) NOTIFICATION.—Notification of a
21 spouse or former spouse under this paragraph
22 shall be made in accordance with such proce-
23 dures as the chief judge of the Tax Court shall
24 prescribe. The chief judge may provide under
25 such procedures that subparagraph (A)(i) may

1 *be waived with respect to a spouse or former*
 2 *spouse if the magistrate judge establishes to the*
 3 *satisfaction of the chief judge that the where-*
 4 *abouts of such spouse or former spouse cannot be*
 5 *determined.*

6 “(C) *RESOLUTION OF 2 OR MORE OR-*
 7 *DERS.—The chief judge shall prescribe proce-*
 8 *dures under which this paragraph shall be ap-*
 9 *plied in any case in which the chief judge re-*
 10 *ceives 2 or more orders or decrees described in*
 11 *subparagraph (A).*

12 “(3) *DEFINITION.—For purposes of this sub-*
 13 *section, the term ‘lump-sum credit’ means the*
 14 *unrefunded amount consisting of—*

15 “(A) *retirement deductions made under this*
 16 *section from the salary of a magistrate judge of*
 17 *the Tax Court,*

18 “(B) *amounts deposited under subsection*
 19 *(k) by a magistrate judge of the Tax Court cov-*
 20 *ering earlier service, and*

21 “(C) *interest on the deductions and deposits*
 22 *which, for any calendar year, shall be equal to*
 23 *the overall average yield to the Tax Court Judi-*
 24 *cial Officers’ Retirement Fund during the pre-*
 25 *ceding fiscal year from all obligations purchased*

1 *by the Secretary during such fiscal year under*
 2 *subsection (o); but does not include interest—*

3 *“(i) if the service covered thereby ag-*
 4 *gregates 1 year or less, or*

5 *“(ii) for the fractional part of a month*
 6 *in the total service.*

7 *“(o) TAX COURT JUDICIAL OFFICERS’ RETIREMENT*
 8 *FUND.—*

9 *“(1) ESTABLISHMENT.—There is established in*
 10 *the Treasury a fund which shall be known as the ‘Tax*
 11 *Court Judicial Officers’ Retirement Fund’. Amounts*
 12 *in the Fund are authorized to be appropriated for the*
 13 *payment of annuities, refunds, and other payments*
 14 *under this section.*

15 *“(2) INVESTMENT OF FUND.—The Secretary*
 16 *shall invest, in interest bearing securities of the*
 17 *United States, such currently available portions of the*
 18 *Tax Court Judicial Officers’ Retirement Fund as are*
 19 *not immediately required for payments from the*
 20 *Fund. The income derived from these investments con-*
 21 *stitutes a part of the Fund.*

22 *“(3) UNFUNDED LIABILITY.—*

23 *“(A) IN GENERAL.—There are authorized to*
 24 *be appropriated to the Tax Court Judicial Offi-*

1 *cers' Retirement Fund amounts required to re-*
 2 *duce to zero the unfunded liability of the Fund.*

3 “(B) *UNFUNDED LIABILITY.*—*For purposes*
 4 *of subparagraph (A), the term ‘unfunded liabil-*
 5 *ity’ means the estimated excess, determined on*
 6 *an annual basis in accordance with the provi-*
 7 *sions of section 9503 of title 31, United States*
 8 *Code, of the present value of all benefits payable*
 9 *from the Tax Court Judicial Officers' Retirement*
 10 *Fund over the sum of—*

11 “(i) *the present value of deductions to*
 12 *be withheld under this section from the fu-*
 13 *ture basic pay of magistrate judges of the*
 14 *Tax Court, plus*

15 “(ii) *the balance in the Fund as of the*
 16 *date the unfunded liability is determined.*

17 “(p) *PARTICIPATION IN THRIFT SAVINGS PLAN.*—

18 “(1) *ELECTION TO CONTRIBUTE.*—

19 “(A) *IN GENERAL.*—*A magistrate judge of*
 20 *the Tax Court who elects to receive an annuity*
 21 *under this section or under section 211 of the*
 22 *United States Tax Court Modernization Act may*
 23 *elect to contribute an amount of such individ-*
 24 *ual's basic pay to the Thrift Savings Fund estab-*

1 *lished by section 8437 of title 5, United States*
2 *Code.*

3 “(B) *PERIOD OF ELECTION.*—*An election*
4 *may be made under this paragraph as provided*
5 *under section 8432(b) of title 5, United States*
6 *Code, for individuals subject to chapter 84 of*
7 *such title.*

8 “(2) *APPLICABILITY OF TITLE 5 PROVISIONS.*—
9 *Except as otherwise provided in this subsection, the*
10 *provisions of subchapters III and VII of chapter 84*
11 *of title 5, United States Code, shall apply with re-*
12 *spect to a magistrate judge who makes an election*
13 *under paragraph (1).*

14 “(3) *SPECIAL RULES.*—

15 “(A) *AMOUNT CONTRIBUTED.*—*The amount*
16 *contributed by a magistrate judge to the Thrift*
17 *Savings Fund in any pay period shall not ex-*
18 *ceed the maximum percentage of such judge’s*
19 *basic pay for such pay period as allowable under*
20 *section 8440f of title 5, United States Code.*

21 “(B) *CONTRIBUTIONS FOR BENEFIT OF*
22 *JUDGE.*—*No contributions may be made for the*
23 *benefit of a magistrate judge under section*
24 *8432(c) of title 5, United States Code.*

1 “(C) *APPLICABILITY OF SECTION 8433(b) OF*
2 *TITLE 5.—Section 8433(b) of title 5, United*
3 *States Code, applies with respect to a magistrate*
4 *judge who makes an election under paragraph*
5 *(1) and—*

6 “(i) *who retires entitled to an imme-*
7 *diate annuity under this section (including*
8 *a disability annuity under subsection (d) of*
9 *this section) or section 211 of the United*
10 *States Tax Court Modernization Act,*

11 “(ii) *who retires before attaining age*
12 *65 but is entitled, upon attaining age 65, to*
13 *an annuity under this section or section*
14 *211 of the United States Tax Court Mod-*
15 *ernization Act, or*

16 “(iii) *who retires before becoming enti-*
17 *tled to an immediate annuity, or an annu-*
18 *ity upon attaining age 65, under this sec-*
19 *tion or section 211 of the United States Tax*
20 *Court Modernization Act.*

21 “(D) *SEPARATION FROM SERVICE.—With*
22 *respect to a magistrate judge to whom this sub-*
23 *section applies, retirement under this section or*
24 *section 211 of the United States Tax Court Mod-*
25 *ernization Act is a separation from service for*

1 *purposes of subchapters III and VII of chapter*
2 *84 of title 5, United States Code.*

3 “(4) *DEFINITIONS.*—*For purposes of this sub-*
4 *section, the terms ‘retirement’ and ‘retire’ include re-*
5 *moval from office under section 7443A(a)(2) on the*
6 *sole ground of mental or physical disability.*

7 “(5) *OFFSET.*—*In the case of a magistrate judge*
8 *who receives a distribution from the Thrift Savings*
9 *Fund and who later receives an annuity under this*
10 *section, that annuity shall be offset by an amount*
11 *equal to the amount which represents the Govern-*
12 *ment’s contribution to that person’s Thrift Savings*
13 *Account, without regard to earnings attributable to*
14 *that amount. Where such an offset would exceed 50*
15 *percent of the annuity to be received in the first year,*
16 *the offset may be divided equally over the first 2 years*
17 *in which that person receives the annuity.*

18 “(6) *EXCEPTION.*—*Notwithstanding clauses (i)*
19 *and (ii) of paragraph (3)(C), if any magistrate judge*
20 *retires under circumstances making such magistrate*
21 *judge eligible to make an election under subsection (b)*
22 *of section 8433 of title 5, United States Code, and*
23 *such magistrate judge’s nonforfeitable account balance*
24 *is less than an amount that the Executive Director of*
25 *the Office of Personnel Management prescribes by reg-*

1 *for any service as a magistrate judge of the United*
2 *States Tax Court or special trial judge of the United*
3 *States Tax Court but only with respect to service as*
4 *such a magistrate judge or special trial judge after a*
5 *date not earlier than 9½ years prior to the date of*
6 *the enactment of this Act (as specified in the election*
7 *pursuant to subsection (b)) for which deductions and*
8 *deposits are made under subsections (j) and (k) of*
9 *such section 7443B, as applicable, without regard to*
10 *the minimum number of years of service as such a*
11 *magistrate judge of the United States Tax Court, ex-*
12 *cept that—*

13 (A) *in the case of a magistrate judge who*
14 *retired with less than 8 years of service, the an-*
15 *nuity under subsection (c) of such section 7443B*
16 *shall be equal to that proportion of the salary*
17 *being received at the time the magistrate judge*
18 *leaves office which the years of service bears to*
19 *14, subject to a reduction in accordance with sub-*
20 *section (c) of such section 7443B if the magistrate*
21 *judge is under age 65 at the time he or she leaves*
22 *office, and*

23 (B) *the aggregate amount of the annuity*
24 *initially payable on retirement under this sub-*
25 *section may not exceed the rate of pay for the*

1 *magistrate judge which is in effect on the day be-*
2 *fore the retirement becomes effective.*

3 **(b) FILING OF NOTICE OF ELECTION.**—*A magistrate*
4 *judge of the United States Tax Court shall be entitled to*
5 *an annuity under this section only if the magistrate judge*
6 *files a notice of that election with the chief judge of the*
7 *United States Tax Court specifying the date on which serv-*
8 *ice would begin to be credited under section 7443B of the*
9 *Internal Revenue Code of 1986, as added by this Act, in*
10 *lieu of chapter 83 or chapter 84 of title 5, United States*
11 *Code. Such notice shall be filed in accordance with such*
12 *procedures as the chief judge of the United States Tax Court*
13 *shall prescribe.*

14 **(c) LUMP-SUM CREDIT UNDER TITLE 5.**—*A mag-*
15 *istrate judge of the United States Tax Court who makes*
16 *an election under subsection (b) shall be entitled to a lump-*
17 *sum credit under section 8342 or 8424 of title 5, United*
18 *States Code, as the case may be, for any service which is*
19 *covered under section 7443B of the Internal Revenue Code*
20 *of 1986, as added by this Act, pursuant to that election,*
21 *and with respect to which any contributions were made by*
22 *the magistrate judge under the applicable provisions of title*
23 *5, United States Code.*

24 **(d) RECALL.**—*With respect to any magistrate judge of*
25 *the United States Tax Court receiving an annuity under*

1 *this section who is recalled to serve under section 7443C*
 2 *of the Internal Revenue Code of 1986, as added by this*
 3 *Act—*

4 (1) *the amount of compensation which such re-*
 5 *called magistrate judge receives under such section*
 6 *7443C shall be calculated on the basis of the annuity*
 7 *received under this section, and*

8 (2) *such recalled magistrate judge of the United*
 9 *States Tax Court may serve as a reemployed annu-*
 10 *itant to the extent otherwise permitted under title 5,*
 11 *United States Code.*

12 *Section 7443B(m)(4) of the Internal Revenue Code of 1986,*
 13 *as added by this Act, shall not apply with respect to service*
 14 *as a reemployed annuitant described in paragraph (2).*

15 **SEC. 212. PROVISIONS FOR RECALL.**

16 (a) *IN GENERAL.*—*Part I of subchapter C of chapter*
 17 *76, as amended by this Act, is amended by inserting after*
 18 *section 7443B the following new section:*

19 **“SEC. 7443C. RECALL OF MAGISTRATE JUDGES OF THE TAX**
 20 **COURT.**

21 “(a) *RECALLING OF RETIRED MAGISTRATE*
 22 *JUDGES.*—*Any individual who has retired pursuant to sec-*
 23 *tion 7443B or the applicable provisions of title 5, United*
 24 *States Code, upon reaching the age and service require-*
 25 *ments established therein, may at or after retirement be*

1 *called upon by the chief judge of the Tax Court to perform*
2 *such judicial duties with the Tax Court as may be requested*
3 *of such individual for any period or periods specified by*
4 *the chief judge; except that in the case of any such indi-*
5 *vidual—*

6 “(1) *the aggregate of such periods in any 1 cal-*
7 *endar year shall not (without such individual’s con-*
8 *sent) exceed 90 calendar days, and*

9 “(2) *such individual shall be relieved of per-*
10 *forming such duties during any period in which ill-*
11 *ness or disability precludes the performance of such*
12 *duties.*

13 *Any act, or failure to act, by an individual performing ju-*
14 *dicial duties pursuant to this subsection shall have the same*
15 *force and effect as if it were the act (or failure to act) of*
16 *a magistrate judge of the Tax Court.*

17 “(b) *COMPENSATION.—For the year in which a period*
18 *of recall occurs, the magistrate judge shall receive, in addi-*
19 *tion to the annuity provided under the provisions of section*
20 *7443B or under the applicable provisions of title 5, United*
21 *States Code, an amount equal to the difference between that*
22 *annuity and the current salary of the office to which the*
23 *magistrate judge is recalled. The annuity of the magistrate*
24 *judge who completes that period of service, who is not re-*
25 *called in a subsequent year, and who retired under section*

1 7443B, shall be equal to the salary in effect at the end of
2 the year in which the period of recall occurred for the office
3 from which such individual retired.

4 “(c) *RULEMAKING AUTHORITY.*—The provisions of this
5 section may be implemented under such rules as may be
6 promulgated by the Tax Court.”.

7 (b) *CONFORMING AMENDMENT.*—The table of sections
8 for part I of subchapter C of chapter 76, as amended by
9 this Act, is amended by inserting after the item relating
10 to section 7443B the following new item:

“Sec. 7443C. Recall of magistrate judges of the Tax Court.”.

11 **SEC. 213. EFFECTIVE DATE.**

12 *Except as otherwise provided, the amendments made*
13 *by this title shall take effect on the date of the enactment*
14 *of this Act.*
