## CONCURRENT RESOLUTION

1        *Resolved by the House of Representatives (the Senate*  
2 *concurring)*, That when the House adjourns on the legisla-  
3 tive day of Thursday, February 14, 2008, on a motion  
4 offered pursuant to this concurrent resolution by its Ma-  
5 jority Leader or his designee, it stand adjourned until 2  
6 p.m. on Friday, February 15, 2008, or until the time of  
7 any reassembly pursuant to section 2 of this

1 concurrent resolution, whichever occurs first; that when  
2 the House adjourns on the legislative day of Friday, Feb-  
3 ruary 15, 2008, on a motion offered pursuant to this con-  
4 current resolution by its Majority Leader or his designee,  
5 it stand adjourned until 10 a.m. on Tuesday, February  
6 19, 2008, or until the time of any reassembly pursuant  
7 to section 2 of this concurrent resolution, whichever occurs  
8 first; that when the House adjourns on the legislative day  
9 of Tuesday, February 19, 2008, on a motion offered pur-  
10 suant to this concurrent resolution by its Majority Leader  
11 or his designee, it stand adjourned until noon on Thurs-  
12 day, February 21, 2008, or until the time of any re-  
13 assembly pursuant to section 2 of this concurrent resolu-  
14 tion, whichever occurs first; that when the House adjourns  
15 on the legislative day of Thursday, February 21, 2008,  
16 on a motion offered pursuant to this concurrent resolution  
17 by its Majority Leader or his designee, it stand adjourned  
18 until 2 p.m. on Monday, February 25, 2008, or until the  
19 time of any reassembly pursuant to section 2 of this con-  
20 current resolution, whichever occurs first; and that when  
21 the Senate recesses or adjourns on any day from Friday,  
22 February 15, 2008, through Friday, February 22, 2008,  
23 on a motion offered pursuant to this concurrent resolution  
24 by its Majority Leader or his designee, it stand recessed  
25 or adjourned until noon on Monday, February 25, 2008,

1 or such other time on that day as may be specified in the  
2 motion to recess or adjourn, or until the time of any re-  
3 assembly pursuant to section 2 of this concurrent resolu-  
4 tion, whichever occurs first.

5       SEC. 2. The Speaker of the House and the Majority  
6 Leader of the Senate, or their respective designees, acting  
7 jointly after consultation with the Minority Leader of the  
8 House and the Minority Leader of the Senate, shall notify  
9 the Members of the House and the Senate, respectively,  
10 to reassemble at such place and time as they may des-  
11 ignate if, in their opinion, the public interest shall warrant  
12 it.

**CONCURRENT RESOLUTION**

Providing for a conditional adjournment of the House of Representatives and a conditional recess or adjournment of the Senate.
