## CONCURRENT RESOLUTION

Supporting the goals and ideals of National Caribbean American HIV/AIDS Awareness Day, and for other purposes.

Whereas nearly 3,000,000 Americans self-identified as Caribbean American in the 2000 Census;

Whereas due to ongoing racial and ethnic health disparities Caribbean Americans face poor health, premature death, low-quality health care, and an additional community stigma regarding HIV/AIDS and its causes;

Whereas the Centers for Disease Control and Prevention (CDC) estimates that over 1,000,000 people were living with HIV/AIDS at the end of 2003 and that over 250,000 were unaware that they were infected;

Whereas the CDC recognizes continuing racial and ethnic disparities among people with HIV/AIDS and cites working

to end such disparities as a key initiative in the fight against HIV/AIDS;

Whereas the Joint United Nations Programme on HIV/AIDS (UNAIDS) estimates that 230,000 people were living with HIV/AIDS in the Caribbean at the end of 2007 and that an additional 17,000 were newly infected, making the region the second-most affected by HIV in the world;

Whereas UNAIDS estimates that approximately 11,000 people in the Caribbean died of AIDS during 2007, making it one of the leading causes of death in the Caribbean among adults between the ages of 15 to 44 years old;

Whereas according to the Bureau of the Census, immigration to the United States from the Caribbean has increased every decade since 1941, with 978,800 Caribbean emigrants entering the United States from 1991 to 2000;

Whereas according to the Department of Homeland Security, 2,569,124 people coming from the Caribbean have obtained legal permanent status in the United States since 1980, including 114,318 in 2007 alone;

Whereas on June 8, 2006, the first annual National Caribbean American HIV/AIDS Awareness Day was organized to encourage Caribbean American and Caribbean-born individuals across the United States and its territories, to get educated, get tested, get treated, and get involved; and

Whereas June 8th of each year has been established as National Caribbean American HIV/AIDS Awareness Day: Now, therefore, be it

- 2 *concurring), That the Congress—*

1           (1) supports the goals and ideals of National  
2 Caribbean American HIV/AIDS Awareness Day and  
3 recognizes the third anniversary of observing such  
4 day;

5           (2) encourages State and local governments, in-  
6 cluding their public health agencies, to recognize  
7 such day, to publicize its importance among their  
8 communities, and to encourage Caribbean Ameri-  
9 cans, Caribbean-born individuals, and all people in  
10 the United States and its territories to know their  
11 status and undergo testing for HIV;

12           (3) encourages national, State, and local media  
13 organizations to carry messages in support of Na-  
14 tional Caribbean American HIV/AIDS Awareness  
15 Day; and

16           (4) supports the development of a national  
17 AIDS strategy with clear goals and objectives to re-  
18 duce new HIV infections, especially among commu-  
19 nities of color.
