## A BILL

To waive the non-Federal share of the cost of certain disaster assistance provided in connection with Hurricanes Katrina and Rita, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4       This Act may be cited as the “~~Hurricanes Katrina~~  
5 ~~and Rita Federal Match Relief Act of 2007~~”.

6 **SEC. 2. FEDERAL SHARE OF DISASTER ASSISTANCE.**

7       ~~Notwithstanding any other provision of law, including~~  
8 ~~any agreement, the Federal share of the cost of disaster~~  
9 ~~assistance provided before the date of enactment of this~~  
10 ~~Act in connection with Hurricane Katrina or Rita under~~  
11 ~~title IV of the Robert T. Stafford Disaster Relief and~~  
12 ~~Emergency Assistance Act (42 U.S.C. 5170 et seq.), in-~~  
13 ~~cluding direct Federal assistance, shall be 100 percent~~  
14 ~~with respect to assistance provided for the States of Lou-~~  
15 ~~isiana and Mississippi.~~

1 **SEC. 3. CANCELLATION OF LOANS.**

2 (a) **IN GENERAL.**—Section 2(a) of the Community  
3 Disaster Loan Act of 2005 (Public Law 109–88) is  
4 amended by striking “*Provided further, That notwith-*  
5 *standing section 417(e)(1) of the Stafford Act, such loans*  
6 *may not be canceled.*”.

7 (b) **EFFECTIVE DATE.**—The amendment made by  
8 this section shall be effective on the date of enactment of  
9 the Community Disaster Loan Act of 2005 (Public Law  
10 109–88).

11 **SECTION 1. SHORT TITLE.**

12 *This Act may be cited as the “Hurricanes Katrina,*  
13 *Rita, and Wilma Federal Match Relief Act of 2007”.*

14 **SEC. 2. FEDERAL SHARE OF DISASTER ASSISTANCE.**

15 (a) **IN GENERAL.**—*Notwithstanding any other provi-*  
16 *sion of law, including any agreement, the Federal share of*  
17 *assistance, including direct Federal assistance, provided for*  
18 *the States of Louisiana, Mississippi, Texas, and Florida in*  
19 *connection with Hurricanes Katrina, Rita, and Wilma*  
20 *under sections 403, 406, 407, and 408 of the Robert T. Staf-*  
21 *ford Disaster Relief and Emergency Assistance Act (42*  
22 *U.S.C. 5170b, 5172, 5173, and 5174) shall be 100 percent*  
23 *of the eligible costs under such sections.*

24 (b) **APPLICABILITY.**—

25 (1) **IN GENERAL.**—*Subject to paragraph (2), the*  
26 *Federal share provided by subsection (a) shall apply*

1       to disaster assistance provided before, on, or after the  
2       date of enactment of this Act.

3               (2) *LIMITATION.*—*In the case of disaster assist-*  
4       *ance provided under sections 403, 406, and 407 of the*  
5       *Robert T. Stafford Disaster Relief and Emergency As-*  
6       *istance Act, the Federal share provided by subsection*  
7       *(a) shall be limited to assistance provided for projects*  
8       *for which project worksheets have been approved by*  
9       *the Federal Emergency Management Agency before*  
10       *the date of enactment of this Act.*

11 **SEC. 3. CANCELLATION OF LOANS.**

12       (a) *COMMUNITY DISASTER LOAN ACT.*—

13               (1) *IN GENERAL.*—*Section 2(a) of the Commu-*  
14       *nity Disaster Loan Act of 2005 (Public Law 109–88)*  
15       *is amended by striking “Provided further, That not-*  
16       *withstanding section 417(c)(1) of the Stafford Act,*  
17       *such loans may not be canceled:”.*

18               (2) *EFFECTIVE DATE.*—*The amendment made by*  
19       *paragraph (1) shall be effective on the date of enact-*  
20       *ment of the Community Disaster Loan Act of 2005*  
21       *(Public Law 109–88).*

22       (b) *EMERGENCY SUPPLEMENTAL APPROPRIATIONS*  
23 *ACT.*—

24               (1) *IN GENERAL.*—*Chapter 4 of title II of the*  
25       *Emergency Supplemental Appropriations Act for De-*

1       *fense, the Global War on Terror, and Hurricane Re-*  
2       *covery, 2006 (Public Law 109–234) is amended under*  
3       *the heading “FEDERAL EMERGENCY MANAGE-*  
4       *MENT AGENCY–DISASTER ASSISTANCE DIRECT*  
5       *LOAN PROGRAM ACCOUNT” by striking “Provided fur-*  
6       *ther, That notwithstanding section 417(c)(1) of such*  
7       *Act, such loans may not be canceled:”.*

8               (2) *EFFECTIVE DATE.—The amendment made by*  
9       *paragraph (1) shall be effective on the date of enact-*  
10       *ment of the Emergency Supplemental Appropriations*  
11       *Act for Defense, the Global War on Terror, and Hur-*  
12       *ricane Recovery, 2006 (Public Law 109–234).*

Amend the title so as to read: “A bill to waive the non-Federal share of the cost of certain disaster assistance provided in connection with Hurricanes Katrina, Rita, and Wilma.”.
