## A BILL

To expand the boundaries of the Gulf of the Farallones National Marine Sanctuary and the Cordell Bank National Marine Sanctuary.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Gulf of the Farallones*  
5 *and Cordell Bank National Marine Sanctuaries Boundary*  
6 *Modification and Protection Act”.*

7 **SEC. 2. FINDINGS.**

8 *The Congress finds the following:*

9 *(1) The Gulf of the Farallones extends approxi-*  
10 *mately 100 miles along the coast of Marin and*  
11 *Sonoma counties of northern California. It includes*  
12 *approximately one-half of California’s nesting*  
13 *seabirds, rich benthic marine life on hard-rock sub-*  
14 *strate, prolific fisheries, and substantial concentra-*  
15 *tions of resident and seasonally migratory marine*  
16 *mammals.*

17 *(2) Cordell Bank is adjacent to the Gulf of the*  
18 *Farallones and is a submerged island with spectac-*

1        *ular, unique, and nationally significant marine envi-*  
2        *ronments.*

3            (3) *These marine environments have national*  
4        *and international significance, exceed the biological*  
5        *productivity of tropical rain forests, and support high*  
6        *levels of biological diversity.*

7            (4) *These biological communities are easily sus-*  
8        *ceptible to damage from human activities, and must*  
9        *be properly conserved for themselves and to protect the*  
10       *economic viability of their contribution to national*  
11       *and regional economies.*

12           (5) *The Gulf of Farallones and Cordell Bank in-*  
13       *clude some of the Nation's richest fishing grounds,*  
14       *supporting important commercial and recreational*  
15       *fisheries. These fisheries are regulated by State and*  
16       *Federal fishery agencies and are supported and fos-*  
17       *tered through protection of the waters and habitats of*  
18       *Gulf of the Farallones National Marine Sanctuary*  
19       *and Cordell Bank National Marine Sanctuary.*

20           (6) *The report of the Commission on Ocean Pol-*  
21       *icy established by Public Law 106–256 calls for com-*  
22       *prehensive protection for the most productive ocean*  
23       *environments and recommends that they be managed*  
24       *as ecosystems.*

1           (7) *New scientific discoveries by the National*  
2           *Marine Sanctuary Program support comprehensive*  
3           *protection for these marine environments by broad-*  
4           *ening the geographic scope of the existing Gulf of the*  
5           *Farallones National Marine Sanctuary and the*  
6           *Cordell Bank National Marine Sanctuary.*

7           (8) *Cordell Bank is at the nexus of an ocean*  
8           *upwelling system, which produces the highest biomass*  
9           *concentrations on the west coast of the United States.*

10 **SEC. 3. POLICY AND PURPOSE.**

11           (a) *POLICY.—It is the policy of the United States in*  
12           *this Act to protect and preserve living and other resources*  
13           *of the Gulf of the Farallones and Cordell Bank marine envi-*  
14           *ronments.*

15           (b) *PURPOSE.—The purposes of this Act are the fol-*  
16           *lowing:*

17                   (1) *To extend the boundaries of the Gulf of the*  
18                   *Farallones National Marine Sanctuary and the*  
19                   *Cordell Bank National Marine Sanctuary to the areas*  
20                   *described in section 5.*

21                   (2) *To strengthen the protections that apply in*  
22                   *the Sanctuaries.*

23                   (3) *To educate and interpret for the public the*  
24                   *ecological value and national importance of those ma-*  
25                   *rine environments.*

1           (4) *To manage human uses of the Sanctuaries*  
2           *under this Act and the National Marine Sanctuaries*  
3           *Act (16 U.S.C. 1431 et seq.).*

4           (c) *EFFECT ON FISHING ACTIVITIES.*—*Nothing in this*  
5           *Act is intended to alter any existing authorities regarding*  
6           *the conduct and location of fishing activities in the Sanc-*  
7           *tuaries.*

8           **SEC. 4. DEFINITIONS.**

9           *In this Act:*

10           (1) *MARICULTURE.*—*The term “mariculture”*  
11           *means the propagation or rearing of aquatic orga-*  
12           *nisms in controlled or selected aquatic environments*  
13           *for any commercial, recreational, or public purpose.*

14           (2) *CORDELL BANK NMS.*—*The term “Cordell*  
15           *Bank NMS” means the Cordell Bank National Ma-*  
16           *rine Sanctuary.*

17           (3) *FARALLONES NMS.*—*The term “Farallones*  
18           *NMS” means the Gulf of the Farallones National Ma-*  
19           *rine Sanctuary.*

20           (4) *SANCTUARIES.*—*The term “Sanctuaries”*  
21           *means the Gulf of the Farallones National Marine*  
22           *Sanctuary and the Cordell Bank National Marine*  
23           *Sanctuary, as expanded by section 5.*

24           (5) *SECRETARY.*—*The term “Secretary” means*  
25           *the Secretary of Commerce.*

1 **SEC. 5. NATIONAL MARINE SANCTUARY BOUNDARY AD-**  
2 **JUSTMENTS.**

3 (a) *GULF OF THE FARALLONES.*—

4 (1) *BOUNDARY ADJUSTMENT.*—*The areas de-*  
5 *scribed in paragraph (2) are added to the existing*  
6 *Gulf of the Farallones National Marine Sanctuary*  
7 *described in part 922.80 of title 15, Code of Federal*  
8 *Regulations.*

9 (2) *AREAS INCLUDED.*—

10 (A) *IN GENERAL.*—*The areas referred to in*  
11 *paragraph (1) consist of the following:*

12 (i) *All submerged lands and waters, in-*  
13 *cluding living marine and other resources*  
14 *within and on those lands and waters, from*  
15 *the mean high water line to the boundary*  
16 *described in subparagraph (B).*

17 (ii) *The submerged lands and waters,*  
18 *including living marine and other resources*  
19 *within those waters, within the approxi-*  
20 *mately two-square-nautical-mile portion of*  
21 *the Cordell Bank NMS (as in effect imme-*  
22 *diately before the enactment of this Act)*  
23 *that is located south of the area that is*  
24 *added to Cordell Bank NMS by subsection*  
25 *(b)(2), which are transferred to the*

1           *Farallones NMS from the Cordell Bank*  
2           *NMS.*

3           *(B) BOUNDARY DESCRIBED.—The boundary*  
4           *referred to in subparagraph (A)(i) commences*  
5           *from the mean high water line (MHWL) at*  
6           *39.00000 degrees north in a westward direction*  
7           *approximately 29 nautical miles (nm) to*  
8           *39.00000 north, 124.33333 west. The boundary*  
9           *then extends in a southeasterly direction to*  
10           *38.30000 degrees north, 124.00000 degrees west,*  
11           *approximately 44 nm westward of Bodega Head.*  
12           *The boundary then extends eastward to the most*  
13           *northeastern corner of the expanded Cordell*  
14           *Bank NMS at 38.30000 north, 123.20000 degrees*  
15           *west, approximately 6 nm miles westward of*  
16           *Bodega Head. The boundary then extends in a*  
17           *southeasterly direction to 38.26500 degrees north,*  
18           *123.18166 degrees west at the northwestern most*  
19           *point of the current Gulf of the Farallones*  
20           *Boundary. The boundary then follows the cur-*  
21           *rent northern Gulf of the Farallones NMS*  
22           *boundary in a northeasterly direction to the*  
23           *MHWL near Bodega Head. The boundary then*  
24           *follows the MHWL in a northeasterly direction*  
25           *to the commencement point at the intersection of*

1           *the MHWL and 39.00000 north. Coordinates*  
2           *listed in this subparagraph are based on the*  
3           *North American Datum 1983 and the geographic*  
4           *projection.*

5           **(b) CORDELL BANK.—**

6           **(1) BOUNDARY ADJUSTMENT.—***The area de-*  
7           *scribed in paragraph (2) is added to the existing*  
8           *Cordell Bank National Marine Sanctuary described*  
9           *in part 922.80 of title 15, Code of Federal Regula-*  
10           *tions.*

11           **(2) AREA INCLUDED.—**

12           **(A) IN GENERAL.—***The area referred to in*  
13           *paragraph (1) consists of all submerged lands*  
14           *and waters, including living marine and other*  
15           *resources within those waters, within the bound-*  
16           *ary described in subparagraph (B).*

17           **(B) BOUNDARY.—***The boundary referred to*  
18           *in subparagraph (A) commences at the most*  
19           *northeastern point of the current Cordell Bank*  
20           *NMS boundary at 38.26500 degrees north,*  
21           *123.18166 degrees west and extends*  
22           *northwestward to 38.30000 degrees north,*  
23           *123.20000 degrees west, approximately 6 nau-*  
24           *tical miles (nm) west of Bodega Head. The*  
25           *boundary then extends westward to 38.30000 de-*

1            *grees north, 124.00000 degrees west, approxi-*  
2            *mately 44 nautical miles west of Bodega Head.*  
3            *The boundary then turns southeastward and con-*  
4            *tinues approximately 34 nautical miles to*  
5            *37.76687 degrees north, 123.75142 degrees west,*  
6            *and then approximately 15 nm eastward to*  
7            *37.76687 north, 123.42694 west at an intersec-*  
8            *tion with the current Cordell Bank NMS bound-*  
9            *ary. The boundary then follows the current*  
10           *Cordell Bank NMS, which is coterminous with*  
11           *the current Gulf of the Farallones boundary, in*  
12           *a northeasterly and the northwesterly direction*  
13           *to its commencement point at 38.26500 degrees*  
14           *north, 123.18166 degrees west. Coordinates listed*  
15           *in this subparagraph are based on NAD83*  
16           *Datum and the geographic projection.*

17           *(c) INCLUSION IN THE SYSTEM.—The areas included*  
18           *in the Sanctuaries under subsections (a) and (b) shall be*  
19           *managed as part of the National Marine Sanctuary Sys-*  
20           *tem, established by section 301(c) of the National Marine*  
21           *Sanctuaries Act (16 U.S.C. 1431(c)), in accordance with*  
22           *that Act.*

23           *(d) UPDATED NOAA CHARTS.—The Secretary shall—*



1           **(b) REVISED PLANS.**—*The Secretary shall issue a re-*  
2 *vised comprehensive management plan for the Sanctuaries*  
3 *during the first management review initiated after the date*  
4 *of the enactment of this Act under section 304(e) of the Na-*  
5 *tional Marine Sanctuaries Act (16 U.S.C. 1434(e)) for the*  
6 *Sanctuaries, and issue such final regulations as may be*  
7 *necessary.*

8           **(c) APPLICATION OF EXISTING REGULATIONS.**—*The*  
9 *regulations for the Gulf of the Farallones National Marine*  
10 *Sanctuary (15 C.F.R. 922, subpart H) and the Cordell*  
11 *Bank National Marine Sanctuary (15 C.F.R. 922, subpart*  
12 *K), including any changes made as a result of a joint man-*  
13 *agement plan review for the Sanctuaries conducted pursu-*  
14 *ant to section 304(e) of the National Marine Sanctuaries*  
15 *Act (16 U.S.C. 1434(e)), shall apply to the areas added to*  
16 *each Sanctuary, respectively, under section 5 until the Sec-*  
17 *retary modifies such regulations in accordance with sub-*  
18 *section (d) of this section.*

19           **(d) REVISED REGULATIONS.**—

20                   **(1) IN GENERAL.**—*The Secretary shall carry out*  
21 *an assessment of necessary revisions to the regulations*  
22 *for the Sanctuaries in a manner that ensures the pro-*  
23 *tection of the resources of the Sanctuaries consistent*  
24 *with the purposes and policies of the National Marine*  
25 *Sanctuaries Act and the goals and objectives for the*

1        *new areas added to each sanctuary under section 5 of*  
2        *this Act. The assessment and any corresponding regu-*  
3        *latory changes shall be complete within 24 months of*  
4        *the date of enactment of this Act.*

5                (2) *REGULATION OF SPECIFIC ACTIVITIES.—In*  
6        *revising the regulations for the Sanctuaries pursuant*  
7        *to this subsection, the Secretary shall consider appro-*  
8        *priate regulations for the following activities:*

9                        (A) *The deposit or release of introduced spe-*  
10                      *cies.*

11                      (B) *The alteration of stream and river*  
12                      *drainage into the Sanctuaries.*

13                      (C) *Mariculture operations in the Sanc-*  
14                      *tuaries.*

15                (3) *CONSIDERATIONS.—In revising the regula-*  
16        *tions for the Sanctuaries pursuant to this subsection,*  
17        *the Secretary shall consider exempting from further*  
18        *regulation under the National Marine Sanctuaries*  
19        *Act and this Act discharges that are permitted under*  
20        *a National Pollution Discharge Elimination System*  
21        *permit in effect on the date of enactment of this Act,*  
22        *or under a new or renewed National Pollution Dis-*  
23        *charge Elimination System permit that does not in-*  
24        *crease pollution in the Sanctuaries and that origi-*  
25        *nates—*

1                   (A) *in the Russian River Watershed outside*  
2                   *the boundaries of the Gulf of the Farallones Na-*  
3                   *tional Marine Sanctuary; or*

4                   (B) *from the Bodega Marine Laboratory.*

5           (e) *CONTENTS OF PLANS.—Revisions to each com-*  
6 *prehensive management plan under this section shall, in*  
7 *addition to matters required under section 304(a)(2) of the*  
8 *Marine Protection, Research, and Sanctuaries Act of 1972*  
9 *(16 U.S.C. 1434(A)(2))—*

10                   (1) *facilitate all appropriate public and private*  
11 *uses of the national marine sanctuary to which each*  
12 *respective plan applies consistent with the primary*  
13 *objective of sanctuary resource protection;*

14                   (2) *establish temporal and geographical zoning if*  
15 *necessary to ensure protection of sanctuary resources;*

16                   (3) *identify priority needs for research that*  
17 *will—*

18                           (A) *improve management of the Sanc-*  
19 *tuaries;*

20                           (B) *diminish threats to the health of the*  
21 *ecosystems in the Sanctuaries; or*

22                           (C) *fulfill both of subparagraphs (A) and*  
23 *(B);*

24                   (4) *establish a long-term ecological monitoring*  
25 *program and database, including the development*

1 *and implementation of a resource information system*  
2 *to disseminate information on the Sanctuaries' eco-*  
3 *system, history, culture, and management;*

4 *(5) identify alternative sources of funding needed*  
5 *to fully implement the plan's provisions and supple-*  
6 *ment appropriations under section 313 of the Marine*  
7 *Protection, Research, and Sanctuaries Act of 1972 (16*  
8 *U.S.C. 1444);*

9 *(6) ensure coordination and cooperation between*  
10 *sanctuary superintendents and other Federal, State,*  
11 *and local authorities with jurisdiction over areas*  
12 *within or adjacent to the Sanctuaries to deal with*  
13 *issues affecting the Sanctuaries, including surface*  
14 *water run-off, stream and river drainages, and navi-*  
15 *gation;*

16 *(7) in the case of revisions to the plan for the*  
17 *Farallones NMS, promote cooperation with farmers*  
18 *and ranchers operating in the watersheds adjacent to*  
19 *the Farallones NMS and establish voluntary best*  
20 *management practices programs;*

21 *(8) promote cooperative and educational pro-*  
22 *grams with fishing vessel operators and crews oper-*  
23 *ating in the waters of the Sanctuaries, and, whenever*  
24 *possible, include individuals who engage in fishing*  
25 *and their vessels in cooperative research, assessment,*

1 *and monitoring programs and educational programs*  
2 *to promote sustainable fisheries, conservation of re-*  
3 *sources, and navigational safety; and*

4 *(9) promote education and public awareness,*  
5 *among users of the Sanctuaries, about the need for*  
6 *marine resource conservation and safe navigation and*  
7 *marine transportation.*

8 *(f) PUBLIC PARTICIPATION.—The Secretary shall pro-*  
9 *vide for participation by the general public in the revision*  
10 *of the comprehensive management plans and relevant regu-*  
11 *lations under this section.*

12 **SEC. 8. AUTHORIZATION OF APPROPRIATIONS.**

13 *There are authorized to be appropriated to the Sec-*  
14 *retary—*

15 *(1) \$3,000,000 to carry out this Act for each of*  
16 *fiscal years 2009 through 2013, other than for con-*  
17 *struction and acquisition projects; and*

18 *(2) \$3,500,000 for fiscal year 2009 and such*  
19 *sums as may be necessary for each of fiscal years*  
20 *2010 through 2013 for construction and acquisition*  
21 *projects related to the Sanctuaries.*

Amend the title so as to read: “A bill to expand the boundaries of the Gulf of the Farallones National Marine Sanctuary and the Cordell Bank National Marine Sanctuary, and for other purposes.”.
