1 **SEC. 2. REVISED STANDARDS FOR QUALITY ASSURANCE IN**
2 **SCREENING AND EVALUATION OF**

4 (a) **IN GENERAL.**—Section 353(f)(4)(B)(iv) of the
5 Public Health Service Act (42 U.S.C. 263a(f)(4)(B)(iv))
6 is amended to read as follows:

7 “(iv) requirements that each clinical
8 laboratory—

9 “(I) ensure that all individuals
10 involved in screening and interpreting
11 cytological preparations at the labora-
12 tory participate annually in a con-
13 tinuing medical education program in
14 gynecologic cytology that—

15 “(aa) is approved by the Ac-
16 crediting Council for Continuing
17 Medical Education or the Amer-
18 ican Academy of Continuing
19 Medical Education; and

20 “(bb) provides each indi-
21 vidual participating in the pro-
22 gram with gynecologic cytologic
23 preparations (in the form of ref-
24 erenced glass slides or equivalent
25 technologies) designed to improve
26 the locator, recognition and inter-

1 pretive skills of the individual;
2 and

3 “(H) maintain a record of the cy-
4 tology continuing medical education
5 results of each individual involved in
6 screening and interpreting cytological
7 preparations at the laboratory.”

8 (b) EFFECTIVE DATE AND IMPLEMENTATION; TER-
9 MINATION OF CURRENT PROGRAM OF INDIVIDUAL PRO-
10 FICIENCY TESTING.—

11 (1) EFFECTIVE DATE AND IMPLEMENTATION.—

12 Except as provided in paragraph (2), the amend-
13 ment made by subsection (a) applies to gynecologic
14 cytology services provided on or after the date that
15 is one year after the date of the enactment of this
16 Act, and the Secretary of Health and Human Serv-
17 ices (hereafter in this subsection referred to as the
18 “Secretary”) shall issue final regulations imple-
19 menting such amendment not later than 270 days
20 after such date of enactment.

21 (2) TERMINATION OF CURRENT INDIVIDUAL
22 PROFICIENCY TESTING PROGRAM.—As of the date of
23 the enactment of this Act, the Secretary shall termi-
24 nate the individual proficiency testing program es-
25 tablished pursuant to section 353(f)(4)(B)(iv) of the

1 Public Health Service Act (42 U.S.C.
2 263a(f)(4)(B)(iv)), as in effect before the enactment
3 of this section.

19 viduals involved in screening and in-
20 terpreting cytological preparations at
21 the laboratory and, when necessary,
22 identify needs for remedial training or
23 a corrective action plan to improve
24 skills; and

1 “(IV) submit the continuing edu-
2 cation program results for each indi-
3 vidual and, if appropriate, plans for
4 corrective action or remedial training
5 in a timely manner to the laboratory’s
6 accrediting organization for purposes
7 of review and on-going monitoring by
8 the accrediting organization, including
9 reviews of the continuing medical edu-
10 cation program results during on-site
11 inspections of the laboratory.”.

12 (b) *EFFECTIVE DATE AND IMPLEMENTATION; TERMI-*
13 *NATION OF CURRENT PROGRAM OF INDIVIDUAL PRO-*
14 *FICIENCY TESTING.—*

15 (1) *EFFECTIVE DATE AND IMPLEMENTATION.—*
16 *Except as provided in paragraph (2), the amendment*
17 *made by subsection (a) applies to gynecologic cytology*
18 *services provided on or after the first day of the first*
19 *calendar year beginning 1 year or more after the date*
20 *of the enactment of this Act, and the Secretary of*
21 *Health and Human Services (hereafter in this sub-*
22 *section referred to as the “Secretary”) shall issue final*
23 *regulations implementing such amendment not later*
24 *than 270 days after such date of enactment.*

1 (2) *TERMINATION OF CURRENT INDIVIDUAL*
2 *TESTING PROGRAM.—The Secretary of Health and*
3 *Human Services shall terminate the individual pro-*
4 *ficiency testing program established pursuant to sec-*
5 *tion 353(f)(4)(B)(iv) of the Public Health Service Act*
6 *(42 U.S.C. 263a(f)(4)(B)(iv)), as in effect on the day*
7 *before the date of the enactment of subsection (a), at*
8 *the end of the calendar year which includes the date*
9 *of enactment of the amendment made by subsection*
10 *(a).*
