Mr. WYNN introduced the following bill; which was referred to the Committee on Small Business

A BILL

To amend the Small Business Act to provide a penalty for the failure by a Federal contractor to subcontract with small businesses as described in its subcontracting plan, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Subcontractor Protec-
5 tion Act”.

1 **SEC. 2. IMPLEMENTATION OF SUBCONTRACTING PLANS.**

2 Section 8(d) of the Small Business Act (15 U.S.C.
3 637(d)) is amended by adding at the end the following
4 new paragraphs:

5 “(12) In the case of any contract containing a sub-
6 contracting plan included pursuant to paragraph (4) or
7 (5), the following provisions apply:

8 “(A) The Federal agency awarding the contract
9 shall include in the contract a clause providing for
10 the withholding of not less than (i) \$5,000 in the
11 case of a contract in the amount of \$100,000 or
12 less, (ii) 3 percent of the contract amount in the
13 case of a contract in an amount of more than
14 \$100,000 and less than \$5,000,000, and (iii) 5 per-
15 cent of the contract amount in the case of a contract
16 in an amount of \$5,000,000 or more, if the con-
17 tractor does not achieve the percentage goal for the
18 utilization of small business concerns owned and
19 controlled by socially and economically disadvan-
20 taged individuals as set forth in the subcontracting
21 plan.

22 “(B) The Federal agency awarding the contract
23 shall require the contractor to provide written jus-
24 tification to the agency whenever the contractor, in
25 performing the contract, does not enter into a sub-
26 contract with, or substitutes another subcontractor

1 for, a specific small business concern identified in
2 the subcontracting plan.

3 “(13) The Administration shall establish a telephone
4 line or other electronic means of communication through
5 which any small business concern identified in a subcon-
6 tracting plan by an offeror or bidder may communicate
7 to the Administration any concerns regarding major devi-
8 ations by prime contractors from the use of small business
9 concerns as subcontractors under the prime contract as
10 described in subcontracting plans.”.

11 **SEC. 3. REQUIREMENT TO CONSIDER USE OF SMALL BUSI-**
12 **NESS CONCERNS OWNED AND CONTROLLED**
13 **BY SOCIALLY AND ECONOMICALLY DIS-**
14 **ADVANTAGED INDIVIDUALS WHEN CONSID-**
15 **ERING PAST COMPLIANCE WITH SUBCON-**
16 **TRACTING PLANS.**

17 Paragraphs (4)(C) and (5)(B) of section 8(d) of the
18 Small Business Act (15 U.S.C. 637(d)) are each amended
19 in the second sentence by inserting “, especially compli-
20 ance with the goal set forth in such plans for the utiliza-
21 tion of small business concerns owned and controlled by
22 socially and economically disadvantaged individuals,” after
23 “other such subcontracting plans”.
