A BILL

To direct the Secretary of the Interior to study the suitability and feasibility of designating certain lands along the northern coast of Maui, Hawaii, as a unit of the National Park System.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. NORTH MAUI COASTAL STUDY.**

4 (a) **SHORT TITLE.**—This section may be cited as the
5 “North Maui Coastal Preservation Act of 2007”.

6 (b) **STUDY.**—

7 (1) **IN GENERAL.**—The Secretary of the Inte-
8 rior shall complete a study to determine the suit-

1 ability and feasibility of designating certain lands lo-
2 cated on the northern coast of Maui, Hawaii, as a
3 National Seashore, National Historical Park, Na-
4 tional Recreation Area, National Monument, Na-
5 tional Preserve, or other unit of the National Park
6 System.

7 (2) STUDY AREA.—The study area shall include
8 the following parcels:

9 (A) Property 1, approximately 43 acres
10 (TMK II 3–8–01, parcel 72) stretching from
11 Kelaakai Place in Sprecklesville to the western
12 boundary of H.P. Baldwin Beach Park Road in
13 Paia, and includes natural sand dunes, coastal
14 beaches, and wetlands.

15 (B) Property 2, approximately 17 acres
16 known as H.P. Baldwin Park comprises TMK
17 II 2–5–05, parcel 47 (4.6 acres) and parcel 46
18 (12.5 acres).

19 (C) Property 3, approximately 4.5 acres of
20 coastal lands stretching from the eastern border
21 of H.P. Baldwin Park to the Maui Youth and
22 Cultural Center known as TMK II 2–6–01, par-
23 cel 1 (3.517 acres) and parcel 4 (1.08 acres).

24 (D) Property 4, approximately 32 acres
25 known as TMK II 2–5–05; parcel 17.

1 (E) Property 5, approximately 5.7 acres
2 known as Lime Kiln Beach (TMK II 2-5-05,
3 parcel 14).

4 (F) Property 6, approximately 26 acres
5 known as Stable Road Beach (TMK II 3-8-01,
6 parcel 3).

7 (3) APPLICABILITY OF OTHER LAW.—Para-
8 graphs (2) and (3) of section 8(c) of Public Law 91-
9 383 (16 U.S.C. 1a-5(c)(2) and (3); commonly
10 known as the National Park System General Au-
11 thorities Act) shall apply to the study.

12 (c) REPORT.—Not later than 18 months after funds
13 are made available for this section, the Secretary of the
14 Interior shall transmit to the Committee on Natural Re-
15 sources of the House of Representatives and the Com-
16 mittee on Energy and Natural Resources of the Senate
17 a report containing the conclusions of the study required
18 by subsection (b).
