**AN ACT**

To amend the Reclamation Wastewater and Groundwater Study and Facilities Act to authorize the Secretary of the Interior to participate in the Elsinore Valley Municipal Water District Wildomar Service Area Recycled Water Distribution Facilities and Alberhill Wastewater Treatment and Reclamation Facility Projects.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Elsinore Valley Munic-  
3 ipal Water District Wastewater and Recycled Water Fa-  
4 cilities Act of 2007”.

5 **SEC. 2. PROJECT AUTHORIZATION.**

6 (a) IN GENERAL.—The Reclamation Wastewater and  
7 Groundwater Study and Facilities Act (Public Law 102–  
8 575, title XVI; 43 U.S.C. 390h et seq.) is amended by  
9 adding after section 1636 the following:

10 **“SEC. 1637. ELSINORE VALLEY MUNICIPAL WATER DIS-**  
11 **TRICT PROJECTS, CALIFORNIA.**

12 “(a) AUTHORIZATION.—The Secretary, in coopera-  
13 tion with the Elsinore Valley Municipal Water District,  
14 California, may participate in the design, planning, and  
15 construction of permanent facilities needed to establish re-  
16 cycled water distribution and wastewater treatment and  
17 reclamation facilities that will be used to treat wastewater  
18 and provide recycled water in the Elsinore Valley Munic-  
19 ipal Water District, California.

20 “(b) COST SHARING.—The Federal share of the cost  
21 of each project described in subsection (a) shall not exceed  
22 25 percent of the total cost of the project.

23 “(c) LIMITATION.—Funds provided by the Secretary  
24 under this section shall not be used for operation or main-  
25 tenance of the projects described in subsection (a).

1       “(d) AUTHORIZATION OF APPROPRIATIONS.—There  
2 is authorized to be appropriated to carry out this section  
3 \$12,500,000.”.

4       (b) CLERICAL AMENDMENT.—The table of sections  
5 in section 2 of Public Law 102–575 is amended by insert-  
6 ing after the item relating to section 1636 the following:

“Sec. 1637. Elsinore Valley Municipal Water District Projects, California.”.
