## A BILL

To extend the trade adjustment assistance program under the Trade Act of 1974 for 3 months.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. EXTENSION OF TRADE ADJUSTMENT ASSIST-**  
2 **ANCE PROGRAM FOR 3 MONTHS.**

3 (a) **ASSISTANCE FOR WORKERS.**—Section 245(a) of  
4 the Trade Act of 1974 (19 U.S.C. 2317(a)) is amended  
5 by striking “September 30, 2007” and inserting “Decem-  
6 ber 31, 2007”.

7 (b) **ASSISTANCE FOR FIRMS.**—Section 256(b) of the  
8 Trade Act of 1974 (19 U.S.C. 2346(b)) is amended by  
9 inserting after “2007,” the following: “, and \$4,000,000  
10 for the 3-month period beginning on October 1, 2007.”.

11 (c) **ASSISTANCE FOR FARMERS.**—Section 298(a) of  
12 the Trade Act of 1974 (19 U.S.C. 2401g(a)) is amended  
13 by inserting before the period the following: “, and there  
14 are authorized to be appropriated to the Department of  
15 Agriculture to carry out this chapter \$22,500,000 for the  
16 3-month period beginning on October 1, 2007”.

17 (d) **EXTENSION OF TERMINATION DATES.**—Section  
18 285 of the Trade Act of 1974 (19 U.S.C. 2271 note) is  
19 amended by striking “September 30” each place it ap-  
20 pears and inserting “December 31”.

21 **SECTION 1. TEMPORARY EXTENSION OF TRADE ADJUST-**  
22 **MENT ASSISTANCE PROGRAM.**

23 (a) **ASSISTANCE FOR WORKERS.**—Section 245(a) of  
24 the Trade Act of 1974 (19 U.S.C. 2317(a)) is amended by  
25 striking “September 30, 2007” and inserting “December 31,  
26 2007”.

1       **(b) ASSISTANCE FOR FIRMS.**—Section 256(b) of the  
2 *Trade Act of 1974 (19 U.S.C. 2346(b))* is amended by in-  
3 *serting after “2007,” the following: “and \$4,000,000 for the*  
4 *3-month period beginning on October 1, 2007,”.*

5       **(c) ASSISTANCE FOR FARMERS.**—Section 298(a) of the  
6 *Trade Act of 1974 (19 U.S.C. 2401g(a))* is amended by in-  
7 *serting before the period the following: “, and there are au-*  
8 *thorized to be appropriated and there are appropriated to*  
9 *the Department of Agriculture to carry out this chapter*  
10 *\$9,000,000 for the 3-month period beginning on October 1,*  
11 *2007”.*

12       **(d) EXTENSION OF TERMINATION DATES.**—Section  
13 *285 of the Trade Act of 1974 (19 U.S.C. 2271 note)* is  
14 *amended by striking “September 30” each place it appears*  
15 *and inserting “December 31”.*

16       **(e) EFFECTIVE DATE.**—The amendments made by this  
17 *section shall be effective as of October 1, 2007.*
