1 **SECTION 1. RUSH HUDSON LIMBAUGH, SR., FEDERAL**  
 2 **COURTHOUSE.**

3 (a) **DESIGNATION.**—The United States courthouse  
 4 located at 555 Independence Street, Cape Girardeau, Mis-  
 5 souri, shall be known and designated as the “Rush Hud-  
 6 son Limbaugh, Sr., United States Courthouse”.

7 (b) **REFERENCES.**—Any reference in a law, map, reg-  
 8 ulation, document, paper, or other record of the United  
 9 States to the United States courthouse referred to in sub-  
 10 section (a) shall be deemed to be a reference to the “Rush  
 11 Hudson Limbaugh, Sr., United States Courthouse”.
