## A BILL

To amend title 23, United States Code, to inspect highway tunnels.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. HIGHWAY TUNNEL INSPECTIONS.**

2 (a) IN GENERAL.—Section 151 of title 23, United  
3 States Code, is amended—

4 (1) in the section heading by inserting “**and**  
5 **tunnel**” after “**bridge**”;

6 (2) in subsection headings (a) and (c) by insert-  
7 ing “AND TUNNEL” after “BRIDGE” each place it  
8 appears;

9 (3) in the text by inserting “and tunnel” after  
10 “bridge” each place it appears; and

11 (4) in the text by inserting “and tunnels” after  
12 “bridges”; and

13 (5) in subsection (d) by striking “of this title”  
14 and inserting “for the bridge inspection program  
15 and section 104(a) and section 502 for the tunnel  
16 inspection program.”

17 (b) SURFACE TRANSPORTATION PROGRAM.—Section  
18 133(b)(1) of such title is amended by inserting “, tunnels,  
19 including safety inspection,” after “highways)”.
