A BILL

To designate the Federal building located at 4600 Silver Hill Road in Suitland, Maryland, as the “Thomas Jefferson Census Bureau Headquarters Building”.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. FINDINGS.**

4 Congress finds that—

1 (1) Thomas Jefferson, as Secretary of State in
2 1790, supervised the first modern census in world
3 history;

4 (2) the 1790 census was the first national cen-
5 sus in the United States and the first periodic cen-
6 sus in the modern nation-state era;

7 (3) Jefferson urged President Washington to
8 veto the first apportionment bill presented by Con-
9 gress on the grounds that it was unconstitutional,
10 and Jefferson's own apportionment formula was
11 adopted and used until 1840;

12 (4) Jefferson's mastery of numbers and statis-
13 tical analysis helped alert the Nation to the impor-
14 tance of accuracy in the numbers used to describe
15 the society and pointed to methods that later im-
16 proved census taking;

17 (5) Jefferson offered population corrections to
18 the European diplomatic community to more accu-
19 rately convey the fast-growing United States popu-
20 lation, which had been undercounted in previous cen-
21 sus taking;

22 (6) Jefferson believed in the importance of ter-
23 ritorial expansion and insisted on equal representa-
24 tion for the territories that were to join the Union
25 as States;

1 (7) Jefferson supervised the first census in
2 world history that gave to the people more than it
3 took from them, being designed less to extract taxes
4 or raise a militia than to apportion political power
5 to the people of the United States according to their
6 numbers; and

7 (8) Jefferson’s role in establishing a republic
8 based on principles of representation underscores the
9 historical significance of the United States census
10 and the way the Government views and governs
11 itself today.

12 **SEC. 2. DESIGNATION.**

13 The Federal building located at 4600 Silver Hill
14 Road in Suitland, Maryland, shall be known and des-
15 ignated as the “Thomas Jefferson Census Bureau Head-
16 quarters Building”.

17 **SEC. 3. REFERENCES.**

18 Any reference in a law, map, regulation, document,
19 paper, or other record of the United States to the Federal
20 building referred to in section 2 shall be deemed to be
21 a reference to the “Thomas Jefferson Census Bureau
22 Headquarters Building”.
