## A BILL

To provide for the repeal of the phase out of incandescent light bulbs unless the Comptroller General makes certain specific findings.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Light Bulb Freedom  
5 of Choice Act”.

6 **SEC. 2. REPEAL.**

7 (a) IN GENERAL.—Effective 6 months after the date  
8 of enactment of this Act, sections 321 and 322, and the

1 items in the table of contents relating thereto, of the En-  
2 ergy Independence and Security Act of 2007 are repealed,  
3 unless the Comptroller General has before that time trans-  
4 mitted to the Congress a report containing all of the find-  
5 ings described in section 3(a).

6 (b) REVERSION.—If a repeal occurs under subsection  
7 (a), the amendments made by sections 321 and 322 of  
8 the Energy Independence and Security Act of 2007 are  
9 hereby repealed, and the laws amended thereby shall read  
10 as if those amendments had not been enacted.

11 **SEC. 3. COMPTROLLER GENERAL REPORT.**

12 (a) FINDINGS.—A report referred to in section 2(a)  
13 is a report that finds that—

14 (1) consumers will obtain a net savings, in  
15 terms of dollars spent on the combination of month-  
16 ly electric bills and expenses for new light fixtures  
17 to accommodate the use of the light bulbs required  
18 by the amendments described in section 2(a), com-  
19 pared to dollars spent before the enactment of those  
20 amendments;

21 (2) the phase-out required by those amend-  
22 ments will reduce overall carbon dioxide emissions by  
23 20 percent in the United States by the year 2025;  
24 and

1           (3) such phase-out will not pose any health  
2 risks, including risks associated with mercury con-  
3 tainment in certain light bulbs, to consumers or the  
4 general public, including health risks with respect to  
5 hospitals, schools, day care centers, mental health  
6 facilities, and nursing homes.

7           (b) PROJECTIONS.—The report shall include monthly  
8 and yearly projections of expenses described in subsection  
9 (a)(1) over the period of January 1, 2012, through De-  
10 cember 31, 2017.
