A BILL

To amend the National Voter Registration Act of 1993 to require applications for voter registration with respect to elections for Federal office to include a statement that an alien who falsely claims to be a citizen of the United States is deportable under the Immigration and Nationality Act, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Noncitizen Voting Pre-
5 vention Act of 2008”.

1 **SEC. 2. REQUIRING APPLICATIONS FOR VOTER REGISTRA-**
2 **TION TO INCLUDE STATEMENT REGARDING**
3 **DEPORTABILITY OF ALIENS MAKING FALSE**
4 **CLAIMS OF UNITED STATES CITIZENSHIP.**

5 (a) CONTENTS OF APPLICATIONS FOR VOTER REG-
6 ISTRATION.—Section 9(b) of the National Voter Registra-
7 tion Act of 1993 (42 U.S.C. 1973gg–7(b)) is amended—

8 (1) by striking “and” at the end of paragraph
9 (3);

10 (2) by striking the period at the end of para-
11 graph (4) and inserting “; and”; and

12 (3) by adding at the end the following new
13 paragraph:

14 “(5) shall include a statement that an alien who
15 falsely represents himself to be a citizen of the
16 United States for any purpose or benefit under law,
17 including registering to vote, is deportable under
18 section 237(a)(3)(D) of the Immigration and Na-
19 tionality Act (8 U.S.C. 1227(a)(3)(D)).”.

20 (b) EFFECTIVE DATE.—The amendment made by
21 subsection (a) shall take effect upon the expiration of the
22 90-day period which begins on the date of the enactment
23 of this Act, and shall apply with respect to elections occur-
24 ring after the expiration of such period.

1 **SEC. 3. REQUIRING POSTING AT POLLING PLACES OF NO-**
2 **TICE REGARDING ILLEGAL VOTING BY NON-**
3 **CITIZENS.**

4 (a) **IN GENERAL.**—Section 302(b)(2)(F) of the Help
5 America Vote Act of 2002 (42 U.S.C. 15482(b)(2)(F)) is
6 amended by striking the period at the end and inserting
7 the following: “, as well as a specific statement that it
8 is a violation of Federal law for an individual who is not
9 a citizen of the United States to cast a ballot in an election
10 for Federal office.”.

11 (b) **EFFECTIVE DATE.**—The amendment made by
12 subsection (a) shall apply with respect to elections occur-
13 ring after the date of the enactment of this Act.
