A BILL

To amend the District of Columbia School Reform Act of 1995 to permit the District of Columbia government to exercise authority over the Public Charter School Board in the same manner as the District government may exercise authority over other entities of the District government.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Public Charter Schools
5 Home Rule Act of 2008”.

1 **SEC. 2. AUTHORITY OF DISTRICT OF COLUMBIA GOVERN-**
 2 **MENT TO REGULATE PUBLIC CHARTER**
 3 **SCHOOL BOARD.**

4 Section 2214 of the District of Columbia School Re-
 5 form Act of 1995 (sec. 38–1802.14, D.C. Official Code)
 6 is amended by adding at the end the following new sub-
 7 section:

8 “(j) DETERMINATION OF MEMBERSHIP OF BOARD IN
 9 ACCORDANCE WITH DISTRICT LAW.—

10 “(1) IN GENERAL.—Notwithstanding subsection
 11 (a), the membership of the Board and the process
 12 by which members of the Board are appointed shall
 13 be determined in accordance with such laws as may
 14 be enacted by the District of Columbia.

15 “(2) TRANSITION.—Subsection (a) shall remain
 16 in effect until a law enacted by the District of Co-
 17 lumbia takes effect to establish the membership of
 18 the Board and the process by which members of the
 19 Board are appointed.”.

20 **SEC. 3. REPEAL OF OTHER REQUIREMENTS RELATING TO**
 21 **RECEIPT OF REPORTS BY FEDERAL GOVERN-**
 22 **MENT.**

23 (a) RECEIPT OF ANNUAL REPORT OF CHARTERING
 24 AUTHORITIES.—Section 2211(d) of the District of Colum-
 25 bia School Reform Act of 1995 (sec. 38–1802.11(d), D.C.
 26 Official Code) is amended in the matter preceding para-

1 graph (1) by striking “the Secretary of Education, the ap-
2 propriate congressional committees,”.

3 (b) RECEIPT OF ANNUAL REPORT ON NUMBER OF
4 STUDENTS.—Section 2402(c) of such Act (sec. 38–
5 1804.02(c), D.C. Official Code), as amended by section
6 102(b) of the Public School Enrollment Integrity Clari-
7 fication and Board of Education Honoraria Amendment
8 Act of 2004 (D.C. Law 15–348), is amended by striking
9 “the Authority (during a control year), the Council, the
10 Comptroller General of the United States, and the appro-
11 priate congressional committees” and inserting “the Au-
12 thority (during a control year) and the Council”.

13 (c) ACCESS TO FISCAL AND STAFFING DATA.—Sec-
14 tion 2752(b) of such Act (sec. 38–1807.52(b), D.C. Offi-
15 cial Code) is amended by striking “the Authority, and ap-
16 propriate congressional committees” and inserting “and
17 the Authority”.
