## A BILL

To designate the facility of the United States Postal Service located at 1750 Lundy Avenue in San Jose, California, as the “Gordon N. Chan Post Office Building”.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. GORDON N. CHAN POST OFFICE BUILDING.**

2 (a) DESIGNATION.—The facility of the United States  
3 Postal Service located at 1750 Lundy Avenue in San Jose,  
4 California, shall be known and designated as the “Gordon  
5 N. Chan Post Office Building”.

6 (b) REFERENCES.—Any reference in a law, map, reg-  
7 ulation, document, paper, or other record of the United  
8 States to the facility referred to in subsection (a) shall  
9 be deemed to be a reference to the “Gordon N. Chan Post  
10 Office Building”.
