# H. R. 6832

## AN ACT

To authorize major medical facility projects and major medical facility leases for the Department of Veterans Affairs for fiscal year 2009, to extend certain authorities of the Secretary of Veterans Affairs, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE; TABLE OF CONTENTS.**

2 (a) SHORT TITLE.—This Act may be cited as the  
3 “Veterans’ Programs Extension and Construction Author-  
4 ization Act of 2008”.

2 **MEDICAL FACILITY**  
3 **PROJECTS AND MAJOR MED-**  
4 **ICAL FACILITY LEASES**

5 **SEC. 101. AUTHORIZATION FOR FISCAL YEAR 2009 MAJOR**  
6 **MEDICAL FACILITY PROJECTS.**

7 The Secretary of Veterans Affairs may carry out the  
8 following major medical facility projects in fiscal year  
9 2009 in the amount specified for each project:

10 (1) Seismic corrections, Building 2, at the De-  
11 partment of Veterans Affairs Palo Alto Health Care  
12 System, Palo Alto Division Palo Alto, California, in  
13 an amount not to exceed \$54,000,000.

14 (2) Construction of a polytrauma healthcare  
15 and rehabilitation center at the Department of Vet-  
16 erans Affairs Medical Center, San Antonio, Texas,  
17 in an amount not to exceed \$66,000,000.

18 (3) Seismic corrections, Building 1, at the De-  
19 partment of Veterans Affairs Medical Center, San  
20 Juan, Puerto Rico, in an amount not to exceed  
21 \$225,900,000.

1 **SEC. 102. MODIFICATION OF AUTHORIZATION AMOUNTS**  
2 **FOR CERTAIN MAJOR MEDICAL FACILITY**  
3 **CONSTRUCTION PROJECTS PREVIOUSLY AU-**  
4 **THORIZED.**

5 (a) MODIFICATION OF MAJOR MEDICAL FACILITY  
6 AUTHORIZATIONS.—Section 801(a) of the Veterans Bene-  
7 fits, Health Care, and Information Technology Act of  
8 2006 (Public Law 109–461) is amended—

9 (1) in paragraph (1)—

10 (A) by striking “\$300,000,000” and in-  
11 sserting “\$625,000,000”; and

12 (B) by striking the second sentence; and

13 (2) in paragraph (3), by striking  
14 “\$98,000,000” and inserting “\$769,200,000”.

15 (b) MODIFICATION OF AUTHORIZATION FOR CER-  
16 TAIN MAJOR MEDICAL FACILITY CONSTRUCTION  
17 PROJECTS PREVIOUSLY AUTHORIZED IN CONNECTION  
18 WITH CAPITAL ASSET REALIGNMENT INITIATIVE.—

19 (1) CORRECTION OF PATIENT PRIVACY DEFICI-  
20 CIENCIES AT THE DEPARTMENT OF VETERANS AF-  
21 FAIRS MEDICAL CENTER, GAINESVILLE, FLORIDA.—

22 Paragraph (5) of section 802 of the Veterans Bene-  
23 fits, Health Care, and Information Technology Act  
24 of 2006 (Public Law 109–461) is amended by strik-  
25 ing “\$85,200,000” and inserting “\$136,700,000”.

1           (2) CONSTRUCTION OF A NEW MEDICAL CEN-  
2           TER FACILITY AT THE DEPARTMENT OF VETERANS  
3           AFFAIRS MEDICAL CENTER, LAS VEGAS, NEVADA.—  
4           Paragraph (7) of such section is amended by strik-  
5           ing “\$406,000,000” and inserting “\$600,400,000”.

6           (3) CONSTRUCTION OF A NEW OUTPATIENT  
7           CLINIC, LEE COUNTY, FLORIDA.—Paragraph (8) of  
8           such section is amended—

9                   (A) by striking “ambulatory” and all that  
10                  follows through “purchase,” and inserting “out-  
11                  patient clinic in”; and

12                   (B) by striking “\$65,100,000” and insert-  
13                  ing “\$131,800,000”.

14           (4) CONSTRUCTION OF A NEW MEDICAL CEN-  
15           TER FACILITY, ORLANDO, FLORIDA.—Paragraph  
16           (11) of such section is amended by striking  
17           “\$377,700,000” and inserting “\$656,800,000”.

18           (5) CONSOLIDATION OF CAMPUSES AT THE UNI-  
19           VERSITY DRIVE AND H. JOHN HEINZ III DIVISIONS,  
20           PITTSBURGH, PENNSYLVANIA.—Paragraph (12) of  
21           such section is amended by striking “\$189,205,000”  
22           and inserting “\$295,600,000”.

1 **SEC. 103. AUTHORIZATION OF FISCAL YEAR 2009 MAJOR**  
2 **MEDICAL FACILITY LEASES.**

3 The Secretary of Veterans Affairs may carry out the  
4 following major medical facility leases in fiscal year 2009  
5 at the locations specified, and in an amount for each lease  
6 not to exceed the amount shown for such location:

7 (1) For an outpatient clinic, Brandon, Florida,  
8 \$4,326,000.

9 (2) For an outpatient clinic, Colorado Springs,  
10 Colorado, \$3,995,000.

11 (3) For an outpatient clinic, Eugene, Oregon,  
12 \$5,826,000.

13 (4) For the expansion of an outpatient clinic,  
14 Green Bay, Wisconsin, \$5,891,000.

15 (5) For an outpatient clinic, Greenville, South  
16 Carolina, \$3,731,000.

17 (6) For an outpatient clinic, Mansfield, Ohio,  
18 \$2,212,000.

19 (7) For an outpatient clinic, Mayaguez, Puerto  
20 Rico, \$6,276,000.

21 (8) For an outpatient clinic, Mesa, Arizona,  
22 \$5,106,000.

23 (9) For interim research space, Palo Alto, Cali-  
24 fornia, \$8,636,000.

25 (10) For the expansion of an outpatient clinic,  
26 Savannah, Georgia, \$3,168,000.

1           (11) For an outpatient clinic, Sun City, Ari-  
2           zona, \$2,295,000.

3           (12) For a primary care annex, Tampa, Flor-  
4           ida, \$8,652,000.

5 **SEC. 104. AUTHORIZATION OF CONSTRUCTION OF MAJOR**  
6                   **MEDICAL FACILITY, OKALOOSA COUNTY,**  
7                   **FLORIDA.**

8           (a) AUTHORIZATION.—The Secretary of Veterans Af-  
9           fairs shall carry out a major medical facility project to  
10          construct a new medical facility of the Department of Vet-  
11          erans Affairs in Okaloosa County, Florida, in an amount  
12          not to exceed \$54,475,000.

13          (b) FACILITY LOCATION.—The facility authorized to  
14          be constructed pursuant to subsection (a) shall be built  
15          in accordance with option 2 of the report to Congress  
16          dated June 26, 2007, required to be submitted under sec-  
17          tion 823 of the Veterans Benefits, Health Care, and Infor-  
18          mation Technology Act of 2006 (Public Law 109–461;  
19          120 Stat. 3449).

20          (c) PLAN FOR SHARING OF INPATIENT AND OUT-  
21          PATIENT SERVICES.—Not later than 180 days after the  
22          date of the enactment of the Act, the Secretary of Vet-  
23          erans Affairs shall submit to the Committees on Veterans’  
24          Affairs of the Senate and House of Representatives a plan  
25          that sets forth terms and conditions for the sharing of in-

1 patient and outpatient services at the medical facility au-  
2 thorized to be constructed pursuant to subsection (a).

3 **SEC. 105. AUTHORIZATION OF APPROPRIATIONS.**

4 (a) AUTHORIZATION OF APPROPRIATIONS FOR FIS-  
5 CAL YEAR 2009 MAJOR MEDICAL FACILITY PROJECTS.—

6 There is authorized to be appropriated for the Secretary  
7 of Veterans Affairs for fiscal year 2009 for the Construc-  
8 tion, Major Projects, account—

9 (1) \$345,900,000 for the projects authorized in  
10 section 101;

11 (2) \$1,694,295,000 for the increased amounts  
12 authorized for projects whose authorizations are  
13 modified by section 102; and

14 (3) \$54,475,000 for the project authorized in  
15 section 104.

16 (b) AUTHORIZATION FOR APPROPRIATIONS FOR FIS-  
17 CAL YEAR 2009 MAJOR MEDICAL FACILITY LEASES.—

18 There is authorized to be appropriated for the Secretary  
19 of Veterans Affairs for fiscal year 2009 for the Medical  
20 Facilities account, \$60,114,000, for the leases authorized  
21 in section 103.

22 **SEC. 106. REPORT ON FACILITIES ADMINISTRATION.**

23 Not later than 60 days after the date of the enact-  
24 ment of this Act, the Secretary of Veterans Affairs shall  
25 submit to the Committees on Veterans' Affairs of the Sen-

1 ate and House of Representatives a report updating the  
2 progress of the Secretary in complying with section 312A  
3 of title 38, United States Code.

4 **SEC. 107. ANNUAL REPORT ON OUTPATIENT CLINICS.**

5 (a) ANNUAL REPORT REQUIRED.—Subchapter I of  
6 chapter 81 of title 38, United States Code, is amended  
7 by adding at the end the following new section:

8 **“§ 8119. Annual report on outpatient clinics**

9 “(a) ANNUAL REPORT REQUIRED.—The Secretary  
10 shall submit to the committees an annual report on com-  
11 munity-based outpatient clinics and other outpatient clin-  
12 ics of the Department. The report shall be submitted each  
13 year not later than the date on which the budget for the  
14 next fiscal year is submitted to the Congress under section  
15 1105 of title 31.

16 “(b) CONTENTS OF REPORT.—Each report required  
17 under subsection (a) shall include the following:

18 “(1) A list of each community-based outpatient  
19 clinic and other outpatient clinic of the Department,  
20 and for each such clinic, the type of clinic, location,  
21 size, number of health professionals employed by the  
22 clinic, workload, whether the clinic is leased or con-  
23 structed and operated by the Secretary, and the an-  
24 nual cost of operating the clinic.

1           “(2) A list of community-based outpatient clin-  
2           ics and other outpatient clinics that the Secretary  
3           opened during the fiscal year preceding the fiscal  
4           year during which the report is submitted and a list  
5           of clinics the Secretary proposes opening during the  
6           fiscal year during which the report is submitted and  
7           the subsequent fiscal year, together with the cost of  
8           activating each such clinic and the information re-  
9           quired to be provided under paragraph (1) for each  
10          such clinic and proposed clinic.

11          “(3) A list of proposed community-based out-  
12          patient clinics and other outpatient clinics that are,  
13          as of the date of the submission of the report, under  
14          review by the National Review Panel and a list of  
15          possible locations for future clinics identified in the  
16          Department’s strategic planning process, including  
17          any identified locations in rural and underserved  
18          areas.

19          “(4) A prioritized list of sites of care identified  
20          by the Secretary that the Secretary could establish  
21          without carrying out construction or entering into a  
22          lease, including—

23                  “(A) any such sites that could be expanded  
24                  by hiring additional staff or allocating staff to

1 Federal facilities or facilities operating in col-  
 2 laboration with the Federal Government; and

3 “(B) any sites established, or able to be es-  
 4 tablished, under sections 8111 and 8153 of this  
 5 title.”.

6 (b) DEADLINE FOR FIRST ANNUAL REPORT.—The  
 7 Secretary of Veterans Affairs shall submit the first report  
 8 required under section 8119(a) of title 38, United States  
 9 Code, as added by subsection (a), by not later than 90  
 10 days after the date of the enactment of this Act.

11 (c) CLERICAL AMENDMENT.—The table of sections  
 12 at the beginning of such chapter is amended by adding  
 13 at the end of the items relating to subchapter I the fol-  
 14 lowing new item:

“8119. Annual report on outpatient clinics.”.

15 **TITLE II—EXTENSION OF**

17 **SEC. 201. REPEAL OF SUNSET ON INCLUSION OF NON-**  
 18 **INSTITUTIONAL EXTENDED CARE SERVICES**  
 19 **IN DEFINITION OF MEDICAL SERVICES.**

20 Section 1701 of title 38, United States Code, is  
 21 amended—

22 (1) by striking paragraph (10); and

23 (2) in paragraph (6)—

1 (A) by redesignating subparagraphs (E)  
2 and (F) as subparagraphs (F) and (G), respec-  
3 tively; and

4 (B) by inserting after subparagraph (D)  
5 the following new subparagraph (E):

6 “(E) Noninstitutional extended care serv-  
7 ices, including alternatives to institutional ex-  
8 tended care that the Secretary may furnish di-  
9 rectly, by contract, or through provision of case  
10 management by another provider or payer.”.

11 **SEC. 202. EXTENSION OF RECOVERY AUDIT AUTHORITY.**

12 Section 1703(d)(4) of title 38, United States Code,  
13 is amended by striking “September 30, 2008” and insert-  
14 ing “September 30, 2013”.

15 **SEC. 203. PERMANENT AUTHORITY FOR PROVISION OF**  
16 **HOSPITAL CARE, MEDICAL SERVICES, AND**  
17 **NURSING HOME CARE TO VETERANS WHO**  
18 **PARTICIPATED IN CERTAIN CHEMICAL AND**  
19 **BIOLOGICAL TESTING CONDUCTED BY THE**  
20 **DEPARTMENT OF DEFENSE.**

21 (a) PERMANENT AUTHORITY.—Subsection (e)(3) of  
22 section 1710 of title 38, United States Code, is amended—

23 (1) in subparagraph (B), by inserting “and”  
24 after the semicolon;

1 (2) in subparagraph (C), by striking “; and”  
2 and inserting a period; and

3 (3) by striking subparagraph (D).

4 (b) CONFORMING AMENDMENT.—Subsection  
5 (e)(1)(E) of such section is amended by striking “para-  
6 graphs (2) and (3)” and inserting “paragraph (2)”.

7 **SEC. 204. EXTENSION OF EXPIRING COLLECTIONS AU-**  
8 **THORITIES.**

9 (a) HEALTH CARE COPAYMENTS.—Section  
10 1710(f)(2)(B) of title 38, United States Code, is amended  
11 by striking “September 30, 2008” and inserting “Sep-  
12 tember 30, 2010”.

13 (b) MEDICAL CARE COST RECOVERY.—Section  
14 1729(a)(2)(E) of title 38, United States Code, is amended  
15 by striking “October 1, 2008” and inserting “October 1,  
16 2010”.

17 **SEC. 205. EXTENSION OF NURSING HOME CARE.**

18 Section 1710A(d) of title 38, United States Code, is  
19 amended by striking “December 31, 2008” and inserting  
20 “December 31, 2013”.

21 **SEC. 206. EXTENSION OF AUTHORITY TO CARRY OUT IN-**  
22 **COME VERIFICATION.**

23 Section 5317(g) of title 38, United States Code, is  
24 amended by striking “September 30, 2008” and inserting  
25 “September 30, 2010”.

1 **SEC. 207. PERMANENT AUTHORITY TO ESTABLISH RE-**  
2 **SEARCH CORPORATIONS.**

3 (a) REPEAL.—Title 38, United States Code, is  
4 amended by striking section 7368.

5 (b) CLERICAL AMENDMENT.—The table of sections  
6 at the beginning of chapter 73 of such title is amended  
7 by striking the item relating to section 7368.

17 inserting “2012”.

18 **SEC. 209. EXTENSION OF REQUIREMENT TO SUBMIT AN-**

20 **ON POST-TRAUMATIC-STRESS DISORDER.**

21 Section 110(e)(2) of the Veterans’ Health Care Act  
22 of 1984 (38 U.S.C. 1712A note; Public Law 98–528) is  
23 amended by striking “through 2008” and inserting  
24 “through 2012”.

1 **SEC. 210. EXTENSION OF REQUIREMENT TO SUBMIT AN-**  
2 **NUAL REPORT ON THE COMMITTEE ON CARE**  
3 **OF SEVERELY CHRONICALLY MENTALLY ILL**  
4 **VETERANS.**

5 Section 7321(d)(2) of title 38, United States Code,  
6 is amended by striking “through 2008” and inserting  
7 “through 2012”.

8 **SEC. 211. PERMANENT REQUIREMENT FOR BIENNIAL RE-**  
9 **PORT ON WOMEN’S ADVISORY COMMITTEE.**

10 Section 542(c)(1) of title 38, United States Code, is  
11 amended by striking “through 2008”.

12 **SEC. 212. PERMANENT AUTHORITY FOR ADVISORY COM-**  
13 **MITTEE ON MINORITY VETERANS.**

14 Section 544 of title 38, United States Code, is  
15 amended by striking subsection (e).

16 **SEC. 213. EXTENSION OF TEMPORARY INCREASE IN MAX-**  
17 **IMUM LOAN GUARANTY AMOUNT FOR CER-**  
18 **TAIN HOUSING LOANS GUARANTEED BY THE**  
19 **SECRETARY OF VETERANS AFFAIRS.**

20 Section 2201 of the Housing and Economic Recovery  
21 Act of 2008 (Public Law 110–289) is amended by striking  
22 “December 31, 2008” and inserting “December 31,  
23 2011”.

11 LOANS SUBJECT TO GUARANTY MAXIMUM.—Section  
12 3703(a)(1)(A)(i)(IV) of title 38, United States Code, is  
13 amended by inserting “(5),” after “(3),”.

14           (b) INCREASE IN MAXIMUM PERCENTAGE OF LOAN  
15 TO-VALUE OF REFINANCING LOANS SUBJECT TO GUAR-  
16 ANTY.—Section 3710(b)(8) of such title is amended by  
17 striking “90 percent” and inserting “100 percent”.

18   **SEC. 303. TECHNICAL AMENDMENTS.**

1 Technology Act of 2006 (Public Law 109–461) is amend-  
2 ed by striking “Medical Care” each place it appears and  
3 inserting “Medical Facilities”.
