Mr. PAUL introduced the following bill; which was referred to the Committee on Transportation and Infrastructure

A BILL

To ensure that a private for-profit nursing home affected by a major disaster receives the same reimbursement as a public nursing home affected by a major disaster.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Nursing Home Emer-
5 gency Assistance Act”.

1 **SEC. 2. FEDERAL ASSISTANCE TO PRIVATE FOR-PROFIT**
2 **NURSING HOMES.**

3 Title IV of the Robert T. Stafford Disaster Relief and
4 Emergency Assistance Act is amended by inserting after
5 section 408 (42 U.S.C. 5170 et seq.) the following:

6 **“SEC. 409. FEDERAL ASSISTANCE TO PRIVATE FOR-PROFIT**
7 **NURSING HOMES.**

8 “(a) IN GENERAL.—Notwithstanding any other pro-
9 vision of this Act, the President may provide, from funds
10 made available to carry out this Act, reimbursement to
11 a private for-profit nursing home, for damage to, or an
12 expense incurred by, such nursing home during a major
13 disaster or emergency declared under this Act, in accord-
14 ance with this section.

15 “(b) ELIGIBILITY.—A private for-profit nursing
16 home shall be eligible to receive reimbursement under sub-
17 section (a) if, as determined by the President, in consulta-
18 tion with the Governor of a State—

19 “(1) the damage to, or expense incurred by, the
20 nursing home was the result of a declared major dis-
21 aster or emergency;

22 “(2) the nursing home is located within 30
23 miles of the declared major disaster or emergency
24 area; and

25 “(3) during the declared major disaster or
26 emergency, the nursing home acted in accordance

1 with any relevant requirement that would apply to a
2 private nonprofit nursing home seeking, and eligible
3 for, reimbursement under this Act.

4 “(c) LIMITATION.—The amount of reimbursement
5 provided to a private for-profit nursing home under this
6 section shall not be greater than the amount of reimburse-
7 ment available under this Act for a public or private non-
8 profit nursing home for similar damage or incurred ex-
9 penses after a declared major disaster or emergency.

10 “(d) DEFINITION.—For purposes of this section, the
11 term ‘nursing home’ means an establishment with 3 or
12 more beds that provides nursing or personal care services
13 to the older population, infirm, or chronically ill.”.
