Mr. SKELTON (for himself and Mr. HUNTER) introduced the following bill;
which was referred to the Committee on Armed Services

A BILL

To amend the Military Construction Authorization Act for Fiscal Year 2007 to correct an error in the enrollment of the law that resulted in the omission of two Army construction and land acquisition projects authorized in the conference report (House Report 109–702), and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. INCLUSION OF OMITTED ARMY CONSTRUCTION**
4 **AND LAND ACQUISITION PROJECTS.**

5 (a) FINDINGS.—Congress make the following find-
6 ings:

1 (1) House Report 109–702, which is the con-
2 ference report resolving the disagreeing votes of the
3 House of Representatives and the Senate on the
4 amendment of the Senate to the bill (H.R. 5122), to
5 authorize appropriations for fiscal year 2007 for
6 military activities of the Department of Defense, for
7 military construction, and for defense activities of
8 the Department of Energy, to prescribe military per-
9 sonnel strengths for such fiscal year, and for other
10 purposes, contains a table of Army construction and
11 land acquisition projects that the Secretary of the
12 Army is authorized to carry out inside the United
13 States.

14 (2) This table of authorized Army projects ap-
15 pears in section 2101(a) on pages 366 and 367 of
16 the conference report, and includes projects for Fort
17 Lee, Virginia, in the amount of \$4,150,000, and
18 Fort Lewis, Washington, in the amount of
19 \$502,600,000.

20 (3) The table of authorized Army projects in
21 section 2101(a) of the enrolled version of the bill
22 (H.R. 5122) and in the resulting Public Law 109–
23 364 (120 Stat. 2445) inadvertently omits these two
24 projects.

1 (b) INCLUSION OF PROJECTS.—Section 2101(a) of
2 the Military Construction Authorization Act for Fiscal
3 Year 2007 (division B of Public Law 109–364; 120 Stat.
4 2445) is amended—

5 (1) by striking the first table of Army projects
6 for inside the United States; and

7 (2) by adding at the end of the remaining table
8 an item relating to Fort Lee, Virginia, in the
9 amount of \$4,150,000, and an item relating to Fort
10 Lewis, Washington, in the amount of \$502,600,000.

11 (c) OTHER MILITARY CONSTRUCTION-RELATED
12 TECHNICAL CORRECTIONS.—

13 (1) LOCATION OF ARMY PROJECT OUTSIDE THE
14 UNITED STATES.—The table in section 2101(b) of
15 that Act (120 Stat. 2446) is amended by striking
16 “Babadag Range” and inserting “Mihail
17 Kogalniceanu Air Base”.

18 (2) LOCATION OF ARMY FAMILY HOUSING
19 PROJECT.—The table in section 2102(a) of that Act
20 (120 Stat. 2447) is amended by striking “Fort
21 McCoyine” and inserting “Fort McCoy”.
