A BILL

To amend Public Law 106–348 to extend the authorization for establishing a memorial in the District of Columbia or its environs to honor veterans who became disabled while serving in the Armed Forces of the United States.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. EXTENSION OF AUTHORITY FOR ESTABLISHING**

4 **DISABLED VETERANS MEMORIAL.**

5 Public Law 106–348 is amended—

1 (1) in subsection (b)—

2 (A) by striking “The establishment” and
3 inserting “Except as provided in subsection (e),
4 the establishment”; and

5 (B) by striking “the Commemorative
6 Works Act (40 U.S.C. 1001 et seq.)” and in-
7 serting “chapter 89 of title 40, United States
8 Code”;

9 (2) in subsection (d)—

10 (A) by striking “section 8(b) of the Com-
11 memorative Works Act (40 U.S.C. 1008(b))”
12 and inserting “section 8906 of title 40, United
13 States Code”;

14 (B) by striking “or upon expiration of the
15 authority for the memorial under section 10(b)
16 of such Act (40 U.S.C. 1010(b)),”; and

17 (C) by striking “section 8(b)(1) of such
18 Act (40 U.S.C. 1008(b)(1))” and inserting
19 “8906(b)(2) or (3) of such title”; and

20 (3) by adding at the end the following new sub-
21 section:

22 “(e) TERMINATION OF AUTHORITY.—Notwith-
23 standing section 8903(e) of title 40, United States Code,

- 1 the authority to establish a memorial under this section
- 2 shall expire on October 24, 2015.”.
