## RESOLUTION

Providing for consideration of the bill (H.R. 5811) to amend title 44, United States Code, to require preservation of certain electronic records by Federal agencies, to require a certification and reports relating to Presidential records, and for other purposes.

1       *Resolved*, That upon the adoption of this resolution  
2 it shall be in order to consider in the House the bill (H.R.  
3 5811) to amend title 44, United States Code, to require  
4 preservation of certain electronic records by Federal agen-

1 cies, to require a certification and reports relating to Pres-  
2 idential records, and for other purposes. All points of  
3 order against consideration of the bill are waived except  
4 those arising under clause 9 or 10 of rule XXI. The  
5 amendment in the nature of a substitute recommended by  
6 the Committee on Oversight and Government Reform now  
7 printed in the bill shall be considered as adopted. The bill,  
8 as amended, shall be considered as read. All points of  
9 order against provisions of the bill, as amended, are  
10 waived. The previous question shall be considered as or-  
11 dered on the bill, as amended, to final passage without  
12 intervening motion except: (1) one hour of debate equally  
13 divided and controlled by the chairman and ranking mi-  
14 nority member of the Committee on Oversight and Gov-  
15 ernment Reform; and (2) one motion to recommit with  
16 or without instructions.

17       SEC. 2. During consideration of H.R. 5811 pursuant  
18 to this resolution, notwithstanding the operation of the  
19 previous question, the Chair may postpone further consid-  
20 eration of the bill to such time as may be designated by  
21 the Speaker.
