Ms. MATSUI, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

# RESOLUTION

Providing for consideration of the bill (H.R. 3043) making appropriations for the Departments of Labor, Health and Human Services, and Education, and related agencies for the fiscal year ending September 30, 2008, and for other purposes.

1       *Resolved*, That at any time after the adoption of this  
2 resolution the Speaker may, pursuant to clause 2(b) of  
3 rule XVIII, declare the House resolved into the Committee  
4 of the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 3043) making appropriations for

1 the Departments of Labor, Health and Human Services,  
2 and Education, and related agencies for the fiscal year  
3 ending September 30, 2008, and for other purposes. The  
4 first reading of the bill shall be dispensed with. All points  
5 of order against consideration of the bill are waived except  
6 those arising under clause 9 or 10 of rule XXI. General  
7 debate shall be confined to the bill and shall not exceed  
8 one hour equally divided and controlled by the chairman  
9 and ranking minority member of the Committee on Appro-  
10 priations. After general debate the bill shall be considered  
11 for amendment under the five-minute rule. Points of order  
12 against provisions in the bill for failure to comply with  
13 clause 2 of rule XXI are waived. During consideration of  
14 the bill for amendment, the Chairman of the Committee  
15 of the Whole may accord priority in recognition on the  
16 basis of whether the Member offering an amendment has  
17 caused it to be printed in the portion of the Congressional  
18 Record designated for that purpose in clause 8 of rule  
19 XVIII. Amendments so printed shall be considered as  
20 read. When the committee rises and reports the bill back  
21 to the House with a recommendation that the bill do pass,  
22 the previous question shall be considered as ordered on  
23 the bill and amendments thereto to final passage without  
24 intervening motion except one motion to recommit with  
25 or without instructions.

1        SEC. 2. During consideration in the House of H.R.  
2 3043 pursuant to this resolution, notwithstanding the op-  
3 eration of the previous question, the Chair may postpone  
4 further consideration of the bill to such time as may be  
5 designated by the Speaker.
