# RESOLUTION

Providing for consideration of the Senate amendment to the House amendment to the Senate amendment to the bill (H.R. 6) to move the United States toward greater energy independence and security, to increase the production of clean renewable fuels, to protect consumers, to increase the efficiency of products, buildings, and vehicles, to promote research on and deploy greenhouse gas capture and storage options, and to improve the energy

performance of the Federal Government, and for other purposes.

1       *Resolved*, That upon adoption of this resolution it  
2 shall be in order to take from the Speaker's table the bill  
3 (H.R. 6) to move the United States toward greater energy  
4 independence and security, to increase the production of  
5 clean renewable fuels, to protect consumers, to increase  
6 the efficiency of products, buildings, and vehicles, to pro-  
7 mote research on and deploy greenhouse gas capture and  
8 storage options, and to improve the energy performance  
9 of the Federal Government, and for other purposes, with  
10 the Senate amendment to the House amendment to the  
11 Senate amendment to the text, and to consider in the  
12 House, without intervention of any point of order except  
13 those arising under clause 10 of rule XXI, a motion of-  
14 fered by the Majority Leader or his designee that the  
15 House concur in the Senate amendment. The Senate  
16 amendment and the motion shall be considered as read.  
17 The motion shall be debatable for one hour equally divided  
18 and controlled by the Majority Leader and the Minority  
19 Leader or their designees. The previous question shall be  
20 considered as ordered on the motion to final adoption  
21 without intervening motion.

22       SEC. 2. During consideration of the motion to concur  
23 pursuant to this resolution, notwithstanding the operation  
24 of the previous question, the Chair may postpone further

1 consideration of the motion to such time as may be des-  
2 ignated by the Speaker.

3       SEC. 3. On the first legislative day of the second ses-  
4 sion of the One Hundred Tenth Congress, the House shall  
5 not conduct organizational or legislative business.
