A BILL

To amend the Great Sand Dunes National Park and Preserve Act of 2000 to explain the purpose and provide for the administration of the Baca National Wildlife Refuge.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. PURPOSE AND MANAGEMENT OF THE BACA NA-**
 2 **TIONAL WILDLIFE REFUGE.**

3 Section 6 of the Great Sand Dunes National Park
 4 and Preserve Act of 2000 (16 U.S.C. 410hhh-4) is
 5 amended—

6 (1) in subsection (a)—

7 (A) by striking “(a) ESTABLISHMENT.—

8 (1) When” and inserting the following:

9 “(a) ESTABLISHMENT AND PURPOSE.—

10 “(1) ESTABLISHMENT.—

11 “(A) IN GENERAL.—When”;

12 (B) in paragraph (2), by striking “(2)
 13 Such establishment” and inserting the fol-
 14 lowing:

15 “(B) EFFECTIVE DATE.—The establish-
 16 ment of the refuge under subparagraph (A)”;
 17 and

18 (C) by adding at the end the following:

19 “(2) PURPOSE.—The purpose of the Baca Na-
 20 tional Wildlife Refuge shall be to restore, enhance,
 21 and maintain wetland, upland, riparian, and other
 22 habitats for native wildlife, plant, and fish species in
 23 the San Luis Valley.”;

24 (2) in subsection (c)—

25 (A) by striking “The Secretary” and in-
 26 serting the following:

1 “(1) IN GENERAL.—The Secretary”; and

2 (B) by adding at the end the following:

3 “(2) REQUIREMENTS.—In administering the
4 Baca National Wildlife Refuge, the Secretary shall,
5 to the maximum extent practicable—

6 “(A) emphasize migratory bird conserva-
7 tion; and

8 “(B) take into consideration the role of the
9 Refuge in broader landscape conservation ef-
10 forts.”; and

11 (3) in subsection (d)—

12 (A) in paragraph (1), by striking “and” at
13 the end;

14 (B) in paragraph (2), by striking the pe-
15 riod at the end and inserting “; and”; and

16 (C) by adding at the end the following:

17 ~~“(3) use decreed water rights on the Refuge in
18 approximately the same manner that the water
19 rights have been used historically.”.~~

20 *“(3) subject to any agreement in existence as of
21 the date of enactment of this paragraph, and to the
22 extent consistent with the purposes of the Refuge, use
23 decreed water rights on the Refuge in approximately
24 the same manner that the water rights have been used
25 historically.”.*
