## A BILL

To establish a program for tribal colleges and universities within the Department of Health and Human Services and to amend the Native American Programs Act of 1974 to authorize the provision of grants and cooperative agreements to tribal colleges and universities, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE; TABLE OF CONTENTS.**

4 (a) **SHORT TITLE.**—This Act may be cited as the  
 5 “Tribal Health Promotion and Tribal Colleges and Uni-  
 6 versities Advancement Act of 2007”.

1 **TITLE I—THROUGH HIGHER**  
 2 **EDUCATION: PROMOTING**  
 3 **THE ADVANCEMENT OF TRIB-**  
 4 **AL HEALTH**

5 **SEC. 101. SHORT TITLE.**

6 This title may be cited as the “Through Higher Edu-  
 7 cation: Promoting the Advancement of Tribal Health Act”  
 8 or “THE PATH Act”.

9 **SEC. 102. FINDINGS AND PURPOSE.**

10 (a) **FINDINGS.**—Congress finds that—

11 (1) because there is a significant lack of health-  
 12 related education and training opportunities for In-  
 13 dians, few Indians are represented in the health-re-  
 14 lated workforce of the United States;

15 (2) tribal colleges and universities remain the  
 16 most poorly-funded institutions of higher education  
 17 in the United States, yet, as engaged institutions,  
 18 tribal colleges and universities serve as true catalysts  
 19 for positive change in Indian communities;

20 (3) tribal colleges and universities with nursing  
 21 programs train hundreds of students to hold criti-  
 22 cally-needed leadership and management positions in  
 23 the Indian Health Service, tribal health organiza-  
 24 tions, and private and community agencies serving  
 25 rural Indian populations;

1           (4) to the extent that tribal colleges and univer-  
2           sities are able, the colleges and universities have  
3           begun to address the many societal challenges faced  
4           by Indian communities;

5           (5) tribal colleges and universities offer criti-  
6           cally-needed education and outreach programs, in-  
7           cluding—

8                   (A) community health fairs;

9                   (B) HIV/AIDS education programs;

10                  (C) extensive diabetes programs;

11                  (D) nutritional and obesity programs, in-  
12                  cluding community garden programs;

13                  (E) substance abuse prevention programs;

14                  (F) youth-at-risk programs;

15                  (G) parenting classes; and

16                  (H) child and elder care services; and

17           (6) due to a chronic lack of operational and tar-  
18           geted program funding, together with the unwilling-  
19           ness of certain Federal agencies to recognize tribal  
20           colleges and universities as valuable partners in ad-  
21           dressing rural community issues, including health  
22           issues, tribal colleges and universities have limited  
23           resources available to adequately address the peren-  
24           nial health challenges of the rural communities  
25           served by the tribal colleges and universities.

1 (b) PURPOSE.—The purpose of this title is to assist  
 2 tribal colleges and universities to strengthen Indian com-  
 3 munities through the provision of health promotion and  
 4 disease prevention education, outreach, and workforce de-  
 5 velopment programs, including through program imple-  
 6 mentation, research, and capacity-building.

7 **SEC. 103. DEFINITIONS.**

8 In this title:

9 (1) DEPUTY ASSISTANT SECRETARY.—The term  
 10 “Deputy Assistant Secretary” means the Deputy As-  
 11 sistant Secretary for Minority Health, within the Of-  
 12 fice of Public Health and Science.

13 (2) DIRECTOR.—The term “Director” means  
 14 the Director of the National Institutes of Health.

15 (3) INDIAN.—The term “Indian” has the mean-  
 16 ing given the term in section 4 of the Indian Health  
 17 Care Improvement Act (25 U.S.C. 1603).

18 (4) SECRETARY.—The term “Secretary” means  
 19 the Secretary of Health and Human Services.

20 (5) TRIBAL COLLEGE OR UNIVERSITY.—The  
 21 term “tribal college or university” means—

22 (A) an institution that is eligible to receive  
 23 funds under the Tribally Controlled College or  
 24 University Assistance Act of 1978 (25 U.S.C.  
 25 1801 et seq.);

1                   (B) Diné College; and

2                   (C) any 1 of the 1994 Institutions (as de-  
3                   fined in section 532 of the Equity in Edu-  
4                   cational Land-Grant Status Act of 1994 (7  
5                   U.S.C. 301 note; Public Law 103-382)).

6 **SEC. 104. ADMINISTRATION BY COORDINATING OFFICER.**

7           (a) DESIGNATION.—The Deputy Assistant Secretary  
8 shall serve as the coordinating officer with respect to pro-  
9 grams of tribal colleges and universities relating to health  
10 promotion and disease prevention.

11          (b) STAFF.—The Secretary shall appoint such addi-  
12 tional staff as the Secretary determines to be necessary—

13               (1) to assist the Deputy Assistant Secretary in  
14 carrying out the duties under this section; and

15               (2) to provide appropriate technical assistance  
16 to tribal colleges and universities that receive grants  
17 or enter into cooperative agreements under this title.

18          (c) MEMORANDUM OF AGREEMENT.—Not later than  
19 180 days after the date of enactment of this Act, the Sec-  
20 retary, in consultation with the Deputy Assistant Sec-  
21 retary, shall develop and implement a formal memo-  
22 randum of agreement with the American Indian Higher  
23 Education Consortium to establish programs—

24               (1) to ensure that Native American commu-  
25 nities, through tribal colleges and universities, par-

1        participate equitably in employment programs, services,  
 2        and resources of the Department of Health and  
 3        Human Services; and

4                (2) to provide necessary technical assistance to  
 5        the tribal colleges and universities.

6        **SEC. 105. COMMUNITY-BASED HEALTH AND WELLNESS**

7                        **FAIRS.**

8                (a) ESTABLISHMENT.—The Secretary, acting  
 9 through the Deputy Assistant Secretary, shall establish a  
 10 program under which the Secretary shall provide grants  
 11 to, or offer to enter into cooperative agreements with, trib-  
 12 al colleges and universities to carry out annual, commu-  
 13 nity-based, and culturally relevant health and wellness  
 14 fairs at the tribal colleges and universities.

15                (b) FUNDING.—

16                        (1) AUTHORIZATION OF APPROPRIATIONS.—

17        There is authorized to be appropriated to the Sec-  
 18        retary to carry out this section for each of fiscal  
 19        years 2009 through 2017 an amount equal to the  
 20        sum of—

21                        (A) the product obtained by multiplying—

22                                (i) the number of tribal colleges and  
 23                                universities in operation on October 1 of  
 24                                the fiscal year; and

25                                (ii) \$15,000; and

1           ~~(B)~~ such amount as the Secretary deter-  
 2           mines to be necessary for the costs of admin-  
 3           istering the program under this section.

4           ~~(2)~~ TOTAL AMOUNT.—Subject to paragraph  
 5           ~~(3)~~, the Secretary shall use all amounts made avail-  
 6           able under paragraph ~~(1)~~(A) to provide grants or  
 7           enter into cooperative agreements pursuant to this  
 8           section.

9           ~~(3)~~ NONAPPLICABILITY OF LIMITATION.—The  
 10          limitation under section 1703(e) of the Public  
 11          Health Service Act (42 U.S.C. 300a-2(e)) shall not  
 12          apply to this section.

13 **SEC. 106. HEALTH PROMOTION AND DISEASE PREVENTION**  
 14                                   **TARGETED PROGRAMS; WELLNESS CENTERS.**

15          ~~(a)~~ HEALTH PROMOTION AND DISEASE PREVENTION  
 16 TARGETED PROGRAMS.—

17           ~~(1)~~ ESTABLISHMENT.—The Secretary, acting  
 18           through the Deputy Assistant Secretary, shall estab-  
 19           lish a program under which the Secretary shall pro-  
 20           vide grants to, or offer to enter into cooperative  
 21           agreements with, tribal colleges and universities to  
 22           carry out activities to improve and expand the ca-  
 23           pacity of the tribal colleges and universities—

24                           ~~(A)~~ to carry out activities relating to  
 25           health promotion and disease prevention; and

1           (~~B~~) to eliminate health disparities in tribal  
2           communities, to the maximum extent prac-  
3           ticable.

4           (~~2~~) REQUIREMENTS.—In providing grants and  
5           entering into cooperative agreements under this sub-  
6           section, the Secretary, to the maximum extent prac-  
7           ticable, shall—

8           (A) approve applications on a competitive  
9           basis; and

10          (~~B~~) ensure maximum and equitable dis-  
11          tribution among eligible tribal colleges and uni-  
12          versities.

13          (~~3~~) APPLICATION.—

14          (A) IN GENERAL.—To be eligible to receive  
15          a grant or enter into a cooperative agreement  
16          under this subsection, a tribal college or univer-  
17          sity shall submit to the Secretary an application  
18          at such time and in such manner as the Sec-  
19          retary may reasonably require.

20          (B) INCLUSION.—An application under  
21          subparagraph (A) shall include a description of  
22          a 5-year strategy of the applicable tribal college  
23          or university for meeting the health promotion  
24          and disease prevention needs of Indians or

1 Alaska Natives, as appropriate, in the area  
2 served by the tribal college or university.

3 (C) STREAMLINED PROCEDURE.—The Sec-  
4 retary shall ensure, to the maximum extent  
5 practicable, a simplified and streamlined proce-  
6 dure for the submission and approval of appli-  
7 cations under subparagraph (A), taking into  
8 consideration the limited number of institutions  
9 that are eligible to receive assistance under this  
10 subsection.

11 (4) ACTIVITIES.—A tribal college or university  
12 that receives a grant or enters into a cooperative  
13 agreement under this subsection may use the grant  
14 or cooperative agreement to develop and carry out  
15 activities to address targeted areas of health pro-  
16 motion and disease prevention in tribal communities,  
17 including activities relating to—

18 (A) diabetes education and prevention;

19 (B) injury prevention;

20 (C) substance abuse, including meth-  
21 amphetamine abuse;

22 (D) HIV-AIDS prevention;

23 (E) emerging health promotion and disease  
24 prevention program and response development;  
25 and

1                   ~~(F)~~ obesity and nutrition.

2                   ~~(5)~~ AUTHORIZATION OF APPROPRIATIONS.—

3                   There is authorized to be appropriated to carry out  
4                   this subsection \$10,000,000 for each of fiscal years  
5                   2009 through 2017.

6                   ~~(b)~~ WELLNESS CENTERS.—

7                   ~~(1)~~ ESTABLISHMENT.—The Secretary, acting  
8                   through the Deputy Assistant Secretary, shall estab-  
9                   lish a program under which the Secretary shall pro-  
10                  vide grants to tribal colleges and universities for  
11                  purposes of—

12                  ~~(A)~~ construction, renovation, and mod-  
13                  ernization of community wellness centers lo-  
14                  cated on the campuses of the tribal colleges and  
15                  universities; and

16                  ~~(B)~~ construction, renovation, and mod-  
17                  ernization of outpatient student health clinics  
18                  located on those campuses.

19                  ~~(2)~~ MAXIMUM AMOUNT.—

20                  ~~(A)~~ IN GENERAL.—Except as provided in  
21                  subparagraph ~~(B)~~, the maximum amount of a  
22                  grant provided under paragraph ~~(1)~~ shall not  
23                  exceed an amount equal to 95 percent of the  
24                  cost of the project carried out by the applicable  
25                  tribal college or university.

1           (B) EXCEPTION.—The limitation under  
 2           subparagraph (A) shall not apply to a tribal  
 3           college or university located in, as determined  
 4           by the Secretary—

5                     (i) an urban area; or

6                     (ii) a poor rural area.

7           (3) AUTHORIZATION OF APPROPRIATIONS.—

8           There is authorized to be appropriated to carry out  
 9           this subsection \$15,000,000 for each of fiscal years  
 10          2009 through 2017.

11 **SEC. 107. DEVELOPMENT AND EXPANSION OF PUBLIC**  
 12                     **HEALTH PROFESSIONAL DEGREE PRO-**  
 13                     **GRAMS.**

14          (a) ESTABLISHMENT.—The Secretary, acting  
 15          through the Administrator of the Health Resources and  
 16          Services Administration, shall establish a program under  
 17          which the Secretary shall provide grants to tribal colleges  
 18          and universities for purposes of developing curricula,  
 19          courses, and degree and in-service programs for health-  
 20          related professions.

21          (b) APPLICATION.—

22                     (1) IN GENERAL.—To be eligible to receive a  
 23          grant under this subsection, a tribal college or uni-  
 24          versity shall submit to the Secretary an application

1 at such time and in such manner as the Secretary  
2 may reasonably require.

3 (2) INCLUSION.—An application under para-  
4 graph (1) shall include a description of a 5-year  
5 strategy of the applicable tribal college or university  
6 for increasing the number of Indians in the health  
7 workforce of the United States.

8 (3) STREAMLINED PROCEDURE.—The Secretary  
9 shall ensure, to the maximum extent practicable, a  
10 simplified and streamlined procedure for the submis-  
11 sion and approval of applications under paragraph  
12 (1), taking into consideration the limited number of  
13 institutions that are eligible to receive assistance  
14 under this section.

15 (c) AUTHORIZATION OF APPROPRIATIONS.—There is  
16 authorized to be appropriated to carry out this subsection  
17 \$10,000,000 for each of fiscal years 2009 through 2017.

18 **SEC. 108. TRIBAL COLLEGE AND UNIVERSITY RURAL**

19 **HEALTH EQUITY ENDOWMENT FUND.**

20 (a) ESTABLISHMENT.—There is established in the  
21 Treasury of the United States a fund, to be known as the  
22 “Tribal College and University Rural Health Equity En-  
23 dowment Fund” (referred to in this section as the  
24 “Fund”), consisting of—

1           (1) such amounts as are appropriated to the  
2 Fund under subsection (b); and

3           (2) any interest earned on those amounts.

4           (b) TRANSFERS TO FUND.—There is appropriated to  
5 the Fund, out of funds of the Treasury not otherwise ap-  
6 propriated, \$9,000,000 for each of fiscal years 2009  
7 through 2017.

8           (c) INVESTMENTS.—The Secretary shall invest  
9 amounts in the Fund in interest-bearing obligations of the  
10 United States.

11          (d) EXPENDITURES FROM FUND.—

12           (1) IN GENERAL.—Subject to paragraph (2), on  
13 September 30 of fiscal year 2009 and annually  
14 thereafter through September 30, 2017, on request  
15 by the Secretary, the Secretary of the Treasury shall  
16 transfer from the Fund to the Secretary an amount  
17 equal to the amount of interest income earned on  
18 amounts in the Fund during the preceding fiscal  
19 year.

20           (2) ADMINISTRATIVE EXPENSES.—An amount  
21 not exceeding 1 percent of the annual interest yield  
22 distributed to tribal colleges and universities shall be  
23 available for each fiscal year to pay the administra-  
24 tive expenses necessary to carry out this section.

1 (e) DISTRIBUTION OF AMOUNTS.—Of amounts trans-  
 2 ferred under subsection (d)(1), the Secretary shall dis-  
 3 tribute—

4 (1) 60 percent to tribal colleges and universities  
 5 on a pro rata basis, based on the proportion that—

6 (A) the Indian student count (as defined in  
 7 section 2(a) of the Tribally Controlled College  
 8 or University Assistance Act of 1978 (25  
 9 U.S.C. 1801(a)) of a tribal college or university  
 10 for the applicable fiscal year; bears to

11 (B) the Indian student count of all tribal  
 12 colleges and universities for that fiscal year;  
 13 and

14 (2) 40 percent in payments of equal amounts to  
 15 each tribal college and university.

16 (f) USE OF FUNDS.—A tribal college or university  
 17 shall use amounts received under this section to establish  
 18 an endowment for a rural health-related program at the  
 19 tribal college or university.

20 **SEC. 109. OFFICES OF SPONSORED PROGRAMS.**

21 (a) ESTABLISHMENT.—The Secretary, acting  
 22 through the Director, shall establish a program under  
 23 which the Secretary shall provide grants to tribal colleges  
 24 and universities to establish and maintain at the tribal col-

1 leges and universities offices of sponsored programs de-  
2 scribed in subsection (b):

3 (b) ~~SPONSORED PROGRAMS.~~—The sponsored pro-  
4 grams referred to in subsection (a) include programs for—

5 (1) pre- and post-grant award research, data  
6 collection, and analyses, through a method that en-  
7 sures—

8 (A) proper documentation of relevant ap-  
9 plications; and

10 (B) compliance with applicable regulations  
11 and guidelines;

12 (2) advancing specific institutional grant appli-  
13 cation procedures and processes through coordina-  
14 tion of external funding sources and faculty, staff,  
15 and financial officers;

16 (3) assisting in negotiations with Federal fund-  
17 ing sources;

18 (4) providing liaisons with Federal counterparts  
19 of tribal colleges and universities—

20 (A) to train and assist principal investiga-  
21 tors, faculty, and college staff with respect to  
22 grant management, reporting, and program im-  
23 plementation; and

24 (B) to ensure that applicable deadlines are  
25 met and required reports are completed;

1           (5) coordinating partnerships between tribal  
2 colleges and universities, Federal agencies, and the  
3 private sector for collaborative programs and activi-  
4 ties; and

5           (6) in consultation with Federal agencies, iden-  
6 tifying and proposing solutions to—

7               (A) obstacles relating to Federal agency  
8 grant application procedures and requirements;  
9 and

10              (B) other problems relating to Federal  
11 grant program structures and requirements.

12       (c) APPLICATION.—

13           (1) IN GENERAL.—To be eligible to receive a  
14 grant under this section, a tribal college or univer-  
15 sity shall submit to the Secretary an application at  
16 such time and in such manner as the Secretary may  
17 reasonably require.

18           (2) INCLUSION.—An application under para-  
19 graph (1) shall include a description of a 5-year  
20 strategy of the applicable tribal college or university  
21 for carrying out a sponsored program at the tribal  
22 college or university, including performance indica-  
23 tors by which success of the tribal college or univer-  
24 sity will be evaluated.

1       (d) DISTRIBUTION OF FUNDS.—For each of fiscal  
2 years 2009 through 2017, the Secretary, acting through  
3 the Director, shall provide to each tribal college and uni-  
4 versity the application of which is approved under sub-  
5 section (c) a grant in an amount equal to the quotient  
6 obtained by dividing—

7           (1) the total amount made available under sub-  
8 section (f) for the fiscal year; by

9           (2) the number of tribal colleges and univer-  
10 sities the applications of which are approved under  
11 subsection (c) for the fiscal year.

12       (e) REPORTS.—For each of fiscal years 2010 through  
13 2018, each tribal college or university that receives a grant  
14 under this section shall submit to the Director a report  
15 describing the success of the office of sponsored programs  
16 of the tribal college or university during the preceding fis-  
17 cal year, as determined in accordance with the perform-  
18 ance indicators contained in the application of the tribal  
19 college or university under subsection (c)(2).

20       (f) AUTHORIZATION OF APPROPRIATIONS.—There is  
21 authorized to be appropriated to carry out this section for  
22 each of fiscal years 2009 through 2017 an amount equal  
23 to the product obtained by multiplying—

1           (1) the number of tribal colleges and univer-  
2           sities in operation on October 1 of the applicable fis-  
3           cal year; and

4           (2) \$50,000.

5 **SEC. 110. HEALTH PROMOTION AND DISEASE PREVENTION**  
6           **RESEARCH PROGRAMS.**

7           (a) **ESTABLISHMENT.**—The Secretary, acting  
8 through the Director, shall establish a program under  
9 which the Secretary shall provide grants to, or offer to  
10 enter into cooperative agreements with, tribal colleges and  
11 universities to conduct research relating to health pro-  
12 motion and disease prevention at the tribal colleges and  
13 universities.

14           (b) **REQUIREMENTS.**—

15           (1) **COMPETITION.**—The Secretary shall provide  
16 grants and offer to enter into cooperative agree-  
17 ments under subsection (a) on a competitive basis.

18           (2) **GENERAL TERMS AND AMOUNTS.**—Except  
19 as provided in paragraph (3)—

20           (A) the term of a grant or cooperative  
21 agreement under subsection (a) shall be not  
22 more than 3 years; and

23           (B) the minimum amount of a grant under  
24 subsection (a) for a fiscal year shall be  
25 \$150,000.

1           ~~(3) UNDERGRADUATE RESEARCH EXPERIENCE~~  
2           PROGRAMS.—With respect to a grant or cooperative  
3           agreement provided for an undergraduate research  
4           experience program under subsection (d)~~(3)~~—

5                   (A) the term of such a grant or cooperative  
6                   agreement shall be not more than 1 year; and

7                   (B) the minimum amount of such a grant  
8                   for a fiscal year shall be \$10,000.

9           ~~(c) APPLICATION.—~~

10           ~~(1) IN GENERAL.—~~To be eligible to receive a  
11           grant, or to enter into a cooperative agreement,  
12           under this subsection, a tribal college or university  
13           shall submit to the Secretary an application at such  
14           time and in such manner as the Secretary may rea-  
15           sonably require.

16           ~~(2) STREAMLINED PROCEDURE.—~~The Secretary  
17           shall ensure, to the maximum extent practicable, a  
18           simplified and streamlined procedure for the submis-  
19           sion and approval of applications under paragraph  
20           ~~(1)~~, taking into consideration the limited number of  
21           institutions that are eligible to receive assistance  
22           under this section.

23           ~~(d) ACTIVITIES.—~~A tribal college or university that  
24           receives a grant or enters into a cooperative agreement

1 under this section may use the grant or cooperative agree-  
 2 ment to carry out activities, including—

3           (1) research on culturally relevant and innova-  
 4 tive health promotion and disease prevention strate-  
 5 gies;

6           (2) epidemiological research on the health sta-  
 7 tus of Indian populations and communities; and

8           (3) undergraduate research experience pro-  
 9 grams as the tribal college or university determines  
 10 to be appropriate.

11       (e) AUTHORIZATION OF APPROPRIATIONS.—There is  
 12 authorized to be appropriated to carry out this section  
 13 \$12,000,000 for each of fiscal years 2009 through 2017.

14 **TITLE II—ADVANCING TRIBES**  
 15 **THROUGH TRIBAL COLLEGES**  
 16 **AND UNIVERSITIES**

17 **SEC. 201. SHORT TITLE.**

18       This title may be cited as the “Advancing Tribes  
 19 Through Tribal Colleges and Universities Act” or the “AT  
 20 TCUs Act”.

21 **SEC. 202. FINDINGS.**

22       Congress finds that—

23           (1) a primary goal of providing Federal support  
 24 for higher education is to ensure social and economic

1 self-sufficiency and growth for all residents of the  
2 United States;

3 ~~(2)~~ social and economic underdevelopment is

6        **SEC. 105. COMMUNITY-BASED HEALTH AND WELLNESS**

7                        **FAIRS.**

8            *(a) ESTABLISHMENT.—The Secretary, acting through*  
 9        *the Deputy Assistant Secretary, shall establish a program*  
 10        *under which the Secretary shall provide grants to, or offer*  
 11        *to enter into cooperative agreements with, tribal colleges*  
 12        *and universities to carry out annual, community-based,*  
 13        *and culturally relevant health and wellness fairs at the trib-*  
 14        *al colleges and universities.*

15            *(b) FUNDING.—*

16                        *(1) AUTHORIZATION OF APPROPRIATIONS.—*  
 17        *There is authorized to be appropriated to the Sec-*  
 18        *retary to carry out this section for each of fiscal years*  
 19        *2009 through 2017 an amount equal to the sum of—*

20                                *(A) the product obtained by multiplying—*

21                                        *(i) the number of tribal colleges and*  
 22                                        *universities in operation on October 1 of the*  
 23                                        *fiscal year; and*

24                                        *(ii) \$15,000; and*

1           (B) such amount as the Secretary deter-  
 2           mines to be necessary for the costs of admin-  
 3           istering the program under this section.

4           (2) *TOTAL AMOUNT.*—Subject to paragraph (3),  
 5           the Secretary shall use all amounts made available  
 6           under paragraph (1)(A) to provide grants or enter  
 7           into cooperative agreements pursuant to this section.

8           (3) *NONAPPLICABILITY OF LIMITATION.*—The  
 9           limitation under section 1703(c) of the Public Health  
 10          Service Act (42 U.S.C. 300u–2(c)) shall not apply to  
 11          this section.

12 **SEC. 106. HEALTH PROMOTION AND DISEASE PREVENTION**  
 13                                   **TARGETED PROGRAMS.**

14          (a) *ESTABLISHMENT.*—The Secretary, acting through  
 15          the Deputy Assistant Secretary, shall establish a program  
 16          under which the Secretary shall provide grants to, or offer  
 17          to enter into cooperative agreements with, tribal colleges  
 18          and universities to assist the tribal colleges and universities  
 19          to build and expand the capacity to work collaboratively  
 20          with relevant Indian tribes—

21                 (1) to conduct coordinated community-based  
 22                 health promotion and disease prevention activities;  
 23                 and

1           (2) *to jointly plan and implement programs to*  
2           *help reduce health disparities in tribal communities,*  
3           *to the maximum extent practicable.*

4           **(b) REQUIREMENTS.**—*In providing grants and enter-*  
5           *ing into cooperative agreements under this section, the Sec-*  
6           *retary, to the maximum extent practicable, shall—*

7           (1) *approve applications on a competitive basis;*  
8           *and*

9           (2) *ensure maximum and equitable distribution*  
10          *among eligible tribal colleges and universities.*

11          **(c) APPLICATION.**—

12          (1) **IN GENERAL.**—*To be eligible to receive a*  
13          *grant or enter into a cooperative agreement under*  
14          *this section, a tribal college or university shall submit*  
15          *to the Secretary an application at such time and in*  
16          *such manner as the Secretary may reasonably re-*  
17          *quire.*

18          (2) **INCLUSIONS.**—*An application under para-*  
19          *graph (1) shall include—*

20                  (A) *a signed agreement between the tribal*  
21                  *college or university and each relevant Indian*  
22                  *tribe that—*

23                          (i) *requires the entities to establish a*  
24                          *partnership to implement the proposed com-*

1                   (ii) specifies the roles of each entity;

2                   (B) a jointly prepared 5-year plan for ad-  
3                   dressing the health promotion and disease pre-  
4                   vention needs of Indians or Alaska Natives, as  
5                   appropriate, in the area served by the tribal col-  
6                   lege or university;

7                   (C) a demonstration of need for the pro-  
8                   posed program;

9                   (D) an assurance that measures will be im-  
10                  plemented and monitored to minimize duplica-  
11                  tion of services; and

12                  (E) an assurance that, under the proposed  
13                  program, the tribal college or university shall not  
14                  be a direct provider of any health care treatment  
15                  or service.

16                  (3) *STREAMLINED PROCEDURE.*—The Secretary  
17                  shall ensure, to the maximum extent practicable, a  
18                  simplified and streamlined procedure for the submis-  
19                  sion and approval of applications under paragraph  
20                  (1), taking into consideration the limited number of  
21                  institutions that are eligible to receive assistance  
22                  under this section.

23                  (d) *ACTIVITIES.*—A tribal college or university that re-  
24                  ceives a grant or enters into a cooperative agreement under  
25                  this section may use the grant or cooperative agreement to

1 *develop and carry out activities to address targeted areas*  
 2 *of health promotion and disease prevention in tribal com-*  
 3 *munities, including activities described in a partnership*  
 4 *agreement under subsection (c)(2)(A) relating to—*

5 *(1) diabetes education and prevention;*

6 *(2) injury prevention;*

7 *(3) substance abuse, including methamphetamine*  
 8 *abuse;*

9 *(4) HIV–AIDS prevention;*

10 *(5) emerging health promotion and disease pre-*  
 11 *vention program and response development; and*

12 *(6) obesity and nutrition education.*

13 *(e) AUTHORIZATION OF APPROPRIATIONS.—There is*  
 14 *authorized to be appropriated to carry out this section*  
 15 *\$10,000,000 for each of fiscal years 2009 through 2017.*

16 **SEC. 107. DEVELOPMENT AND EXPANSION OF PUBLIC**  
 17 **HEALTH PROFESSIONAL DEGREE PROGRAMS.**

18 *(a) ESTABLISHMENT.—The Secretary, acting through*  
 19 *the Administrator of the Health Resources and Services Ad-*  
 20 *ministration, shall establish a program under which the*  
 21 *Secretary shall provide grants to tribal colleges and univer-*  
 22 *sities (which may include consortia of tribal colleges and*  
 23 *universities and other institutions of higher education) for*  
 24 *purposes of—*

1           (1) *developing curricula, courses, degree, and in-*  
2           *service programs for health-related professions; and*

3           (2) *strengthening those programs through the ac-*  
4           *quisition of basic and advanced laboratory, research,*  
5           *and classroom equipment, instruments, and com-*  
6           *puters (including software).*

7           (b) *APPLICATION.—*

8           (1) *IN GENERAL.—To be eligible to receive a*  
9           *grant under this subsection, a tribal college or univer-*  
10          *sity shall submit to the Secretary an application at*  
11          *such time and in such manner as the Secretary may*  
12          *reasonably require.*

13          (2) *INCLUSION.—An application under para-*  
14          *graph (1) shall include a description of a 5-year*  
15          *strategy of the applicable tribal college or university*  
16          *for increasing the number of Indians in the health*  
17          *workforce of the United States.*

18          (3) *STREAMLINED PROCEDURE.—The Secretary*  
19          *shall ensure, to the maximum extent practicable, a*  
20          *simplified and streamlined procedure for the submis-*  
21          *sion and approval of applications under paragraph*  
22          *(1), taking into consideration the limited number of*  
23          *institutions that are eligible to receive assistance*  
24          *under this section.*

1       (c) *AUTHORIZATION OF APPROPRIATIONS.*—*There is*  
2 *authorized to be appropriated to carry out this subsection*  
3 *\$15,000,000 for each of fiscal years 2009 through 2017.*

4 **SEC. 108. TRIBAL COLLEGE AND UNIVERSITY RURAL**  
5 **HEALTH EQUITY ENDOWMENT FUND.**

6       (a) *ESTABLISHMENT.*—*There is established in the*  
7 *Treasury of the United States a fund, to be known as the*  
8 *“Tribal College and University Rural Health Equity En-*  
9 *dowment Fund” (referred to in this section as the “Fund”),*  
10 *consisting of—*

11           (1) *such amounts as are appropriated to the*  
12 *Fund under subsection (b); and*

13           (2) *any interest earned on those amounts.*

14       (b) *TRANSFERS TO FUND.*—*There is appropriated to*  
15 *the Fund, out of funds of the Treasury not otherwise appro-*  
16 *priated, \$9,000,000 for each of fiscal years 2009 through*  
17 *2017.*

18       (c) *INVESTMENTS.*—*The Secretary shall invest*  
19 *amounts in the Fund in interest-bearing obligations of the*  
20 *United States.*

21       (d) *EXPENDITURES FROM FUND.*—

22           (1) *IN GENERAL.*—*Subject to paragraph (2), on*  
23 *September 30 of fiscal year 2009 and annually there-*  
24 *after through September 30, 2017, on request by the*  
25 *Secretary, the Secretary of the Treasury shall transfer*

1       *from the Fund to the Secretary an amount equal to*  
2       *the amount of interest income earned on amounts in*  
3       *the Fund during the preceding fiscal year.*

4           (2) *ADMINISTRATIVE EXPENSES.*—*An amount*  
5       *not exceeding 1 percent of the annual interest yield*  
6       *distributed to tribal colleges and universities shall be*  
7       *available for each fiscal year to pay the administra-*  
8       *tive expenses necessary to carry out this section.*

9           (e) *DISTRIBUTION OF AMOUNTS.*—*Of amounts trans-*  
10       *ferred under subsection (d)(1), the Secretary shall dis-*  
11       *tribute—*

12           (1) *60 percent to tribal colleges and universities*  
13       *on a pro rata basis, based on the proportion that—*

14           (A) *the Indian student count (as defined in*  
15       *section 2(a) of the Tribally Controlled College or*  
16       *University Assistance Act of 1978 (25 U.S.C.*  
17       *1801(a)) of a tribal college or university for the*  
18       *applicable fiscal year; bears to*

19           (B) *the Indian student count of all tribal*  
20       *colleges and universities for that fiscal year; and*

21           (2) *40 percent in payments of equal amounts to*  
22       *each tribal college and university.*

23           (f) *USE OF FUNDS.*—*A tribal college or university*  
24       *shall use amounts received under this section to establish*  
25       *and maintain an endowment for a health professions work-*

1 *force development program at the tribal college or univer-*  
2 *sity.*

3 **SEC. 109. OFFICES OF SPONSORED PROGRAMS.**

4       (a) *ESTABLISHMENT.*—*The Secretary, acting through*  
5 *the Director, shall establish a program under which the Sec-*  
6 *retary shall provide grants to tribal colleges and univer-*  
7 *sities to establish and maintain at the tribal colleges and*  
8 *universities offices of sponsored programs described in sub-*  
9 *section (b).*

10       (b) *SPONSORED PROGRAMS.*—*The sponsored programs*  
11 *referred to in subsection (a) include programs for—*

12               (1) *pre- and post-grant award research, data col-*  
13 *lection, and analyses, through a method that en-*  
14 *sures—*

15                       (A) *proper documentation of relevant appli-*  
16 *cations; and*

17                       (B) *compliance with applicable regulations*  
18 *and guidelines;*

19               (2) *advancing specific institutional grant appli-*  
20 *cation procedures and processes through coordination*  
21 *of external funding sources and faculty, staff, and fi-*  
22 *nancial officers;*

23               (3) *assisting in negotiations with Federal fund-*  
24 *ing sources;*

1           (4) *providing liaisons with Federal counterparts*  
2 *of tribal colleges and universities—*

3           (A) *to train and assist principal investiga-*  
4 *tors, faculty, and college staff with respect to*  
5 *grant management, reporting, and program im-*  
6 *plementation; and*

7           (B) *to ensure that applicable deadlines are*  
8 *met and required reports are completed;*

9           (5) *coordinating partnerships between tribal col-*  
10 *leges and universities, Federal agencies, and the pri-*  
11 *vate sector for collaborative programs and activities;*  
12 *and*

13           (6) *in consultation with Federal agencies, identi-*  
14 *fying and proposing solutions to—*

15           (A) *obstacles relating to Federal agency*  
16 *grant application procedures and requirements;*  
17 *and*

18           (B) *other problems relating to Federal grant*  
19 *program structures and requirements.*

20 (c) *APPLICATION.—*

21           (1) *IN GENERAL.—To be eligible to receive a*  
22 *grant under this section, a tribal college or university*  
23 *shall submit to the Secretary an application at such*  
24 *time and in such manner as the Secretary may rea-*  
25 *sonably require.*

1           (2) *INCLUSION.*—An application under para-  
2           graph (1) shall include a description of a 5-year  
3           strategy of the applicable tribal college or university  
4           for carrying out a sponsored program at the tribal  
5           college or university, including performance indica-  
6           tors by which success of the tribal college or university  
7           will be evaluated.

8           (d) *DISTRIBUTION OF FUNDS.*—For each of fiscal  
9           years 2009 through 2017, the Secretary, acting through the  
10          Director, shall provide to each tribal college and university  
11          the application of which is approved under subsection (c)  
12          a grant in an amount equal to the quotient obtained by  
13          dividing—

14                 (1) the total amount made available under sub-  
15                 section (f) for the fiscal year; by

16                 (2) the number of tribal colleges and universities  
17                 the applications of which are approved under sub-  
18                 section (c) for the fiscal year.

19          (e) *REPORTS.*—For each of fiscal years 2010 through  
20          2018, each tribal college or university that receives a grant  
21          under this section shall submit to the Director a report de-  
22          scribing the success of the office of sponsored programs of  
23          the tribal college or university during the preceding fiscal  
24          year, as determined in accordance with the performance in-

1 *dicators contained in the application of the tribal college*  
2 *or university under subsection (c)(2).*

3 *(f) AUTHORIZATION OF APPROPRIATIONS.—There is*  
4 *authorized to be appropriated to carry out this section for*  
5 *each of fiscal years 2009 through 2017 an amount equal*  
6 *to the product obtained by multiplying—*

7 *(1) the number of tribal colleges and universities*  
8 *in operation on October 1 of the applicable fiscal*  
9 *year; and*

10 *(2) \$50,000.*

11 **SEC. 110. HEALTH PROMOTION AND DISEASE PREVENTION**  
12 **RESEARCH PROGRAMS.**

13 *(a) ESTABLISHMENT.—The Secretary, acting through*  
14 *the Director, shall establish a program under which the Sec-*  
15 *retary shall provide grants to, or offer to enter into coopera-*  
16 *tive agreements with, tribal colleges and universities to con-*  
17 *duct research relating to health promotion and disease pre-*  
18 *vention at the tribal colleges and universities.*

19 *(b) REQUIREMENTS.—*

20 *(1) COMPETITION.—The Secretary shall provide*  
21 *grants and offer to enter into cooperative agreements*  
22 *under subsection (a) on a competitive basis.*

23 *(2) GENERAL TERMS AND AMOUNTS.—Except as*  
24 *provided in paragraph (3)—*

1           (A) *the term of a grant or cooperative*  
2           *agreement under subsection (a) shall be not more*  
3           *than 3 years; and*

4           (B) *the minimum amount of a grant under*  
5           *subsection (a) for a fiscal year shall be \$150,000.*

6           (3) *UNDERGRADUATE RESEARCH EXPERIENCE*  
7           *PROGRAMS.—With respect to a grant or cooperative*  
8           *agreement provided for an undergraduate research ex-*  
9           *perience program under subsection (d)(3)—*

10           (A) *the term of such a grant or cooperative*  
11           *agreement shall be not more than 1 year; and*

12           (B) *the minimum amount of such a grant*  
13           *for a fiscal year shall be \$10,000.*

14           (c) *APPLICATION.—*

15           (1) *IN GENERAL.—To be eligible to receive a*  
16           *grant, or to enter into a cooperative agreement, under*  
17           *this subsection, a tribal college or university shall*  
18           *submit to the Secretary an application at such time*  
19           *and in such manner as the Secretary may reasonably*  
20           *require.*

21           (2) *STREAMLINED PROCEDURE.—The Secretary*  
22           *shall ensure, to the maximum extent practicable, a*  
23           *simplified and streamlined procedure for the submis-*  
24           *sion and approval of applications under paragraph*  
25           *(1), taking into consideration the limited number of*

1        *institutions that are eligible to receive assistance*  
 2        *under this section.*

3        *(d) ACTIVITIES.—A tribal college or university that re-*  
 4        *ceives a grant or enters into a cooperative agreement under*  
 5        *this section may use the grant or cooperative agreement to*  
 6        *carry out activities, including—*

7                *(1) research on culturally relevant and innova-*  
 8                *tive health promotion and disease prevention strate-*  
 9                *gies;*

10                *(2) epidemiological research on the health status*  
 11                *of Indian populations and communities; and*

12                *(3) undergraduate research experience programs*  
 13                *as the tribal college or university determines to be ap-*  
 14                *propriate.*

15        *(e) AUTHORIZATION OF APPROPRIATIONS.—There is*  
 16        *authorized to be appropriated to carry out this section*  
 17        *\$12,000,000 for each of fiscal years 2009 through 2017.*

18        **TITLE II—ADVANCING TRIBES**  
 19                **THROUGH TRIBAL COLLEGES**  
 20                **AND UNIVERSITIES**

21        **SEC. 201. SHORT TITLE.**

22        *This title may be cited as the “Advancing Tribes*  
 23        *Through Tribal Colleges and Universities Act” or the “AT*  
 24        *TCUs Act”.*

1 **SEC. 202. FINDINGS.**

2 *Congress finds that—*

3 *(1) a primary goal of providing Federal support*  
4 *for higher education is to ensure social and economic*  
5 *self-sufficiency and growth for all residents of the*  
6 *United States;*

7 *(2) social and economic underdevelopment is the*  
8 *primary obstacle to the self-sufficiency of Indian com-*  
9 *munities and families;*

10 *(3) research has demonstrated that higher edu-*  
11 *cation is a primary method of achieving economic*  
12 *and social development for Indian communities;*

13 *(4) tribal colleges and universities are institu-*  
14 *tions of higher education created by Indians for Indi-*  
15 *ans primarily on rural and isolated Indian reserva-*  
16 *tions, which were virtually excluded from the general*  
17 *system of higher education in the United States;*

18 *(5) underlying goals of tribal colleges and uni-*  
19 *versities are—*

20 *(A) to improve the lives of Indians through*  
21 *higher education; and*

22 *(B) to assist Indians in achieving self-suffi-*  
23 *ciency;*

24 *(6) tribal colleges and universities—*

25 *(A) offer a variety of social services for stu-*  
26 *dents and community members; and*

1           (B) often serve as community centers, li-  
2           braries, tribal archives, career and business cen-  
3           ters, economic development centers, public meet-  
4           ing places, and childcare and wellness centers;

5           (7) tribal colleges and universities and students  
6           of those colleges or universities contribute signifi-  
7           cantly to the economic and social health of Indian  
8           communities;

9           (8)(A) tribal colleges and universities have been  
10          more successful than any other institution of higher  
11          education in educating and helping to retain Indians  
12          in high-need fields, such as nursing and teaching;

13          (B) data from 2005 indicates that—

14               (i) approximately  $\frac{1}{2}$  of all graduates of  
15               tribal colleges and universities pursue advanced  
16               education; and

17               (ii) of those graduates, more than 86 per-  
18               cent pursue bachelor's degrees;

19          (9) individuals, including Indians, with bach-  
20          elor's or advanced degrees earn—

21               (A) almost 4 times as much as individuals  
22               who do not graduate from high school; and

23               (B) more than twice as much as individuals  
24               with high school diplomas;

1           (10) of the 155 indigenous languages spoken in  
2           the United States as of the date of enactment of this  
3           Act, 135 are spoken only by Indian elders;

4           (11)(A) language and culture are at the heart of  
5           the mission of each tribal college and university;

6           (B) tribal colleges and universities—

7           (i) play a strong leadership role in Native  
8           American language immersion; and

9           (ii) are responsible for the majority of the  
10          approximately 50 Native American language im-  
11          mersion programs in the United States; and

12          (12) despite the proven success of Native Amer-  
13          ican language preservation and vitalization efforts of  
14          tribal colleges and universities, only minimal Federal  
15          and private sector resources are used for the activities.

16 **SEC. 203. NATIVE PROSPERITY PROGRAMS AT TCUS.**

17          (a) *IN GENERAL.*—Section 166 of the Workforce In-  
18          vestment Act of 1998 (29 U.S.C. 2911) is amended by add-  
19          ing at the end the following:

20               “(k) *NATIVE PROSPERITY PROGRAMS AT TCUS.*—

21                       “(1) *ESTABLISHMENT.*—The Secretary shall es-  
22                       tablish a program, to be known as the ‘TCU Native  
23                       Prosperity Program’, under which the Secretary shall  
24                       provide grants to, or offer to enter into cooperative  
25                       agreements with, eligible tribal colleges and univer-

1 *sities to promote economic development, entrepreneur-*  
2 *ship, community development, and sound fiscal lead-*  
3 *ership in Indian communities.*

4 “(2) *REQUIREMENTS.*—

5 “(A) *IN GENERAL.*—*Except as provided in*  
6 *subparagraph (B)—*

7 “(i) *the Secretary shall provide grants*  
8 *and offer to enter into cooperative agree-*  
9 *ments under paragraph (1) on a competi-*  
10 *tive basis; and*

11 “(ii) *the term of a grant or cooperative*  
12 *agreement under paragraph (1) shall be 5*  
13 *years.*

14 “(B) *EXCEPTION.*—*If the Secretary deter-*  
15 *mines that a tribal college or university that re-*  
16 *ceives a grant or enters into a cooperative agree-*  
17 *ment under this subsection has performed satis-*  
18 *factorily throughout the initial 5-year term of*  
19 *the grant or cooperative agreement under sub-*  
20 *paragraph (A)(i)—*

21 “(i) *the tribal college or university*  
22 *may submit to the Secretary an application*  
23 *to extend the grant or cooperative agree-*  
24 *ment, as applicable, for a period of not*  
25 *more than 3 additional years; and*

1                   “(ii) the Secretary may waive the com-  
2                   petitiveness requirement of subparagraph  
3                   (A)(i) with respect to the application.

4                   “(3) APPLICATION.—

5                   “(A) IN GENERAL.—To be eligible to receive  
6                   a grant or enter into a cooperative agreement  
7                   under this subsection, a tribal college or univer-  
8                   sity shall submit to the Secretary an application  
9                   at such time and in such manner as the Sec-  
10                  retary may reasonably require.

11                  “(B) PROGRAM PLAN.—

12                  “(i) IN GENERAL.—An application  
13                  under subparagraph (A) shall include a  
14                  plan for the program proposed to be carried  
15                  out by the eligible tribal college or univer-  
16                  sity using the grant or pursuant to the co-  
17                  operative agreement, as applicable.

18                  “(ii) INCLUSIONS.—A program plan  
19                  under subparagraph (A) shall include—

20                         “(I) a description of a 5-year  
21                         plan for the applicable tribal college or  
22                         university, developed in consultation  
23                         with, and approved by, each relevant  
24                         Indian tribe, through which the tribal  
25                         college or university will work collabo-

1 *ratively to meet the needs of Indians or*  
2 *Alaska Natives, as appropriate, in the*  
3 *area served by the tribal college or uni-*  
4 *versity;*

5 *“(II) an identification of the pop-*  
6 *ulation to be served by the tribal col-*  
7 *lege or university;*

8 *“(III) an identification of the*  
9 *education and employment needs of*  
10 *that population and a description of*  
11 *the manner in which the program*  
12 *will—*

13 *“(aa) strengthen the eco-*  
14 *nomie development potential of*  
15 *the population; or*

16 *“(bb) contribute to the devel-*  
17 *opment of high-quality local and*  
18 *community services;*

19 *“(IV) a description of the services*  
20 *to be provided under the program, in-*  
21 *cluding the manner in which the serv-*  
22 *ices will be integrated with other ap-*  
23 *propriate activities to minimize dupli-*  
24 *cation of services; and*

1                   “(V) a description, to be prepared  
2                   in consultation with the Secretary, of  
3                   the performance measures to be used to  
4                   assess the performance of the tribal col-  
5                   lege or university in carrying out the  
6                   program.

7                   “(iii) *REQUIREMENT.*—A program  
8                   plan shall be consistent with the purposes of  
9                   this section, as determined by the Secretary.

10                  “(4) *ACTIVITIES.*—A tribal college or university  
11                  that receives a grant or enters into a cooperative  
12                  agreement under this subsection may use the grant or  
13                  cooperative agreement to carry out activities, includ-  
14                  ing—

15                         “(A) microenterprise development;

16                         “(B) business development and administra-  
17                         tion courses and degree programs;

18                         “(C) entrepreneurship programs;

19                         “(D) municipality planning and adminis-  
20                         tration courses, degree programs, and in-service  
21                         training; and
