## A BILL

For the relief of Anton Dodaj, Gjyljana Dodaj, Franc Dodaj, and Kristjan Dodaj.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. PERMANENT RESIDENT STATUS FOR ANTON**

4 **DODAJ, GJYLJANA DODAJ, FRANC DODAJ,**

5 **AND KRISTJAN DODAJ.**

6 (a) IN GENERAL.—Notwithstanding subsections (a)  
7 and (b) of section 201 of the Immigration and Nationality  
8 Act (8 U.S.C. 1151), Anton Dodaj, Gjyljana Dodaj, Franc  
9 Dodaj, and Kristjan Dodaj shall each be eligible for an  
10 immigrant visa or for adjustment of status to that of an

1 alien lawfully admitted for permanent residence upon fil-  
2 ing an application for issuance of immigrant visas under  
3 section 204 of that Act or for adjustment of status to law-  
4 ful permanent resident.

5 (b) ADJUSTMENT OF STATUS.—If Anton Dodaj,  
6 Gjyljana Dodaj, Franc Dodaj, and Kristjan Dodaj enter  
7 the United States before the filing deadline set forth in  
8 subsection (c), they shall be considered to have entered  
9 and remained lawfully in the United States and shall be  
10 eligible for adjustment to lawful permanent resident status  
11 under section 245 of the Immigration and Nationality Act  
12 (8 U.S.C. 1255) as of the date of the enactment of this  
13 Act.

14 (c) DEADLINE FOR APPLICATION AND PAYMENT OF  
15 FEES.—Subsections (a) and (b) shall apply only if the ap-  
16 plications for issuance of immigrant visas or the applica-  
17 tions for adjustment of status are filed with appropriate  
18 fees not later than 2 years after the date of the enactment  
19 of this Act.

20 (d) REDUCTION OF IMMIGRANT VISA NUMBERS.—  
21 Upon granting immigrant visas or lawful permanent resi-  
22 dent status to Anton Dodaj, Gjyljana Dodaj, Franc Dodaj,  
23 and Kristjan Dodaj, the Secretary of State shall instruct  
24 the proper officer to reduce by 4, during the current or  
25 next following fiscal year, the total number of immigrant

1 visas that are made available to natives of the country of  
2 the aliens' birth under section 203(a) of the Immigration  
3 and Nationality Act (8 U.S.C. 1153(a)) or, if applicable,  
4 the total number of immigrant visas that are made avail-  
5 able to natives of the country of the aliens' birth under  
6 section 202(e) of that Act.
