**A BILL**

To authorize appropriations for fiscal year 2009 for military  
construction, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Military Construction  
5 Authorization Act for Fiscal Year 2009”.

4 **SEC. 2001. SHORT TITLE.**

5 This division may be cited as the “Military Construc-  
6 tion Authorization Act for Fiscal Year 2009”.

7 **SEC. 2002. EXPIRATION OF AUTHORIZATIONS AND**  
8 **AMOUNTS REQUIRED TO BE SPECIFIED BY**  
9 **LAW.**

10 (a) EXPIRATION OF AUTHORIZATIONS AFTER THREE  
11 YEARS.—Except as provided in subsection (b), all author-  
12 izations contained in titles XXI through XXVI and title  
13 XXIX for military construction projects, land acquisition,  
14 family housing projects and facilities, and contributions to  
15 the North Atlantic Treaty Organization Security Invest-  
16 ment Program (and authorizations of appropriations  
17 therefor) shall expire on the later of—

18 (1) October 1, 2011; or

19 (2) the date of the enactment of an Act author-  
20 izing funds for military construction for fiscal year  
21 2012.

22 (b) EXCEPTION.—Subsection (a) shall not apply to  
23 authorizations for military construction projects, land ac-  
24 quisition, family housing projects and facilities, and con-  
25 tributions to the North Atlantic Treaty Organization Se-

1 curity Investment Program (and authorizations of appro-  
 2 priations therefor), for which appropriated funds have  
 3 been obligated before the later of—

4 (1) October 1, 2011; or

5 (2) the date of the enactment of an Act author-  
 6 izing funds for fiscal year 2012 for military con-  
 7 struction projects, land acquisition, family housing  
 8 projects and facilities, or contributions to the North  
 9 Atlantic Treaty Organization Security Investment  
 10 Program.

11 **SEC. 2003. EFFECTIVE DATE.**

12 Titles XXI, XXII, XXIII, XXIV, XXV, XXVI,  
 13 XXVII, and XXIX shall take effect on the later of—

14 (1) October 1, 2008; or

15 (2) the date of the enactment of this Act.

5 Army may construct or acquire family housing units (in-  
6 cluding land acquisition and supporting facilities) at the  
7 installations or locations, in the number of units, and in  
8 the amounts set forth in the following table:

1 **SEC. 2103. IMPROVEMENTS TO MILITARY FAMILY HOUSING**  
2 **UNITS.**

3 Subject to section 2825 of title 10, United States  
4 Code, and using amounts appropriated pursuant to the  
5 authorization of appropriations in section 2104(a)(5)(A),  
6 the Secretary of the Army may improve existing military  
7 family housing units in an amount not to exceed  
8 \$420,001,000.

9 **SEC. 2104. AUTHORIZATION OF APPROPRIATIONS, ARMY.**

10 (a) IN GENERAL.—Funds are hereby authorized to  
11 be appropriated for fiscal years beginning after September  
12 30, 2008, for military construction, land acquisition, and  
13 military family housing functions of the Department of the  
14 Army in the total amount of \$6,042,210,000 as follows:

15 (1) For military construction projects inside the  
16 United States authorized by section 2101(a),  
17 \$4,007,863,000.

18 (2) For military construction projects outside  
19 the United States authorized by section 2101(b),  
20 \$202,250,000.

21 (3) For unspecified minor military construction  
22 projects authorized by section 2805 of title 10,  
23 United States Code, \$23,000,000.

24 (4) For host nation support and architectural  
25 and engineering services and construction design

1 under section 2807 of title 10, United States Code,  
2 \$200,807,000.

3 (5) For military family housing functions:

4 (A) For construction and acquisition, plan-  
5 ning and design, and improvement of military  
6 family housing and facilities, \$678,580,000.

7 (B) For support of military family housing  
8 (including the functions described in section  
9 2833 of title 10, United States Code),  
10 \$716,110,000.

11 (6) For the construction of increment 3 of a

 16 and all that follows through the period at the end of the  
 17 second sentence and inserting “\$3,000,000.”.

18 **SEC. 2802. AUTHORITY TO USE OPERATION AND MAINTEN-**  
 19 **NANCE FUNDS FOR CONSTRUCTION**  
 20 **PROJECTS OUTSIDE THE UNITED STATES.**

21 (a) ONE-YEAR EXTENSION OF AUTHORITY.—Sub-  
 22 section (a) of section 2808 of the Military Construction  
 23 Authorization Act for Fiscal Year 2004 (division B of  
 24 Public Law 108–136; 117 Stat. 1723), as amended by sec-  
 25 tion 2810 of the Military Construction Authorization Act

1 for Fiscal Year 2005 (division B of Public Law 108–375;  
2 118 Stat. 2128), section 2809 of the Military Construction  
3 Authorization Act for Fiscal Year 2006 (division B of  
4 Public Law 109–163; 119 Stat. 3508), section 2802 of  
5 the Military Construction Authorization Act for Fiscal  
6 Year 2007 (division B of Public Law 109–364; 120 Stat.  
7 2466), and section 2801 of the Military Construction Au-  
8 thorization Act for Fiscal Year 2008 (division B of Public  
9 Law 110–181; 122 Stat. 538), is further amended by  
10 striking “2008” and inserting “2009”.

11 (b) EXCEPTION FOR PROJECTS IN AFGHANISTAN  
12 FROM LIMITATION ON AUTHORITY RELATED TO LONG-  
13 TERM UNITED STATES PRESENCE.—Such subsection, as  
14 so amended, is further amended by inserting before the  
15 period at the end of paragraph (2) the following: “, unless  
16 the military installation is located in Afghanistan, in which  
17 case the condition shall not apply”.

18 (c) QUARTERLY REPORTS.—Subsection (d)(1) of sec-  
19 tion 2808 of the Military Construction Authorization Act  
20 for Fiscal Year 2004 (division B of Public Law 108–136;  
21 117 Stat. 1723), as amended by section 2810 of the Mili-  
22 tary Construction Authorization Act for Fiscal Year 2005  
23 (division B of Public Law 108–375; 118 Stat. 2128) and  
24 section 2809 of the Military Construction Authorization  
25 Act for Fiscal Year 2006 (division B of Public Law 109–

1 163; 119 Stat. 3508), is further amended by striking “30  
2 days” and inserting “45 days”.

3 **SEC. 2803. IMPROVED OVERSIGHT AND ACCOUNTABILITY**  
4 **FOR MILITARY HOUSING PRIVATIZATION INI-**  
5 **TIATIVE PROJECTS.**

6 (a) IN GENERAL.—Subchapter IV of chapter 169 of  
7 title 10, United States Code, is amended by adding at the  
8 end the following new section:

9 **“§ 2885. Oversight and accountability for privatiza-**  
10 **tion projects**

11 “(a) OVERSIGHT AND ACCOUNTABILITY MEAS-  
12 URES.—Each Secretary concerned shall prescribe regula-  
13 tions to effectively oversee and manage military housing  
14 privatization projects carried out under this subchapter.  
15 The regulations shall include the following requirements  
16 for each privatization project:

17 “(1) The installation asset manager shall con-  
18 duct monthly site visits and provide reports on the  
19 progress of the construction or renovation of the  
20 housing units. The reports shall be endorsed by the  
21 commander at such installation and submitted quar-  
22 terly to the assistant secretary for installations and  
23 environment of the respective military department  
24 and the Deputy Under Secretary of Defense (Instal-  
25 lations and Environment).

1           “(2) The installation asset manager, and, as  
2 applicable, the resident construction manager, pri-  
3 vatization asset manager, bondholder representative,  
4 project owner, developer, general contractor, and  
5 construction consultant for the project shall conduct  
6 monthly meetings to ensure that the construction or  
7 renovation of the units meets performance and  
8 schedule requirements and that appropriate oper-  
9 ating and ground lease agreements are in place and  
10 adhered to.

11           “(3) If a project is 90 days or more behind  
12 schedule or otherwise appears to be substantially  
13 failing to adhere to the obligations or milestones  
14 under the contract, the assistant secretary for instal-  
15 lations and environment of the respective military  
16 department shall submit a notice of deficiency to the  
17 Deputy Under Secretary of Defense (Installations  
18 and Environment), the Secretary concerned, the  
19 managing member, and the trustee for the project.

20           “(4)(A) Not later than 15 days after the sub-  
21 mittal of a notice of deficiency under paragraph (3),  
22 the Secretary concerned shall submit to the project  
23 owner, developer, or general contractor responsible  
24 for the project a summary of deficiencies related to  
25 the project.

1           “(B) If the project owner, developer, or general  
2 contractor responsible for the project is unable, with-  
3 in 30 days after receiving a notice of deficiency  
4 under subparagraph (A), to make progress on the  
5 issues outlined in such notice, the Secretary con-  
6 cerned shall submit to the project owner, developer,  
7 or general contractor, the bondholder representative,  
8 and the trustee an official letter of concern address-  
9 ing the deficiencies and detailing the corrective ac-  
10 tions that should be taken to correct the deficiencies.

11           “(C) If the project owner, developer, or general  
12 contractor responsible for the privatization project is  
13 unable, within 60 days after receiving a notice of de-  
14 ficiency under subparagraph (A), to make progress  
15 on the issues outlined in such notice, the Deputy  
16 Under Secretary of Defense (Installations and Envi-  
17 ronment) shall notify the congressional defense com-  
18 mittees of the status of the project, and shall pro-  
19 vide a recommended course of action to correct the  
20 problems.

21           “(b) COMMUNITY MEETINGS.—(1) Prior to the com-  
22 mencement of privatization project, the assistant secretary  
23 for installations and environment of the respective military  
24 department and the commanding officer of the local mili-

1 tary installation shall hold a meeting with the local com-  
2 munity to communicate the following information:

3 “(A) The nature of the project.

4 “(B) Any contractual arrangements.

5 “(C) Potential liabilities to local construction  
6 management companies and subcontractors.

7 “(2) The requirement under paragraph (1) may be  
8 met by publishing the information described in such para-  
9 graph on the Federal Business Opportunities  
10 (FedBizOpps) Internet website.

11 “(c) REQUIRED QUALIFICATIONS.—The Secretary  
12 concerned shall certify that the project owner, developer,  
13 or general contractor that is selected for each military  
14 housing privatization initiative project has construction  
15 experience commensurate with that required to complete  
16 the project.

17 “(d) BONDING LEVELS.—The Secretary concerned  
18 shall ensure that the project owner, developer, or general  
19 contractor responsible for a military housing privatization  
20 initiative project has sufficient payment and performance  
21 bonds or suitable instruments in place for each phase of  
22 a construction or renovation portion of the project to en-  
23 sure successful completion of the work in amounts as  
24 agreed to in the project’s legal documents, but in no case  
25 less than 50 percent of the total value of the active phases

1 of the project, prior to the commencement of work for that  
2 phase.

3       “(e) CERTIFICATIONS REGRADING PREVIOUS BANK-  
4 RUPTCY DECLARATIONS.—If a military department  
5 awards a contract or agreement for a military housing pri-  
6 vatization initiative project to a project owner, developer,  
7 or general contractor that has previously declared bank-  
8 ruptcy, the Secretary concerned shall specify in the notifi-  
9 cation to Congress of the project award the extent to  
10 which the issues related to the previous bankruptcy are  
11 expected to impact the ability of the project owner, devel-  
12 oper, or general contractor to complete the project.

13       “(f) COMMUNICATION REGARDING POOR PERFORM-  
14 ANCE.—The Deputy Under Secretary of Defense (Instal-  
15 lations and Environment) shall prescribe policies to pro-  
16 vide for regular and appropriate communication between  
17 representatives of the military departments and bond-  
18 holders for military housing privatization initiative  
19 projects to ensure timely action to address inadequate per-  
20 formance in carrying out projects.

21       “(g) REPORTING OF EFFORTS TO SELECT SUC-  
22 CESSOR IN EVENT OF DEFAULT.—In the event a military  
23 housing privatization initiative project enters into default,  
24 the assistant secretary for installations and environment  
25 of the respective military department shall submit a report

1 to the congressional defense committees every 90 days de-  
2 tailing the status of negotiations to award the project to  
3 a new project owner, developer, or general contractor.

4       “(h) EFFECT OF UNSATISFACTORY PERFORMANCE  
5 RATING ON AFFILIATED ENTITIES.—In the event the  
6 project owner, developer, or general contractor for a mili-  
7 tary construction project receives an unsatisfactory per-  
8 formance rating due to poor performance, each parent,  
9 subsidiary, affiliate, or other controlling entity of such  
10 owner, developer, or contractor shall also receive an unsat-  
11 isfactory performance rating.

12       “(i) EFFECT OF NOTICES OF DEFICIENCY ON CON-  
13 TRACTORS AND AFFILIATED ENTITIES.—(1) The Deputy  
14 Under Secretary of Defense (Installations and Environ-  
15 ment) shall keep a record of all plans of action or notices  
16 of deficiency issued to a project owner, developer, or gen-  
17 eral contractor under subsection (a)(4), including the  
18 identity of each parent, subsidiary, affiliate, or other con-  
19 trolling entity of such owner, developer, or contractor.

20       “(2) CONSULTATION.—Each military department  
21 shall consult the records maintained under paragraph (1)  
22 when reviewing the past performance of owners, devel-  
23 opers, and contractors in the bidding process for a con-  
24 tract or other agreement for a military housing privatiza-  
25 tion initiative project.

1 “(j) PROCEDURES FOR IDENTIFYING AND COMMU-  
2 NICATING BEST PRACTICES FOR TRANSACTIONS.—(1)

3 The Secretary of Defense shall identify best practices for  
4 military housing privatization projects, including—

5 “(A) effective means to track and verify proper  
6 performance, schedule, and cash flow;

7 “(B) means of overseeing the actions of bond-  
8 holders to properly monitor construction progress  
9 and construction draws;

10 “(C) effective structuring of transactions to en-  
11 sure the United States Government has adequate  
12 abilities to oversee project owner performance; and

13 “(D) ensuring that notices to proceed on new  
14 work are not issued until proper bonding is in place.

15 “(2) The Secretary shall prescribe regulations to im-  
16 plement the best practices developed pursuant to para-  
17 graph (1).”.

18 (b) CLERICAL AMENDMENT.—The table of sections  
19 at the beginning of such subchapter is amended by adding  
20 at the end the following new item:

“2885. Oversight and accountability for privatization projects.”.

21 **SEC. 2804. LEASING OF MILITARY FAMILY HOUSING TO**  
22 **SECRETARY OF DEFENSE.**

23 (a) LEASING OF HOUSING.—Subchapter II of chap-  
24 ter 169 of title 10, United States Code, is amended by  
25 inserting after section 2837 the following new section:

1 **“§ 2838. Leasing of military family housing to Sec-**  
2 **retary of Defense**

3 “(a) **AUTHORITY.**—(1) The Secretary of a military  
4 department may lease to the Secretary of Defense military  
5 family housing in the National Capital Region (as defined  
6 in section 2674(f) of this title).

7 “(2) In determining the military housing unit to lease  
8 under this section, the Secretary of Defense should first  
9 consider any available military housing units that are al-  
10 ready substantially equipped for executive communications  
11 and security.

12 “(b) **RENTAL RATE.**—A lease under subsection (a)  
13 shall provide for the payment by the Secretary of Defense  
14 of consideration in an amount equal to 105 percent of the  
15 monthly rate of basic allowance for housing prescribed  
16 under section 403(b) of title 37 for a member of the uni-  
17 formed services in the pay grade of O–10 with dependents  
18 assigned to duty at the military installation on which the  
19 leased housing unit is located. A rate so established shall  
20 be considered the fair market value of the lease interest.

21 “(c) **TREATMENT OF PROCEEDS.**—(1) The Secretary  
22 of a military department shall deposit all amounts received  
23 pursuant to leases entered into by the Secretary under this  
24 section into a special account in the Treasury established  
25 for such military department.

1       “(2) The proceeds deposited into the special account  
 2 of a military department pursuant to paragraph (1) shall  
 3 be available to the Secretary of that military department,  
 4 without further appropriation, for the maintenance, pro-  
 5 tection, alteration, repair, improvement, or restoration of  
 6 military housing on the military installation at which the  
 7 housing leased pursuant to subsection (a) is located.”.

8       (b) CLERICAL AMENDMENT.—The table of sections  
 9 at the beginning of such subchapter is amended by adding  
 10 at the end the following new item:

“2838. Leasing of military family housing to Secretary of Defense.”.

11 **SEC. 2805. COST-BENEFIT ANALYSIS OF DISSOLUTION OF**  
 12 **PATRICK FAMILY HOUSING LLC.**

13       (a) COST-BENEFIT ANALYSIS.—Not later than 30  
 14 days after the date of the enactment of this Act, the Sec-  
 15 retary of the Air Force shall submit to the congressional  
 16 defense committees a cost-benefit analysis of dissolving  
 17 Patrick Family Housing LLC without exercising the full  
 18 range of rights available to the United States Government  
 19 to recover damages from the partnership.

20       (b) CONTENT.—The analysis required under sub-  
 21 section (a) shall include an evaluation of the best practices  
 22 for executing military housing privatization projects as de-  
 23 termined by the Department of Defense and the Secre-  
 24 taries concerned and the other options available to restore

1 the financial health of nonperforming or defaulting  
2 projects.

3 (c) TEMPORARY MORATORIUM ON CERTAIN AC-  
4 TIONS.—The Secretary of the Air Force may not, in car-  
5 rying out a military housing privatization project initiated  
6 at Patrick Air Force Base, Florida, dissolve the Patrick  
7 Family Housing LLC until the Secretary of the Air Force  
8 submits the cost-benefit analysis required under sub-  
9 section (a).

## 10 **Subtitle B—Real Property and** 11 **Facilities Administration**

### 12 **SEC. 2811. PARTICIPATION IN CONSERVATION BANKING** 13 **PROGRAMS.**

14 (a) IN GENERAL.—Chapter 159 of title 10, United

#### 17 **“§ 2694c. Participation in conservation banking pro-** 18 **grams**

19 “(a) AUTHORITY TO PARTICIPATE.—The Secretary  
20 of a military department, and the Secretary of Defense  
21 with respect to matters concerning a Defense Agency,  
22 when engaged or proposing to engage in an authorized ac-  
23 tivity that may or will result in an adverse impact on one  
24 or more species protected (or pending protection) under  
25 any applicable provision of law, or on a habitat for such

1 species, may make payments to a conservation banking  
2 program or ‘in-lieu-fee’ mitigation sponsor approved in ac-  
3 cordance with the Federal Guidance for the Establish-  
4 ment, Use and Operation of Mitigation Banks (60 Fed.  
5 Reg. 58605; November 28, 1995) or the Guidance for the  
6 Establishment, Use, and Operation of Conservation Banks  
7 (68 Fed. Reg. 24753; May 2, 2003), or any successor or  
8 related administrative guidance or regulation.

9 “(b) FACILITATION OF TESTING OR TRAINING AC-  
10 TIVITIES OR MILITARY CONSTRUCTION.—Participation in  
11 conservation banking and ‘in-lieu-fee’ programs under  
12 subsection (a) shall be for the purposes of facilitating—

13 “(1) military testing or training activities; or

14 “(2) military construction.

15 “(c) TREATMENT OF PAYMENTS.—Payments made  
16 under subsection (a) to a conservation banking program  
17 or ‘in-lieu-fee’ mitigation sponsor for the purpose of facili-  
18 tating military construction may be treated as eligible  
19 project costs for such military construction.”.

20 (b) CLERICAL AMENDMENT.—The table of sections  
21 at the beginning of such chapter is amended by inserting  
22 after the item relating to section 2694b the following new  
23 item:

“2694c. Participation in conservation banking programs.”.

1 **SEC. 2812. CLARIFICATION OF CONGRESSIONAL REPORT-**  
2 **ING REQUIREMENTS FOR CERTAIN REAL**  
3 **PROPERTY TRANSACTIONS.**

4 Section 2662(c) of title 10, United States Code, is  
5 amended by striking “river and harbor projects or flood  
6 control projects” and inserting “water resource develop-

8 **SEC. 2813. MODIFICATION OF LAND MANAGEMENT RE-**  
9 **STRICTIONS APPLICABLE TO UTAH NA-**  
10 **TIONAL DEFENSE LANDS.**

11 Section 2815 of the National Defense Authorization  
12 Act for Fiscal Year 2000 (Public Law 106–65; 113 Stat.  
13 852) is amended—

14 (1) in subsection (a), by striking “that are ad-

16 and Dugway Proving Ground or beneath” and in-

5           (a) **TRANSFER AUTHORIZED.**—The Secretary of De-  
6 fense may transfer any proceeds from the sale of approxi-  
7 mately 120.375 acres of improved land located at the  
8 former Boyett Village Family Housing Complex at the  
9 Marine Corps Logistics Base, Albany, Georgia, into the  
10 Department of Defense Family Housing Improvement
