## CONCURRENT RESOLUTION

Providing for a conditional adjournment or recess of the Senate, and a conditional adjournment of the House of Representatives.

1        *Resolved by the Senate (the House of Representatives*  
2 *concurring)*, That when the Senate adjourns on any day  
3 from Tuesday, December 18, 2007, through Monday, De-  
4 cember 31, 2007, on a motion offered pursuant to this  
5 concurrent resolution by its majority leader or his des-  
6 ignee, it stand adjourned sine die, or until the time of any  
7 reassembly pursuant to section 3 of this concurrent resolu-  
8 tion; and that when the House adjourns on any legislative  
9 day from Tuesday, December 18, 2007, through Saturday,  
10 December 22, 2007, on a motion offered pursuant to this

1 concurrent resolution by its majority leader or his des-  
2 ignee, it stand adjourned sine die, or until the time of any  
3 reassembly pursuant to section 3 of this concurrent resolu-  
4 tion.

5       SEC. 2. When the Senate recesses or adjourns on  
6 Thursday, January 3, 2008, on a motion offered pursuant  
7 to this concurrent resolution by its majority leader or his  
8 designee, it shall stand recessed or adjourned until noon  
9 on Tuesday, January 22, 2008, or such other time on that  
10 day as may be specified in the motion to recess or adjourn,  
11 or until the time of any reassembly pursuant to section  
12 3 of this concurrent resolution, whichever occurs first; and  
13 when the House adjourns on the legislative day of Thurs-  
14 day, January 3, 2008, on a motion offered pursuant to  
15 this concurrent resolution by its majority leader or his des-  
16 ignee, it shall stand recessed or adjourned until noon on  
17 Tuesday, January 15, 2008, or until the time of any re-  
18 assembly pursuant to section 3 of this concurrent resolu-  
19 tion, whichever occurs first.

20       SEC. 3. The majority leader of the Senate and the  
21 Speaker of the House, or their respective designees, acting  
22 jointly after consultation with the minority leader of the  
23 Senate and the minority leader of the House, shall notify  
24 Members of the Senate and the House, respectively, to re-

- 1 assemble at such a place and time as they may designate
- 2 if, in their opinion, the public interest shall warrant it.
