The SPEAKER OF THE HOUSE OF REPRESENTATIVES.

SIR: In accordance with provisions of the Departments of Labor, Health and Human Services, Education, and Related Agencies Appropriations Act, 2000, as enacted by section 1000(a)(4) of the Consolidated Appropriations Act, 2000, Public Law 106-113, I hereby request and make available appropriations of \$130,000,000 in budget authority for the Department of Health and Human Services' Low Income Home Energy Assistance Program. These funds will enable the Department to address the needs of all States, Territories, and Tribes due to continuing, substantial increases in home heating fuel costs.

I hereby designate the \$130,000,000 made available today as an emergency requirement pursuant to section 251(b)(2)(A) of the Balanced Budget and Emergency Deficit Control Act of 1985, as amended.

The details of this action are set forth in the enclosed letter from the Director of the Office of Management and Budget. I concur with his comments and observations.

Submitted for your consideration is a request to make available \$130.0 million in emergency appropriations for the Department of Health and Human Services (HHS). Your approval of this request would make available previously appropriated funds to the Low Income Home Energy Assistance Program (LIHEAP) to address the needs of all States, Territories, and Tribes due to continuing, substantial increases in home heating fuel costs.

The Departments of Labor, Health and Human Services, Education, and Related Agencies Appropriations Act, 2000, as enacted by section 1000(a)(4) of the Consolidated Appropriations Act, 2000, P.L. 106-113, provided \$300.0 million for LIHEAP, contingent upon the President submitting a budget request to the Congress and designating the entire amount requested as an emergency requirement. On January 25, 2000, you released \$45.0 million to address the needs of Alaska and 10 New England and Middle Atlantic States due to increases in home heating fuel costs. On October 18, 1999, you released \$5.0 million to provide support to New Jersey in the wake of Hurricane Floyd.

I recommend that you designate this request for \$130.0 million as an emergency requirement in accordance with section 251(b)(2)(A) of the Balanced Budget and Emergency Deficit Control Act of 1985, as amended. No further congressional action will be required.

I have carefully reviewed this proposal and am satisfied that it is necessary at this time. Therefore, I join the Secretary of Health and Human Services in recommending that you make the requested funds available by signing the enclosed letter to the Speaker of the House of Representatives.

The Departments of Labor, Health and Human Services, Education, and Related Agencies Appropriations Act, 2000, as enacted by section 1000(a)(4) of the Consolidated Appropriations Act, 2000, Public Law 106-113, provided \$300,000,000 million for the Low In-

come Home Energy Assistance Program (LIHEAP), contingent upon the President submitting a budget request to the Congress and designating the entire amount requested as an emergency requirement.

On January 25, 2000, \$45,000,000 was released to address the needs of Alaska and 10 New England and Middle Atlantic States due to increases in home heating fuel costs. On October 18, 1999, \$5,000,000 was released to support the needs of New Jersey in the wake of Hurricane Floyd. At this time, an additional \$130,000,000 of the remaining \$250,000,000 in contingent funding is required to support the needs of all States, Territories, and Tribes resulting from the continuing, substantial increases in home heating fuel costs.
